To renew by mail, please complete this document in its entirety and submit it with the renewal fee of \$105.00 to the address above, allowing 4 weeks for processing. Make check or money order payable to 'Indiana Professional Licensing Agency'. If this document is postmarked after the license expiration date you must include a \$50 late fee. If you answer 'Yes' to any question, below send a detailed statement regarding the response with your renewal form.

However, while in inactive status, you may not use the title "public accountant," or "accounting practitioner" or the abbreviation "PA," or "AP" unless it is immediately followed by the word "inactive". To reactivate the certificate, you must file an application for reactivation and submit evidence of the completion of 120 CPE hours obtained within the previous 3 years.
