- 3. Proof of Continuing Education including 10 hours for the initial expiration date (4 in IN law) plus 5 hours for each year after expiration date (2 of the 5 in Law)
- 4. Once reviewed, you will be informed that you may pay your Indiana Law Exam fee of \$50.00, and you will be scheduled for the next exam.
- After your license has been reinstated, you will need to print a free license card or order one from our website at <a href="https://www.in.gov/pla/license.htm">www.in.gov/pla/license.htm</a> to comply with the posting requirement.
- If a tax protest has been recorded on your license according to the Indiana Department of Revenue (DOR), your license may not be renewed until this agency receives confirmation from the DOR that the protest is removed.
