PERSONAL APPEARANCES

Desmon White, Broker Application – Positive Response:

Mr. White appeared in person and was not represented by counsel regarding the positive response on his initial broker application.

Mr. White explained to the Commission that in 2015 he was working for people that had counterfeit money. He stated he was a senior in high school working at Pizza Hut. He was guilty by association as he didn't have any counterfeit money on him, but he knew they had it.

In 2016, while in college, someone took some of his things from his room and took it to a college house, which he entered and took back his things. The tenants of the house called the Police, and he was arrested.

In 2018, he was charged with breaking and entering his girlfriend's house. He indicated that she had some of his things and they got into a fight, she wouldn't give him back his things. He stated since they were his he just went in and got them and was then arrested.

He informed the Commission that all this happened when he was 18/19 years old. He stated that he feels he had grown up a lot since then and now has a child of his own. He has been shadowing a mentor that is a licensed realtor. He stated that he is currently doing welding.

At this time, he still owes \$100 to the courts for the 2018 arrest.

After discussion, the Commission moved to APPROVE Mr. White's application on INDEFINITE PROBATION for no less than one (1) year with the following terms:

- Proof of payment of the \$100 to the courts withing thirty (30) days from the date of the order
- Affiliate with a established Brokerage firm

Douglas Horton, Broker Application – Positive Response:

Mr. Horton appeared in person and was not represented by counsel regarding the positive response on his initial broker application.

Let the record reflect that John Desouza recused himself from this matter and left the room.

Mr. Horton explained that he lives up in the South Bend area and is currently licensed in the state of Michigan. His license was issued on 10/7/2021 on active status and he wants to be licensed in both states so he can work in both.

He explained that his first arrest was when he was sixteen (16) years old back in 2012 he was charged with armed robbery in Chicago in August 2012. The following charges show on his court documents relating to the armed robbery charge:

On October 18, 2013, he was sentenced to ten (10) years with 427 days credit to the IL department of corrections. He indicated he served five (5) of the ten (10) years.

He stated that in 2019 he was with his girlfriend in her car when they were pulled over for a traffic stop. A cup in the console had a counterfeit bill in it. The court document shows the following charges in 2019:

He plead NOLLE PROSEQUI to all charges, this was in Illinois. There wasn't any information regarding sentencing with this.

In 2019 he was arrested and charged with Forgery – Def, W/Intent to Defraud, Makes/Utters Written Instrument that Purports to have been Made Comment: He plead guilty by agreement. He was fined \$200 and sentenced to 1 year 182 days, with 2 days credit and 427 days suspended leaving 120 days to serve and the balance on a suspended sentenced. No probation ordered.

After discussion, the Commission moved to APPROVE Mr. Horton's broker application.

Mr. Willis appeared in person and was not represented by counsel regarding the positive response on his initial broker application.

He indicated that his retired from the Military at the age of 31 as an E6 after he was shot in the chest. He indicated that after his surgery he had difficulty getting back into society. He stated that he had been self-medicating for the pain from the surgery.

He was pulled over by the Police, they searched his car and found Marijuana. He indicated he spent a few days in jail and the matter was dismissed.

Peter Basford, Broker Application – Positive Response:

Mr. Basford appeared in person and was not represented by counsel regarding the positive response on his initial broker application.

Mr. Basford indicated he fell in with the wrong crowd and had the following arrests:

2019 – Charged with Dealing in Marijuana, he stated he was smoking a lot of Marijuana at the time. He was sentenced to 60 days in jail, with 60 days suspended.

2020 – he was smoking marijuana in his car, was pullover and the Police found pills in his car too. He was charged with possession of controlled substances and two counts of possession of Marijuana. He plead guilty to possession of a controlled substance and the two counts of possession of Marijuana were dismissed. He was sentenced to 365 days in jail, with 1 day credit and 364 days suspended. He was then placed on court probation for 1 year.

2021 – He was charged with carrying a handgun with out a license to which he plead guilty. He was sentenced to 20 days in jail, with 8 days credit, 0 suspended.

2022 – He was arrested and charged with a Felony 6 OWI with a prior conviction within 7 years. He was sentenced to 365 days in jail, with 11 days credit and 345 days suspended. His driver's license was suspended for 1 year.

He indicated that after his arrest in 2022 he was fired from his job and now works at Henny Penny in Ohio. All of his court probations have been completed.

After discussion, the Commission moved to APPROVE Mr. Basford's broker application.

Ali Beilk, Broker Application – Positive Response:

Mr. Beilk appeared in person and was not represented by counsel regarding the positive response on his initial broker application.

In 2017, Mr. Beilk plead guilty to a Felony 6, maintaining a common nuisance – controlled substances. He was also charged with the following, but they were dismissed with his guilty plea.

- Dealing in Marijuana
- Possession of a controlled substance 5 counts
- Possession of Marijuana
- Possession of Hashish

He stated that he plead guilty to maintaining a common nuisance – controlled substances because they arrested his wife too. When he pleaded guilty they released his wife.

He said he had all kinds of pills that he had stockpiled to trade for Marijuana.

He was sentenced to 365 days confinement in the county jail, with 2 days jail credit, 363 days suspended. Court Probation for 363 days.

On March 28, 2022, he was charged with the following:

- Dealing in a schedule I controlled substance with weight of at least 28 grams Felony 2
- Dealing in Marijuana weighing b/t 30 grams & 10 pounds Felony 6
- Possession of a Controlled Substance Possession of a Schedule I, II, III, IV cont – 4 counts
- Possession of Marijuana
- Possession of paraphernalia

These charges are all still pending, with a jury trial scheduled currently for May 8, 2023.

He stated that after the 2017 incident he went to an outpatient rehab through his physician and saw a therapist three times a week. When asked he couldn't give any information regarding the rehab program.

After discussion, the Commission moved to DENY Mr. Beilke's broker application.

Jeffrey McGownd – Broker Application – Positive Response:

Mr. McGownd appeared in person and was not represented by counsel regarding the positive response on his initial broker application.

In 2013 he entered a guilty plea and the court having entered a Judgment of Conviction for the crime of Amended Count I Dealing in A Schedule II Controlled Substance, a Class B Felony.

The court accepted the negotiated plea agreement and entered the following sentence:

- Sentenced to Indiana Department of Corrections for classification and confinement for a period of twenty (20) years of which thirteen (13) shall be suspended;
- Pay court costs of \$166.00
- Shall be on probation for a period of thirteen (13) years to begin upon date of release from incarceration; there are many more terms but the above are the most important.

It was found that he was eligible for the Community Transition Program. On July 8, 2014, his began his In-Home incarceration portion of the sentence.

He violated his probation in 2018 due to a positive drug screen. He was then placed in the SERCC Work Release Program for sixty (60) days and then one hundred-eighty (180) days in the SERCC In-Home Detention Program.

His court probation will continue until July 1, 2027.

After discussion, the Commission moved to APPROVE Mr. McGownd's broker application.

Ms. Holbrook informed the Commission that the opposing counsel has been very cooperative, and she does not oppose the continuance.

Daniel Annee, Cause No. 2023 IREC 0005

Respondent appeared in person and was represented by Derek Peterson regarding a Petition for Review Hearing on License Application scheduled before the Board.

Brenda Richard, his managing broker was sworn in as a witness.

Mr. Annee's broker application was not officially denied by the Commission at the March 2023 meeting, the Commission voted on the approval of the application and that vote failed to pass.

On his application Mr. Annee has several positive responses to the questions. He indicated that everything happened ten (10) years ago. He plead guilty to one (1) count of Arson.

After incidents of his building be destroyed on the inside and other issues, Mr. Annee agreed to listed to two guys on how to fix the problem, which was to possibly burn down the building and how the arson would be arranged. One of the two men was a undercover police officer and the other was a confidential informant of the police officer. They recorded the conversation, and the recording was handed over to the Department of Justice.

He was charged with one (1) count of Solicitation to commit a crime of violence (arson). He was sentenced to three (3) years' probation from April 4, 2011, to April 3, 2014, and Fined \$10,000.

On January 28, 2013, the Commission permanently revoked his salesperson license.

Ms. Richards testified that she met Mr. Annee twenty-five (25) years ago. They have a client relationship. She has been a broker for forty-five (45) years. She is willing to serve as his managing broker and will be proud to have him work for her.

After having considered the evidence presented, testimony of the witness, and taking official, judicial notice of the pleadings, evidence, and orders in this matter the Commission moved to APPROVE Mr. Annee's broker application.
