II. ADOPTION OF THE AGENDA

A motion was made and seconded to adopt the agenda as amended. Laux/Ogle 8-0-0, motion carries

III. ADOPTION OF THE MINUTES FROM THE JUNE 20 2013 MEETING OF THE BOARD

A motion was made and seconded to adopt the June 20, 2013 minutes. McIntosh/Laux 7-0-1, motion carries (Narwold abstains)

IV. INDIANA STATE NURSES ASSISTANCE PROGRAM

Chuck Lindquist, Program Director of ISNAP, reported on the INSPECT query for this quarter. Twenty-nine (29) nurses with encumbered licenses showed INSPECT activity. Eighteen (18) of them had only 1 or 2 prescriptions and there was concern regarding continued use with three participants. Two of those participants were issued an order to show cause and one was given a mandate for six months off of all controlled substances prior to successful completion. Ms. Ogle asked a question regarding the Needs Assistance Fund and how program participants became aware of this program. A brief discussion took place and the end result is that the ISNAP program will send the Needs Assistance Fund application to all new participants as part of their orientation packet.

V. EDUCATION

A. Indiana State University- Request for change in credit hours and courses (Lea Hall)

Staff appeared from ISU. They are proposing to decrease total their total credit hours from 126 to 120 hours to follow baccalaureate trends. They indicated they do not want to disturb nursing courses or foundational courses and have identified content which can be covered elsewhere. They proposed removal of Sociology 101 and Statistics. Sociology would be incorporated into other courses and they have created a new research course including Statistics when reviewing research studies. The accelerated track BSN will also remove these courses as well to stay in conjunction with traditional track. The Board members expressed concerns about removing a statistics class as most masters degree admission programs will look specifically for a rigorous statistics program. A motion was made and seconded to table this issue until August. McIntosh/Laux 8-0-0, motion carries

They are also requesting a change in the LPN to BS curriculum. Two mental health courses would be consolidated into one 4 hour mental health course. In addition, they are seeking approval to add a 2 credit hour course in the final semester to prepare for the NCLEX exam. Ms. Hall asked how students are doing now on the NCLEX. Staff indicated that of the students who have taken the NCLEX prep

course on the accelerated track; all 15 students passed NCLEX on first attempt. A motion was made and seconded to approve the request. McIntosh/Laux 8-0-0, motion carries

B. FYI Only: Kaplan College, Indianapolis, Jody Richardson, RN, MSN named interim director of PN nursing program effective 7/5/13 replacing Jill Buchholz.

C. Marion Community School System-Tucker Vocational Program Center LPN Program- Monthly progress report and Notice of Intent to close program (Susan Chastain)

Susan Chastain appeared on behalf Marion Community School System. The Superintendent, Director of Tucker Vocational Program and Director of the Nursing program were not present. The Marion Community School System's Board has decided to close the LPN program. The program will close when the current class graduates in September 2013. Ms. Chastain reports that they have had one staff member leave but they are looking to replace that person and additional staff picked up the slack. Ms. Chastain does not know the specific date in September when students will graduate. Ms. McIntosh indicated last month that the Board shared their frustrations because reports were late, requirements were not being met, etc. and today the staff at Tucker and the school system is not present. Ms. Chastain indicates this may be a mistake on her part as they have had a change in superintendent since the June board meeting. Ms. McIntosh indicates she finds it very disrespectful that the staff has not appeared today. The Board requests a closure date within 72 hours of today's date. Ms. Chastain indicates no disrespect is intended but they have not been through this process before. Students would not need to be transferred because they will all graduate as evidenced by their current grades and progression. Mr. Burghduff asked about articulation of credits and Ms. Chastain did not know the answer. Ms. Hall asked about remediation for students that may not pass NCLEX and Ms. Chastain does not know the answer. Ms. McIntosh indicated they will table the issue until August so that Ms. Chastain may inform the client of these questions and the importance of them being here in August. Ms. Chastain was made aware that the Board meeting date is August 15th. Ms. Narwold asked, should a student be unsuccessful and not complete in September, what is the plan to let that student complete. Ms. Chastain did not know the answer. Ms. Cooper asked for an accounting of any student who is a part of the nursing program but is not actively enrolled at this time. Ms. Chastain did not know the answer. The Board wants to know where any potentially enrolled student is and how that will be addressed. Ms. Narwold asked how many students are in the program right now and Ms. Chastain indicated about 40. Ms. McIntosh also indicated they need to look and see if past alumni did not pass the NCLEX and need a refresher or guidance on how to pass the NCLEX what do they do with those students. Ms. Chastain was not aware of a plan in place for this at this time. Ms. Narwold indicated there is a comment in the current report re: recordkeeping and an error regarding the regulations as the nursing regulations clearly the amount of time for recordkeeping as 60 years after closure. The plan submitted indicates 75 years but the report itself is wrong. A motion was made and seconded for the program to submit responses to these questions no later than August 9th. The superintendent, director of Tucker, and nursing program direct must appear at the August 15, 2013 board meeting. McIntosh/Burghduff 8-0-0, motion carries

VI. DISCUSSION

A. Indiana Center for Nursing (Kim Harper)

Ms. Harper expressed thanks for the work of the Board their integral role in the Indiana Center for Nursing. She indicated that it is a breath of fresh air within nursing leadership ranks within the state to have the Board's active involvement. She said that on a national level the state nursing workforce centers and NCSBN work very closely together so it is wonderful to do that at the state level as well. Ms. Harper discussed the current work on data collection for the re-licensure surveys and various projects.

B. Introduction from Paula Beller , Interim Deputy Director, Office of the Attorney General

Ms. Beller met with the Board and indicated she is the interim deputy director at this time. She is not sure she is staying in this role as the OAG is exploring various options. She expressed her appreciation for the work of the Board and the Board members roles in the nursing profession.

VIII. BOARD DIRECTOR REPORT

Ms. Kiefner Crawford reported the following:

- Board members received copies of a recent article from Consumer Reports regarding APN practice and a brief submitted to the ANA on behalf of multiple state associations, including Indiana's.
- The Journal of Nursing Regulation for July 2013 includes a supplement with the RN survey between NCSBN and the Forum of Nursing Workforce Centers.
- The Board has been asked to speak at Purdue University on October 11th. Any board members interested in accompanying Ms. Kiefner Crawford are welcome and encouraged to attend.

A. Appearances by Applicants for Licensure

1. **Alina Casey** **LPN Exam** **CBC Hit/Positive Response**
Ms. Casey appeared for her personal appearance regarding her application for licensure. She has 6 arrests. In 2000, she was with someone who was shoplifting. She knew the person was shoplifting. The charges were dropped. Also in 2000, she was driving while suspended. Her driver's license was suspended due to the fact that she had been pulled over for driving without a license. In 2005, she had a failure to appear which was related to the driving while suspended charge. 2010 and 2011, she had driving while suspended charges. 2012, she had bad checks; she paid all the necessary fees. Also in 2012, she had a failure to appear charge related to the bad checks. She currently has a driver's license. It took her so long to get the matter cleaned up because of all the fees that kept getting pile on and at the time she did not have the money to pay for them. She is allowed to test. Her license will be issued on probation for 6 months active practice with quarterly reports.
2. **Tanya Lynn Liedtke** **RN Endorsement** **CBC Hit/Positive Response**
Ms. Liedtke appeared for her personal appearance regarding her application for licensure. She is currently licensed in Wisconsin, which is active. In 2012, she received a careless driving charge/driving under the limit. She was pulled over because a cigarette butt was thrown out of the passenger window and she crossed the fog line. There have not been any other incidents. She is allowed to endorse. License to be issued free and clear.
3. **Jacqueline Burkholder** **RN Endorsement** **CBC Hit/Positive Response**
Ms. Burkholder appeared for her personal appearance regarding her application for licensure. She currently holds a Michigan license, which is active. Her only arrest was in 2012. She received an OUI. Her blood alcohol level was .10. She is allowed to endorse. Her license is to be issued on probation for 6 months active practice with quarterly reports.
4. **Cristina Ann Navrkal** **LPN Exam** **CBC Hit/Positive Response**
Ms. Navrkal did not appear for her personal appearance. Matter will be rescheduled one time.
5. **David Brown** **RN Exam** **CBC Hit/Positive Response**
Mr. Brown appeared for his personal appearance regarding his application for licensure. He currently holds an LPN nursing license. On his LPN application/renewals Mr. Brown had disclosed a 2006 and 2010 arrest. He did not disclose a 2008 battery charge on his 2010 or 2012 renewal but did his RN application. In 2008, he had a verbal disagreement with his wife. He was arrested for domestic battery, intimidation, and police interference. The wife did not press charges; however the complaint was made by a third party so the prosecutor proceeded with the matter. He entered into a deferral agreement. He did not disclose it because he didn't think he had too. He is allowed to test. His license will be issued on probation for 6 months active practice with quarterly reports. He also needs to have an MMPI-2 done and the results to be reviewed by the board to see if any additional action needs to be taken.
6. **Shauna Toth** **RN Exam** **CBC Hit/Positive Response**
Ms. Toth appeared for her personal appearance regarding her application for licensure. She has had 3 arrests. She was 17 years old she had an issue with bad checks. She was charged with fraud against financial institution. She paid back the restitution and was on probation that she successfully completed. In 2006, she received an OWI. Her blood alcohol level was .1. She received counseling and completed probation. In 2013, she went to CVS with her children. She was pulled over after leaving and was asked to search her car. She said yes. They found some stolen lotion in her daughter's purse. Tapes from CVS showed that her daughter had put the lotions in her little purse. The charges are to be dropped. She is allowed to test. Her license is to be issued on probation for 6 months active practice with quarterly reports. She needs to send in documentation showing that the criminal charges related to the CVS incident have been dropped.
7. **Amber E. Rasberry** **RN Exam** **Failed 3 Times/Graduated 2008**
Ms. Rasberry appeared for her personal appearance regarding her application for licensure. She has taken the NCLEX 3 times and did not pass. She has taken Hurst twice in the last 2 months. They provided her with a letter but it did not have the predictability. She needs to take a review course that will provide her with predictability. Once she has provided the board with documentation showing she has a 95% or greater chance of passing she will be allowed to test. License to be issued free and clear after she passes.
8. **Sandra Russell** **RN Endorsement** **Positive Response**
Ms. Russell appeared for her personal appearance regarding her application for licensure. She has an active Oklahoma license. In 1999, she was charged with actual physical control. She was sitting in the driver's seat while she was intoxicated. She was charged with public intoxication. In 2012, she was with a designated driver. The driver was pulled over and was taken to jail because he was drunk. She was charged with public intoxication. She is allowed to endorse. License is to be issued on probation for 6 months active practice with quarterly reports.
9. **Maria Menendez** **RN Exam** **Failed 2 Times/Graduated 1999**
Ms. Menendez appeared for her personal appearance regarding her application for licensure. She has an active Indiana LPN license. She completed RN school in 1999. She last tested for her RN about 4 years ago. She has been working as an LPN during this time. She has taken the Kaplan review and received documentation showing 95% predictability on passing. She is allowed to test and her license is to be issued free and clear.
10. **Destiney M. Nehrig** **RN Exam** **Failed 3 Times/Graduated 2012**
Ms. Nehrig appeared for her personal appearance regarding her application for licensure. She has taken the NCLEX 3 times and not passed. She has taken ATI and a proctor exam. She does have documentation showing 95% predictability on passing. She is allowed to test and license to be issued free and clear.

11. **Jennifer Marie Nickolich** **RN Exam** **Positive Response**
 Ms. Nickolich appeared for her personal appearance regarding her application for licensure with her attorney Lorie Brown. In January 2012, she went to an ex-boyfriends house and got into an argument with him. She dumped her drink on him and left. A third party accused her of keying her car. She was charged with criminal mischief. She entered into a pre-trial diversion. She successfully completed her probation. Alcohol was not a factor in the argument. She does not have any other arrest. She has learned to not over look "red flags" and surround herself with better people. She took counseling that showed no anger issues. Her school was aware of what happened. She is allowed to test. Her license is to be issued on probation for 6 months active practice with quarterly reports.
12. **Gina Howard** **LPN Exam** **CBC Hit/Positive Response**
 Ms. Howard did not appear for her personal appearance. Matter will be rescheduled one time.
13. **Michelle Ann Coulter** **RN Exam** **CBC Hit/Positive Response**
 Ms. Coulter appeared for her personal appearance regarding her application for licensure. She has had 2 arrests. In 2001, she had a DUI. She had been drinking and rear ended someone at a stop light. She also did not have insurance. Her blood alcohol level was .17. In 2006, she had a domestic battery and resisting arrest charge. The domestic battery charge was dropped. She was out with her husband on New Year's Eve. She had been drinking. She did not want to leave. Her husband and a friend tried to physically put them in the car. She fought with them. The police were called and she fought with them as well. She has not had a drink since. She is allowed to test. She will need to have an ISNAP evaluation. Her license is to be issued on probation. It will be for 6 months active practice or the length of her RMA (if she meets criteria). She will also need quarterly reports.
14. **Stephanie Marie Cooler** **RN Exam** **CBC Hit/Positive Response**
 Ms. Cooler appeared for her personal appearance regarding her application for licensure. In 2009, she was out and had a drink; she had also just started a new medication. She left to drive home. She fell asleep at the stop light. She was approached by a police officer. Her blood alcohol level was .08. She was 20 at the time. There was no one else with her in the car. She no longer drinks. She is allowed to test. Her license is to be issued on probation for 6 months active practice with quarterly reports.
15. **Monty Wayne Layman** **RN Endorsement** **Positive Response**
 Mr. Layman did not appear for his personal appearance. Matter will be rescheduled one time.
16. **Richard L. Cain** **APN/CSR Applicant** **Positive Response**
 Mr. Cain appeared for his personal appearance regarding his application for licensure. Mr. Cain currently holds an active Indiana RN license. He is applying for his APN/CSR. In 1989, he was in a fight with a couple other guys. That was is only arrest. In 2007, he was terminated due to a personal conflict with another employee. He was fired for intimidation. He fought the charge and won. The issue with the other employee did not happen at work. He currently works at Med Tech as a professor. He is allowed to be licensed free and clear.
17. **Linda Yvonne Caldwell** **RN Endorsement** **Working on Expired Temp**
 Ms. Caldwell did not appear for her personal appearance. Matter will be rescheduled one time.
18. **Jordan Bryce Ellis** **RN Exam** **Failed 3 Times/Graduated 2010**
 Mr. Ellis appeared for his personal appearance regarding his application for licensure. He has previously taken 2 different review courses. He needs to take another review course that offers predictability. This will be his last chance to take the test. He will be allowed to test after he presents documentation showing he has 95% or greater at passing. He needs to have an ISNAP evaluation. If he meets criteria for a RMA then his license will be issued on probation the length of his RMA. If he does not meet criteria then his license will be issued free and clear.
19. **Jennifer Ann Hooper** **RN Exam** **CBC Hit/Positive Response**
 Ms. Hooper appeared for her personal appearance regarding her application for licensure. In 2000, she received a battery charge. She had spanked her son and bruised his butt. Her mother turned her in for spanking her son. She spanked her for going to the bathroom in his pants. In 2004, she received a battery charge for getting into a fight with her sister. In 2004, she had a battery charge with her ex. He showed up 6 hours late to pick up her son. They got into an argument. He told the cops that she threatened him. In 2006, she was in an argument with her mom. She threw a shake and her mom walked in front of it. She has multiple driving while suspended charges. In 1996, she had a battery charge against an ex. She has not had any incidents at work. She is currently going to anger management classes at the Swanson Center. She went to counseling on her own accord. She grew up in an abusive household and she did not to repeat that life with her own kids. Alcohol or drugs were not a factor in any of the battery charges. She needs to have an MMPI-2 and send back to the board. Once this documentation is received she will have to have a personal appearance in front of the full board.
20. **Sierra Renee Roberts** **LPN Exam** **CBC Hit/Positive Response**
 Ms. Roberts appeared for her personal appearance regarding her application for licensure. In 2007, she received a charge of criminal reckless and battery. She got into a fight with her son's father. They started fighting and she grabbed a knife to defend herself. She never actually used the knife on him. They both were arrested. The charges were dismissed. In 2011, she received another battery charge. She was at a friend's house. They were outside and a lady drove by. She yelled for the lady to slow down. The lady got out of the car and pushed her son out of the way. She then pushed the lady and she hit her head. Both ladies were arrested and charges dismissed. She had a criminal conversion and trespassing. She was with a friend that was shoplifting from a mall. She was arrested because she was there. She went through a deferral program and has been banned from the mall. She is allowed to test. Her license will be issued on probation for 6 months active practice with

quarterly reports. She will need to have an MMPI-2 test. Those results will be reviewed by the board to see if any additional action needs to be taken.

21. **Steven Edward Trask** **RN Exam** **CBC Hit/Positive Response**
Mr. Trask appeared for his personal appearance regarding his application for licensure. He had answered no on his application when he should have answered yes. He stated that was just a typo. He has a significant criminal history. In 2004, he had a DUI which was dismissed. In 2004 or 2006 he had a driving while suspended charge. His license was suspended due to speeding. He was hanging out with the wrong crowd. He had a public intoxication and disorderly conduct charge that was dismissed. He had a battery charge while in Chicago. He was in a bar fight that involved a group of guys. During the fight his twin brother hit a bouncer and they both were arrested because they couldn't tell them apart. In 2008, he had an OWI and endangering a passenger in Indiana. He did not blow so he didn't know what his blood alcohol level was. In 2010, he was charged with public intoxication. It was New Year's Eve. He went into a bar to use the restroom. He got into a fight while he was using the bathroom. After leaving the rest room he told the bouncer and the cops. Afterwards he started walking home. Some of the guy's friends followed him and tried to start a fight. He was arrested for public intoxication. He is allowed to test. He needs to have an ISNAP evaluation. If he meets criteria he will have to sign an RMA. His license is to be issued on probation for one year of active practice or the length of his RMA whichever is longer. He will also have to have quarterly reports and an MMPI-2 which will be reviewed by the board to see if any additional action is needed.
22. **Brenda S. Tillman** **LPN Exam** **Positive Response**
Ms. Tillman appeared for her personal appearance regarding her application for licensure. She has tested once since she graduated in 2012. In 2013 she received a DUI. She has a court date of September 4, 2013. In 2010, she had an ammunition charge. She was with a group of people and she did not know one of them had put ammunition in her trunk. She is allowed to test. Her license is to be issued on probation for 6 months of active nursing practice with quarterly reports. If she is placed on any type of criminal probation her probation will be whichever is longer.
23. **April Lynn Taylor** **RN Exam** **Positive Response**
Ms. Taylor appeared for her personal appearance regarding her application for licensure. She is currently in ISNAP with no pending issued. She is allowed to test. Her license is to be issued free and clear if she has completed her RMA; if not it will be the length of her RMA.

B. Appearances by Applicants for Renewal

1. **Diana Lynn Hall** **LPN Renewal** **Positive Response**
Ms. Hall appeared for her renewal application. Arrested in August 2012 for domestic battery with bodily harm against husband's girlfriend. Pulled hair and abrasion occurred. She had been drinking alcohol at the time this occurred. She had a warrant out, turned herself in and on day of sentencing changed plea agreement to complete jail time. Her conviction stands as misdemeanor battery. She last worked as a nurse September 2012. She has taken an anger management class and has moved out of the prior geographic area. Recommendation: Allow to renew on probation, must contact ISNAP and sign an RMA if eligible, 3 quarterly employer reports from nursing position.
2. **Chassidy Rene Harper** **LPN Renewal** **Positive Response**
Ms. Harper has a positive response on her LPN renewal. She was terminated in 2011 from the Indiana Masonic Home for tardies. She was tardy at least six times over the course of a year. She reports no other issues at Indiana Masonic Home. She was previously in ISNAP due to a positive drug screen for marijuana and came off of licensing probation in June 2012. She reports no alcohol use. She stopped working as an LPN in January 2012. Renew on probation with same order in effect from July 2012.
3. **Katigan Whitlock** **RN Renewal** **Positive Response**
Ms. Whitlock failed to appear in person or by counsel. Ms. McIntosh recommended renewal of the license on suspension.
4. **Tamara L. Bandy*** **LPN Renewal** **Positive Response (Currently Suspended)**
Ms. Bandy failed to appear. The recommendation is to deny renewal.
5. **Mary P. Topper*** **RN Renewal** **Missing Proof of Active License/CEU's**
Ms. Topper failed to appear. The recommendation is to deny the renewal.
6. **Mornie Thomas** **LPN Renewal** **Expired over 10 years**
Ms. Thomas failed to appear but sent an email to the group folder twenty minutes prior to her scheduled appeared today indicating she is ill. The recommendation is to reschedule one time.
7. **Kelly Trieglaff** **CSR Renewal** **Positive Response**
Ms. Trieglaff appeared based on the renewal of her CSR. She has a positive response because she received an OWI in February 2013. She refused the chemical test but had many drinks and indicates at least 10 drinks were consumed. She is an alcoholic and she relapsed. Prior to this incident, her date of sobriety was in May 2008 though she acknowledges her history with alcohol dates back to 2002. She is in ISNAP and is in full compliance. She signed her RMA in April 2013 and it is a 3 year contract. The recommendation is to grant CSR but she is aware that she will need to report this on her RN/APN renewal and that she will come back before the Board at that time.
8. **Michelle D. Cowan** **LPN Renewal** **Positive Response**
Ms. Cowan appeared regarding her LPN renewal. She has two positive responses on her renewal. She has had 3 arrests and was terminated from an employer. First arrest was in 2011 for public intoxication indicates she was "super drunk" and she fell asleep behind the wheel of a car that was not running. Upon arrest she had a warrant out for over purchasing of pseudoephedrine. She admits to use of methamphetamines but was also in a relationship with a man who was physically abusing her and forcing her to

obtain pseudoephedrine. She had another warrant out for her arrest and turned herself in for over purchasing pseudoephedrine again. The former boyfriend was making meth and she was aware of that at the time. The recommendation is to deny.

9. Stephanie Burdine RN Renewal Positive Response (FULL BOARD)

Ms. Burdine appeared before the full Board regarding her application for renewal. She is in the ISNAP program in Indiana. She moved to Florida and included an addendum in her Florida application and is in the Florida equivalent to ISNAP at this time. She has a disciplinary record on her Indiana license and has undergone investigation in Kentucky. Her discipline is based on opiate use at work in Indiana and the same scenario in Kentucky and Florida. Her Indiana license was suspended when it expired. The recommendation is to renew on suspension for participation in ISNAP. 5-0-1, motion carries McIntosh/Burghduff (Hall abstained)

10. Candace Vice LPN Renewal Positive Response

Ms. Vice appeared regarding her positive response on her LPN renewal. She worked for a private practice family medicine physician who is now joining with a new health network. Her license was inactive since 2010 and she indicates that while she believes she sent in payment in prior renewal periods but the licensing system shows no renewal fees paid or applications processed in 2010 or 2012. She was working as a medical assistant in private practice and does not believe she signed documents as an LPN, she did not pass medication and did not wear any identification as an LPN. The recommendation is to deny renewal and refer to the OAG for investigation.
