- II. **ADOPTION OF THE AGENDA**
A motion was made and seconded to adopt the agenda as amended. Burghduff/Laux, 8-0-0, motion carries


- III. **ADOPTION OF THE MINUTES FROM THE JUNE 21, 2012 MEETING OF THE BOARD**
A motion was made and seconded to adopt the minutes of the June 21, 2012 meeting. Narwold/Burghduff, 6-0-2, motion carries (Ogle and Hall abstain)

IV. **INDIANA STATE NURSES ASSISTANCE PROGRAM**

Chuck Lindquist, program director for ISNAP, presented the monthly report to the Board. Mr. Lindquist provided a handout of the June monthly report which indicates 226 nurses on probation or suspension are being actively monitored. ISNAP ran an INSPECT report on each of these individuals and 192 had no prescription activity. Mr. Lindquist also provided a handout regarding education for nursing students and addictions. The handbook has been updated to reflect ISNAP's change to Affinity Online Solutions and the changes to the ISNAP appeals process. Mr. Burghduff asked a question regarding an individual getting a prescription for 21 tablets of Hydrocodone for 7 days but when someone comes up 3 months later as positive and provides the old prescription that loophole should be closed and ruled positive with the prescription that is now several months out. Mr. Lindquist indicated that ISNAP will discuss that information with the ISNAP clinical team. Mr. Lindquist then addressed the audience.

V. **EDUCATION**

A. **Ivy Tech Columbus: Request for discontinuation of quarterly reports and removal of conditional accreditation**
NCLEX Scores: 2011: 86.73% First Quarter 2012: 97.92%
Staff from Ivy Tech Columbus appeared. The campus has been on conditional status since November 2010 and has submitted six quarterly reports. They have changed their culture to increase rigor of the program and increased student



involvement in the program. They have strict admission guidelines and smaller class sizes to allow for faculty/student interaction. Remediation processes have improved. Students are being held accountable and they are using ATI. They now have their own Nursing advisor. Teamwork among faculty has improved greatly. **Board Action: A motion was made and seconded to remove conditional accreditation status and discontinue quarterly reports. McIntosh/Narwold, 7-0-1 (Dolk abstains)**

B. Ivy Tech Community College College-Wide NCLEX Performance Improvement Plan/Evaluation of Campuses Placed on Corrective Action Plan in 2012

Staff from all campuses was present. New initiatives on a state-wide level include: remediation, ongoing contact with students past graduation, integration of ATI resources, increased rigor of curriculum and test plans, strong administrative support, addition of more NCLEX questions, looking at each region to insure steady progression, new admission guidelines, involvement in the NCSBN simulation study and current development of state-wide clinical scenarios to be utilized in Fall 2012. Ms. Laux asked the % of adjunct vs. full time and Ms. Peters indicated it was less than 50%. Their MSN adjunct faculty % has also increased. Ms. Laux asked how NCLEX scores were improving. Their second quarter 2012 results indicate that every program except for one was above 80%.

Note: Ivy Tech Richmond ASN Program (2011 NCLEX 68.29%) and Ivy Tech Sellersburg ASN Program (2011 NCLEX 71.43%) will require site visits in 2012.

C. Indiana University School of Nursing @ IUPUI- Request for guidance on clinicals for international students Staff from IUSON @ IUPUI was present. Ms. McIntosh indicated there is no issue with them working as preceptors since they are not doing patient clinicals. Staff indicated the international students will not be doing clinical work instead they are completing a global plan with no direct clinical care and they are always supervised. **Board Action: A motion was made and seconded to allow them to participate in activities with no direct patient care. McIntosh/Ogle, 6-0-2 (Laux and Narwold abstained)**


B. Draft Annual Report Form from Education Subcommittee

- NCLEX results for the second quarter of 2012 have been released to Nursing programs;
- The ISNAP contract for the FY 2012/2013 has been executed by ISNAP and is now going through the process of obtaining state signatures;
- The Board's staff issued nearly 2,000 licenses in June 2012;
- The Board will be obtaining two new case managers in the next month;
- Ms. Crawford and Ms. McIntosh will be attending the NCSCN Annual Meeting in Dallas, Texas from August 7-10, 2012;

A. Appearances by Applicants for Licensure

- 1. Renea Stahl** **RN Examination** **CBC Hit**
 Ms. Stahl appeared regarding her license application. She has misdemeanors for shoplifting on her record. She has previously worked the ISNAP program before as an LPN. She shifted addictions from alcohol and drugs to shoplifting. She currently takes suboxone for depression. Her last arrest was in March 2012. She has gone through counseling and is part of a program for shoplifter's addiction. She works at Neurology Associates and Advantage Home Health Care. She has worked at these two places for the last 2 years. She is allowed to test. She needs to have a re-assessment with ISNAP. Her license will be issued on indefinite probation for one year of active nursing practice or length of RMA, whichever is longer. She is also restricted from working in home health care settings where there is no supervision.
- 2. Elizabeth Guy** **RN Examination** **CBC Hit**
 Ms. Guy appeared regarding her license application. She has an extensive history of alcohol related arrests. She states she is a recovering alcoholic. She started drinking in HS and continued in college. She has 2 arrests for minor consumption and DUIs in 2008 & 2009. In March 2012, she was pulled over for tail light out but found out there was a warrant for the 2008 DUI for not completing all probation classes. She is currently completing that probation which is due to be completed by August 20, 2012. She is not currently drinking and attends AA meetings once a week. She has been sober since 2009. She is allowed to test. She needs an ISNAP evaluation. Her license is to be issued on indefinite probation for one year of active nursing practice or length of RMA, whichever is longer.
- 3. Crystal Goodman** **RN Endorsement** **Out of State Discipline**
 Ms. Goodman appeared regarding her license application. She refused a drug screen at work and was terminated from employment in Missouri. Her Missouri RN license has charges pending against it. Her endorsement has been denied until issue in Missouri is cleaned up.
- 4. Melissa Puterbaugh** **RN Examination** **7 Failures; Graduated 1994**
 Ms. Puterbaugh appeared regarding her license application. She needs to take a review course and submit documentation showing 95% probability of passing. Once the document is received, she can test and license be issued free and clear.
- 5. Yolanda Latulip** **RN Examination** **CBC Hit**
 Ms. Latulip appeared regarding her license application. She had charges show up on CBC that shouldn't have been on there. Another CBC was run and those charges have been removed. One misdemeanor charge remains on her CBC. She was arrested for public indecency 20 years ago. She is allowed to test and licensed to be issued free and clear.
- 6. Marie Piechoinski** **RN Endorsement** **CBC Hit**
 Ms. Piechoinski did not appear regarding her license application. She will be rescheduled one time.
- 7. Lisa Hensley** **RN Examination** **CBC Hit**
 Ms. Hensley appeared regarding her license application. She has been charged with felony battery and neglect over son's broken arm. These charges are still pending. She took son to ER after a day of his arm hurting. The ER doctor said his arm could only have been broken by a blow and mom says son is a fitful sleeper. She answered "no" on her application because at the time nothing had been charged yet. Her son is accusing her husband of hurting him. She is allowed to test. Once the license is issued, the matter is to be referred to the Attorney General's office for investigation.
- 8. Kamri Macon** **RN Examination** **CBC Hit- Must be seen by full board**

Ms. Macon appeared regarding her application for licensure by examination for RN renewal. She had three misdemeanors. Minor consumption in 2002 she was drinking underage and got pulled over. She had a disorderly conduct charge in 2005 based on a physical altercation. She had an OWI in 2006 based on drinking. She indicates she was drinking "not much." She doesn't recall what her BAC was and then indicated she refused the breathalyzer. **Board Action: A motion was made and seconded to place the Respondent's license on indefinite probation, must have an ISNAP evaluation and sign an RMA if eligible. Must have one year of active nursing or one year in ISNAP RMA whichever is eligible.**

9. Keith Coyle **L.P.N. Endorsement** **CBC Hit**
Mr. Coyle appeared regarding his license application. He has an extensive criminal history. He also answered "no" to all questions on application. His last arrest was a result of being pulled over and his license was suspended due to no proof of insurance in IL. When police arrested him they found brass knuckles in the car and he was charged with unlawful use of weapon. These charges were dropped. He had previous charges when he was younger for theft, criminal damage and reckless driving/battery. In regards to the reckless driving/battery charge, he took plea bargain. He also plead guilty to battery but says that he didn't actually commit battery. The reckless battery charge was dropped. After these 3 charges he went into the military to turn his life around. He answered "no" because he states he is going to request the charges be expunged and didn't think he had to put it on there. He has an IL license that is active with no discipline against it. He is allowed to endorse and his license be issued free and clear.

10. Kelley Hughes **RN Endorsement** **CBC Hit**
Ms. Hughes appeared regarding her license application. In 2009, she went to doctor's appointment with her husband. Her husband was given a script and on the script she wrote in an additional medication. She gave the script to the pharmacy and the pharmacy called the doctor because it was written wrong. She was arrested. She went through community service and charges were dropped. She answered "no" because she thought since charges were dropped she didn't have to answer yes. Her Georgia license is active with no restrictions. She is not under any kind of criminal probation. She is allowed to endorse and her license is to be issued free and clear.

11. Carlee McDonald **RN Endorsement** **Pending Out of State Discipline**
Ms. McDonald did not appear regarding her license application. She will be rescheduled one time.


12. Jesika Jackson **RN Examination** **CBC Hit**
Ms. Jackson appeared regarding her license application. In 1995 and 2001 she was arrested for shoplifting. She was arrested again in 2010 for shoplifting but the charges were dropped. She shoplifted to make herself feel better and relieve stress. She now takes Paxil and Wellbutrin to deal with stress and depression. She has family support to help with anxiety and depression. She has plans on getting professional counseling. She is allowed to test. Her licensed is to be issued on indefinite probation for 6 months active nursing practice with employer reports quarterly.

13. Christopher Larsen **RN Endorsement** **CBC Hit**
Mr. Larsen appeared for his license application. Mr. Larsen has an IL nursing license. He was arrested several times for domestic dispute issues with wife. He pled guilty after one of the incidents because his wife said she would come back to him if he did. All criminal charges are related to his wife. They are currently going through a divorce. A divorce hearing is set for September 2012. His IL license is active with no discipline. He is allowed to be issued a temporary license with the online verification. Once his official verification is received from IL showing his IL license is active with no discipline then his license can be issued free and clear.

14. Charlie Kubik **RN Examination** **Positive Response**
Mr. Kubik did not appear regarding his license application. He will be rescheduled one time.

15. Tamla Johnson **RN Examination** **Positive Response**
Ms. Johnson appeared regarding her license application. She was terminated from her job as an LPN. There were allegations of Ms. Johnson not completing an assessment on a resident after being asked to. Ms. Johnson does not recall being asked this. She was presented with a write up and she refused to sign it due to the fact that she was never told to do the assessment. She was terminated because she would not sign the write up. She is allowed to test and her license to be issued free and clear.

16. Therese Tate **RN Examination** **CBC Hit**



Ms. Tate appeared regarding her license application. She had three hits on her CBC. Two were for driving on suspended license and no insurance and one was a domestic charge with the father of her child. Police were called after an argument. He made the phone call to the police so she was arrested. Her IL license is active and has had no discipline. She answered "no" on her application because charges were dropped. She is allowed to be endorsed and her license to be issued free and clear.

She indicated she is being framed because she is rich and people are trying to kill her for her money. Ms. McIntosh asked the last time she worked as a nurse and Ms. Perry indicated it had been almost two years. Ms. Perry indicated her ex-boyfriend has been raping her and putting her online.

Ms. Moore appeared regarding her application for renewal of her LPN license. She has 3 arrests for Class C felony forgery charges. Ms. Moore indicated she has been an addict since she was 13 years old. Every time she got in trouble she had been drinking or using. Mr. Burghduff asked what programs she completed. She indicated she has done NA, AA and IOP. Ms. McIntosh asked the last time she practiced and Ms. Moore indicated she has not practiced since 1996. 



Ms. Rodewald appeared regarding her license application. In 2009, she was charged with an OWI. She blew a .08 She attended a diversion program and the case was dismissed. She was previously arrested for disorderly conduct July 2009. She did not report this on her application because an attorney told her not to. She is allowed to test. She must get an ISNAP evaluation. She is to be licensed free and clear.
- 2. Nicole Sweetin** **RN Examination** **CBC Hit**
Ms. Sweetin appeared regarding her license application. She was arrested for minor consumption of alcohol. She did not report it because her lawyer told her it was going to be dismissed. She has had no other arrest. She is allowed to test. She needs an ISNAP evaluation. She is to be licensed free and clear.
- 3. Brooke Smith** **RN Examination** **6 Failures, Graduated May 2006**
Ms. Smith appeared regarding her license application. She needs to take a review course and return with 95% probability of passing. Once this documentation is received she can test. License should be issued free and clear.

Ms. Adeniyi appeared regarding her license application. She was terminated while working as an LPN. She falsified a patient's record by signing off on a dressing change that she did not do. She is allowed to test and her license to be issued free and clear.
- 5. Reno Williams** **LPN Examination** **Positive Response**
Ms. Williams did appear for her personal appearance. She had a suspended driver's license for no proof of insurance. In 2012, she went to jail based on a 2008 warrant for driving while her license was suspended. All her criminal matters are traffic related issues. She is allowed to test and license to be issued free and clear.
- 6. Silvia Hernandez** **LPN Examination** **CBC Hit**
Ms. Hernandez did appear regarding her license application. She received a disorderly conduct charge in 2002. She was at high school basketball game and was involved in a fight. In 2008 she received another disorderly conduct charge due to being involved in a bar fight. In 2010, she was terminated from her job because a resident's husband claimed she put his wife's soiled clothes in basket without first putting it in a bag. She is allowed to test. Her license is to be issued on probation for 6 months. Monthly reports from supervisor need to be submitted. She needs to take the MMP-II with primary focus on anger management.
- 7. Tristen Gesenhues** **RN Examination** **Positive Response**
Mr. Gesenhues appeared regarding his license application. He was pulled over and blew over the legal limit, at station he blew .016. He was arrested for a DUI. It is recommended he be allowed to test but needs to see ISNAP for an evaluation. License is to be issued free and clear.
- 8. Stephanie Santos** **RN Examination** **CBC Hit**
Ms. Santos appeared regarding her license application. She had a minor consumption charge in 2010, while in nursing school. This was her first arrest. She is allowed to test. She needs to have an ISNAP evaluation, and her license is to be issued free and clear.
- 9. Staley Street** **RN Examination** **CBC Hit**
Ms. Street appeared regarding her license application. She ran a home daycare center on an Air force base. She spanked her own child in front of a daycare child. The parent of the daycare child reported the matter to DCHS. DCHS found charges unsubstantial. The ADA went forward with charges of intimidation. She plead guilty to charges because she did spank her own child She is allowed to test, once her license is issued the matter is to be referred to AG's office for investigation.

- 10. LaToya Marshall** **LPN Examination** **CBC Hit**
 Ms. Marshall appeared regarding her license application. She was arrested in 2002 for fighting in high school. She was terminated in 2006 and 2011 for attendance issues as a CNA. She missed 2 days during her probation period due to pregnancy issues. In 2006, was pulled over with her cousin in the car. Her cousin had marijuana but told the cops that Ms. Marshall had it. She was arrested but not charged. She is allowed to test. She must contact ISNAP for an evaluation. Her license is to be issued on probation for 6 months with monthly performance evaluations from supervisor. She needs to have an MMP-II evaluation for anger issues.
- 11. Trisha Gunselman** **RN Examination** **CBC Hit**
 Ms. Gunselman appeared regarding her license application. She received an OWI in 2011. She was drinking at bar and made bad decision. When she was pulled over she blew .17. She plead guilty and did 16 hours of community service; her licenses was suspended for 90 days; and attended a 12 hours of alcohol classes. She was on probation until the end of May. She previously received a minor possession ticket in 2007. She is to contact ISNAP for an evaluation. She is allowed to test. Her license is to be issued on probation for 6 months of full compliance with ISNAP RMA. If she does not meet ISNAP criteria she can request to have probation withdrawn.
- 12. Robin Vescovi** **RN Examination** **Positive Response**
 Ms. Vescovi appeared regarding her license application. In February she was charged with criminal conversion. She was with sister-in-law, who shoplifted. She was charged because she was with her. The charges were completely dismissed after a plea agreement, which was 190 days of no trouble. She is allowed to test and license to be issued free and clear.
- 13. Joshua Williams** **RN Examination** **CBC Hit/did not disclose on app**
 Mr. Williams appeared regarding his license application. In May 2009, he received an OWI. He blew .07, blew chemical test and blew .08. He entered into a plea agreement. He was charged with PI, took drug and alcohol education and completed a probation period. He is allowed to test. He is to contact ISNAP evaluation. His license is to be issued free and clear.
- 14. Jeremy Hagen** **RN Examination** **Positive Response**
 Mr. Hagen appeared regarding his license application. He had a minor consumption in 1996 where he received OWI. He had an accident and left the scene. He blew a .094. He plead guilty. Mr. Salazar appeared regarding his license application. He does not meet criteria for ISNAP and does not take any medications. His license is to be issued free and clear. Reviewed results of MMP-II which did not indicate any issues.

While she was working at shoe carnival she was giving family and friend's discounts on their purchases. 


