## **INDIANA STATE NURSES ASSISTANCE PROGRAM**

Donna Goch, Director of the Indiana State Nurses Assistance Program (ISNAP) was present. Ms. Goch informed the Board that one of their approved addictionist has relapsed. The addictionist has been removed from the approved list and the patients have been referred to other addictionists in the area. As of April 30, 2004, the total number of nurses actively involved with ISNAP is 418. They have had 32 intakes and 19 discharges during the past month. They continue to do educational outreaches at every opportunity. Ms. Goch explained the program to the students in the audience.

### **DISCUSSION**

Rule amendments concerning requirements for licensure by examination and endorsement –Kristen Kelley addressed the Board regarding this matter. Ms. Kelly informed the Board that we need to repeal the rules regarding Multi-state licensure since Indiana is not being recognized as a compact state. There is also some clarification regarding applicants only being able to apply for licensure for the profession for which they have their degree. For example, a RN graduate cannot apply for licensure as a practical nurse.

### **EDUCATION**

Olympia College – Proposed Curriculum changes – Mary Klinefelter, President and Patricia Jones, RN, MSN, Chair were present to discuss this matter. Ms. Jones explained that these changes are based on the suggestions from the survey visit preformed by Laurie Peters, R.N. and Mervin Helmuth, R.N. She indicated they would admit twenty-four (24) students three (3) times per year. With each new class they will increase their faculty by two (2) full-time and 1 part-time instructor. After reviewing the suggested changes, the Board suggested the following:

- The Department Chair should be in control of the budget and should prepare the budget.
- All faculty should have input concerning the developmental objectives for the program.
- The faculty should also evaluate all clinical sites, not just the students.
- Throughout the policy, they need to change the reference of LVN to LPN.

After discussion, the Board moved to APPROVE the new curriculum changes. The Board scheduled the next survey visit for July 19, 2004.

Respondent did not appear in person and was not represented by counsel regarding a Notice of Proposed Default scheduled before the Board. The State of Indiana was not

represented in this matter and the court reporter in this matter was Charlotte Hedrick. The Respondent's contract with ISNAP has been closed for non-compliance. After having considered the evidence presented and taking official notice of its file in this matter the Board moved to hold the Respondent's license in DEFAULT.
