IV. INDIANA STATE NURSES ASSISTANCE PROGRAM

Roxanne Thomas presented ISNAP's report. The Needs Assistance Fund ("NAF") guidelines have been revised and are now increased to 200% above poverty level. Since January 2007 ISNAP has provided \$10,580 of NAF for UDS. ISNAP continues to see a decline in intakes (11 last month) as a direct result of the OAG's policy of not referring and fewer self reports, also not getting copies of the OAG letter so that they cannot follow up on those not responding to OAG's opening letter. ISNAP is now a regular part of St. Francis Hospital's nursing orientation and regularly provides training there every 2 weeks. ISNAP also provide orientation to IU Health. The Board made a suggestion of putting this information on CD and expressed concerns with the amount of time spent on outreach and training vs. the monitoring program. The Board further expressed concerns about the lag time between closure of the ISNAP file and the time the OAG files its cases. The Board requested ISNAP to forward a copy of its closure letters directly to the Board. The Board also requested a two (2) month time window between closure of an ISNAP file for noncompliance and Board action.
