Joseph Fischkelta, P.A. – Positive response

Mr. Fischkelta answered yes to the following questions on his license application:

- 2. Have you ever surrendered or been denied a license, certificate, registration or permit to practice as a physician assistant or any regulated health occupation in any state (including Indiana) or country?
- 4. Have you ever been the subject of an investigation by an authority regulating your profession?
- 5. Except for minor violations of traffic laws resulting in fines, and arrests or convictions that have been expunged by a court,
 - 1) Have you ever been arrested?
 - 3) Have you ever been convicted of any offense, misdemeanor, or felony in any state?
 - 4) Have you ever pled guilty to any offense, misdemeanor, or felony in any state?
 - 5) Have you ever pled nolo contendre to any offense, misdemeanor, or felony in any state?

Mr. Fischkelta's license was placed on probation for three years by Ohio in 2004 for failing to disclose upon renewal disciplinary actions taken by the Virginia Medical Board for forging Vicodin prescriptions.

In 2006 Mr. Fischkelta failed a drug screen, which was part of the terms and conditions of his Virginia Medical Board probation order. Ohio revoked his license in 2007 and Virginia Medical Board followed with a 3 year suspension. Virginia denied his ability to reinstate his license due to revocation in Ohio

NCCPA revoked his certification in 2007 and Mr. Fischkelta was able to recertify in January of 2018.

In 2017 Mr. Fischkelta was arrested for operating a vehicle under the influence, having a concealed firearm and child endangerment.

Fischkelta requested to withdraw his application.
