ORDER TO RELEASE FORFEITURE FUNDS

This matter having come before the Court on the State's Motion to Release Forfeiture Funds, and the Court, being duly advised in the premises and having reviewed the Motion and the Court's prior Agreed Order for Civil Forfeiture entered on March 10, 2026, now FINDS and ORDERS as follows:

1. The State's Motion to Release Forfeiture Funds is well-taken and should be GRANTED.
2. The Court finds that outside counsel has been properly employed in this matter pursuant to I.C. 34-24-1-8.
3. The distribution of forfeited funds shall be made in accordance with Indiana Code § 34-24-1-4(d)(3).

IT IS THEREFORE ORDERED that:

1. The Indiana State Police and/or the Switzerland County Sheriff's Department are hereby DIRECTED to release the forfeited funds totaling FIFTY-SEVEN THOUSAND NINE HUNDRED SIXTY DOLLARS AND ZERO CENTS (\$57,960.00) for distribution as ordered herein.
2. The funds shall be distributed as follows pursuant to I.C. 34-24-1-4(d)(3):
 - a. \$12,925.33 to Bascom & Kisor, LLC as attorney's fees pursuant to I.C. 34-24-1-4(d)(3)(A);
 - b. \$15,011.56 (one-third of the remaining amount after attorney's fees) to the Switzerland County Prosecutor's Forfeiture Fund pursuant to I.C. 34-24-1-4(d)(3)(B);

c. \$25,519.64 (eighty-five percent of the remaining proceeds) to the general fund of Switzerland County to offset expenses incurred in the investigation pursuant to I.C. 34-24-1-4(d)(3)(C);

d. \$4,503.47 (the remaining proceeds) to the Treasurer of State for deposit in the common school fund.

3. Such distribution shall be made within ten (10) days of this Order
