# RDA to Hold First Public Hearing on the Beverly Shores/Pines Transit Development District

*The RDA Board of Directors will hold the first public hearing on the Beverly Shores/Pines Transit Development District boundary on May 8th.*

CROWN POINT, IN (April 17, 2025) – The Board of Directors of the Northwest Indiana Regional Development Authority (RDA) will hold the first of two public hearings for the Beverly Shores/Pines Transit Development District (TDD) boundary on Thursday, May 8<sup>th</sup>, 2025. The hearing will begin at 10 a.m. and will be held in the main conference room of the Purdue Technology Center, 9800 Connecticut Drive, Crown Point, Indiana 46307.
