Sherri Ziller, a lifelong resident of Northwest Indiana, is currently serving as the organization's **President and Chief Executive Officer** as of October 2021. She had been serving as their Chief Operating Officer since 2012. The Northwest Indiana Regional Development Authority (RDA) is recognized as a highly credible organization known for catalytic project investments and strong financial management practices. She has been with the organization since inception, spring of 2006 and provides leadership in the RDA's efforts to support economic development and redevelopment throughout the Region. Sherri works with her leadership team to continually refine and implement the strategic growth plan to expand and position the RDA as a leader in regional development. She works diligently to provide oversight leadership in marketing development, operations, professional services and financial performance of the RDA. While managing the organization's overall activities, Sherri fosters an environment of accountability, excellence, collaboration, and innovation among the staff and demonstrates fiscal responsibility. Through strong communication, problem solving, capacity building, legislative awareness and financial leveraging, she works to solidify and foster new relationships and stronger regional collaboration. Sherri also develops financial plans and provides budgetary analysis to support the organization in providing guidance and understanding of revenue sources and expenditure costs needed to strengthen their budget. A strategic analysis of budgets yields effective and streamlined policy decisions for the RDA's Board of Directors.

The RDA is now entering its 20th year of operations and has reached a high water mark as an established organization. Sherri works with the RDA's partners to change Northwest Indiana's vision for itself and moving the region toward its economic development potential. Responsible for creating benchmarks for financial and policy performance, Sherri ensures best management practices are created, adopted, implemented and adhered to in all facets of the RDA's operations. Since the RDA's inception, all financial and internal control audits have yielded "clean" opinions. Sherri serves as the fiscal agent due to her expertise and strong dedication to the highest standards of public service when working with local, state and federal dollars.

Sherri works with the community and stakeholders to identify ways to leverage RDA investments. Partnered with her team, Sherri has assisted in leveraging over \$1B (*one Billion*) since 2006 from federal, state, local, private, and other sources of funds.



Sherri is working with the RDA to lead a coalition of partners on one of the largest economic development projects ever undertaken in the State of Indiana in the financing and planning of the West Lake Corridor and the Double Track commuter rail projects. In October of 2020, the Federal Transit Administration awarded the West Lake Corridor its full funding grant agreement. The same milestone was reached earlier that year with the Double Track project. As of today, both region-wide economic development initiatives, the rail projects, are fully funded through Federal, state and local match. This is the result of years of visionary planning, hard work and commitment at all levels of government and being a partner on this project has been a highlight in her career. This level of funding commitment by the administration shows that they recognize the importance of the West Lake Corridor and Double Track and its ability to grow our state's economy with new jobs and business development.

Prior to joining the RDA team, Sherri has served as full-time faculty for Kaplan Higher Education since 2001. Sherri has a demonstrable commitment to her students providing a student-centered approach to create the best educational experience possible for her learners. Sherri's practical experience makes her an excellent resource for giving students the tools they need to achieve their educational and career goals.
