Update on the Rail Investment (as of November 2023)

Development of the new rail lines and stations is progressing at a steady pace.

	West Lake		
9-mile extension of existing SSL service between Dyer and Hammond, includes four new stations, a maintenance and storage facility, refurbishment of 32 rail cars, and construction of 2,322 parking spaces.	Utilizing Design-Build contracting structure, contractor tasked with completing design elements before beginning construction of them.	Design is 91% complete; design of smaller civil works, train operating systems and one major bridges remain in progress.	Current construction is focuse on rail bed, utility relocation bridges, station areas and retaining walls.
Utility relocation south of 45 th Street in Munster is complete	The walls, roof and interior floor of the EALM building in Hammond are complete. Utility installation is ongoing.	Construction is 54% complete.	An extended period of testin and commissioning is require between construction completion and Revenue Service.

The NICTD team is focused on when the trains will be running. Revenue Service Date of May 1, 2025, is NICTD's current target. The FTA grant commitment is May 20, 2026.

Update on the Rail Investment (as of November 2023)

Development of the new rail lines and stations is progressing at a steady pace.

25-mile project area, includes 16 miles of new second track, the closing of 20 grade-level crossings in Michigan City, and the elimination of "street running" in Michigan City.	Overall Construction is 83% complete.	DT1 (Main rail project): Work is fully underway in the sections west of Dune Park with several bridges nearing completion. New overhead catenary system and systems testing activities have begun for areas west of Dune Park.	NICTD resumed train service between Carrol Ave. and Dune Park on the new tracks.
DT2 (MC 11th Street Station): Terracotta façade restoration is complete. The TOD developer has begun sitework on the station and parking site.	DT3 (Gary Miller Station): Work is schedule to be complete by the end of November.	DT4 (Portage/Ogden Dunes Parking Lot) and DT5 (Dune Park East Parking Lot): Projects are complete.	DT6 (Positive Train Control): Contract is 68% complete. Coordination continues with DT contractor.

Revenue Service Date of May 15, 2024, is NICTD's current target. The FTA grant commitment is November 6, 2024.


