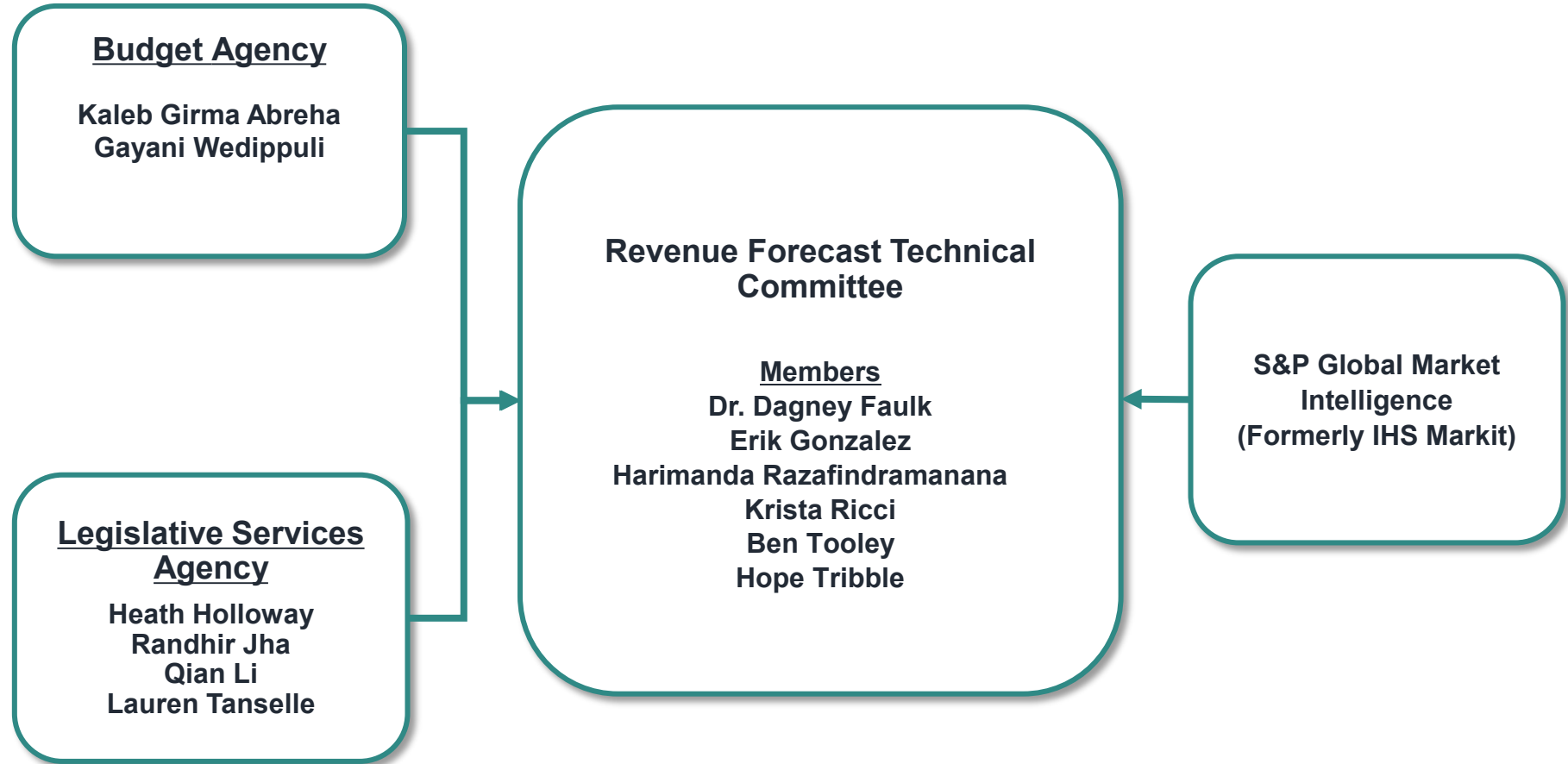

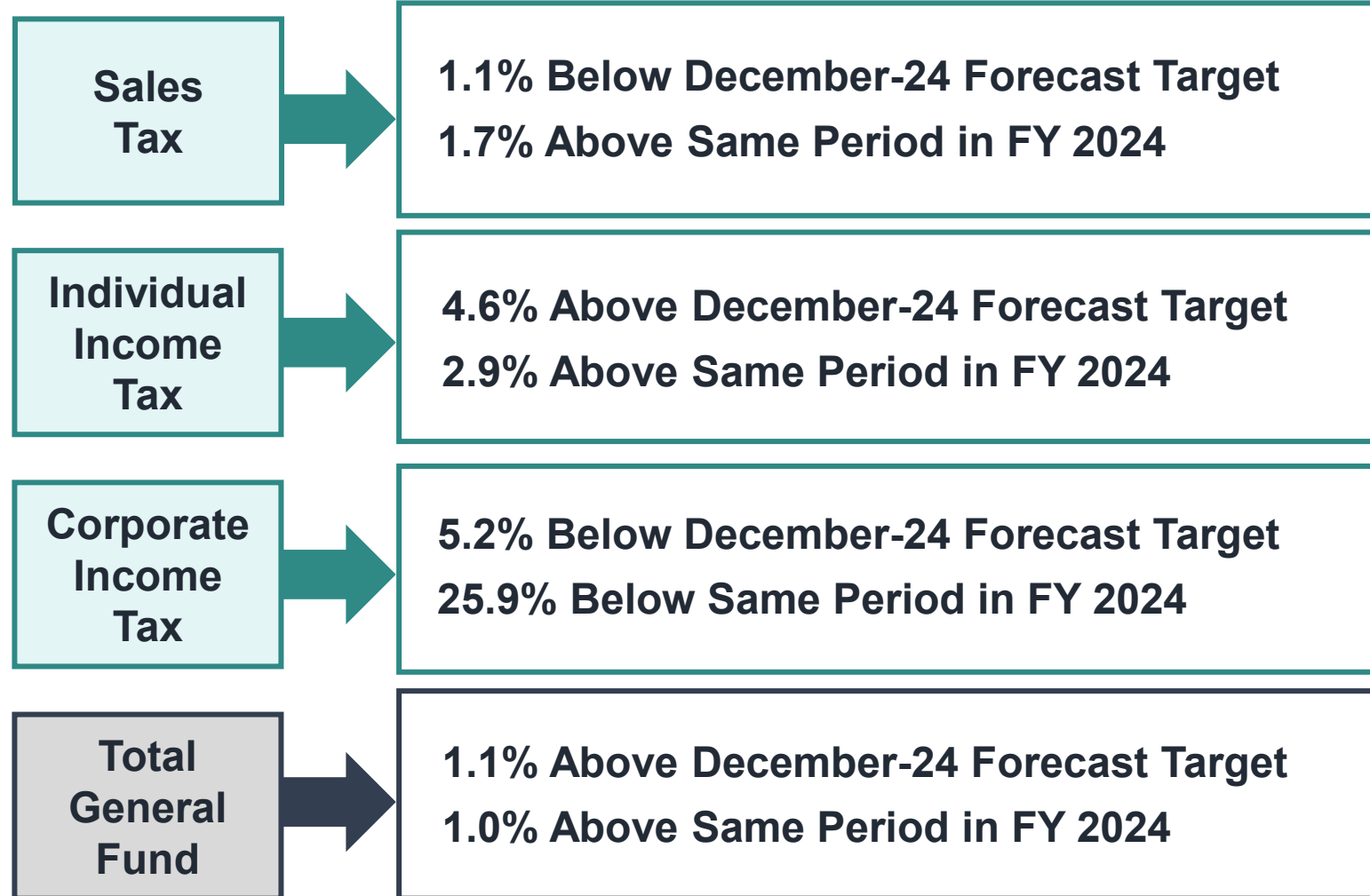

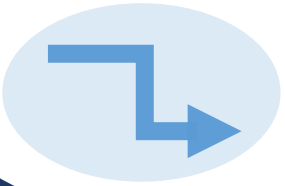

# Economic Forecast Overview



Upward revisions from September through December 2024 across key income indicators have been adjusted downward by S&P Global Market Intelligence.



While the broad economy is projected to continue to grow, growth projections for employment, wages and personal income have been revised downward from December 2024.



The combination of economic performance through the first quarter of 2025 and expectations of federal policy actions drive the outlook through the biennium.



During this biennium, the unemployment rate is estimated to rise close to 4.98% by mid-2027.

- Economic Nexus (removed 200 transaction threshold).
- Utility sales tax exemption for restaurants equal to 50% of the sales tax imposed on electricity.

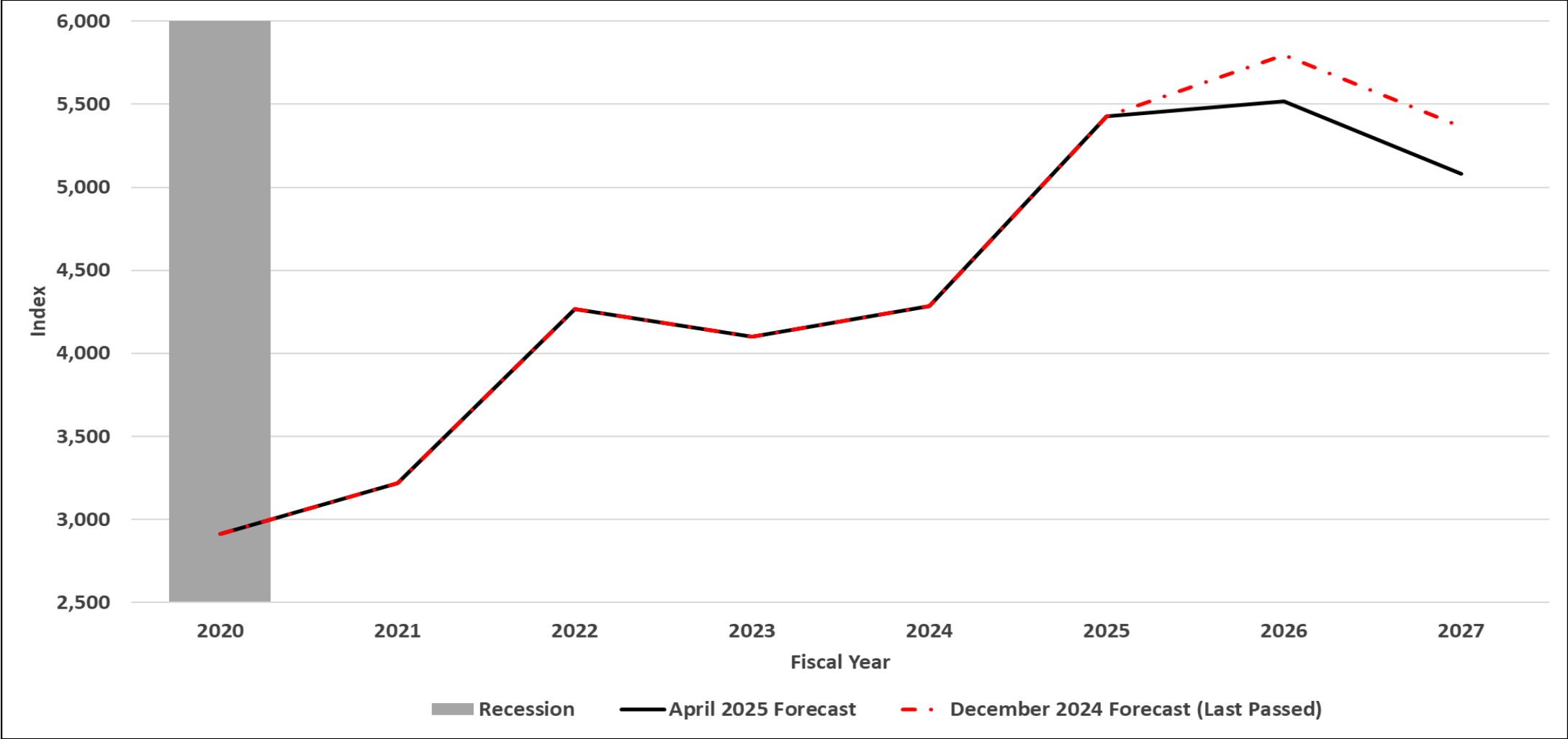
## Individual Income Tax Rate Reduction

- 2.90% in CY 2027

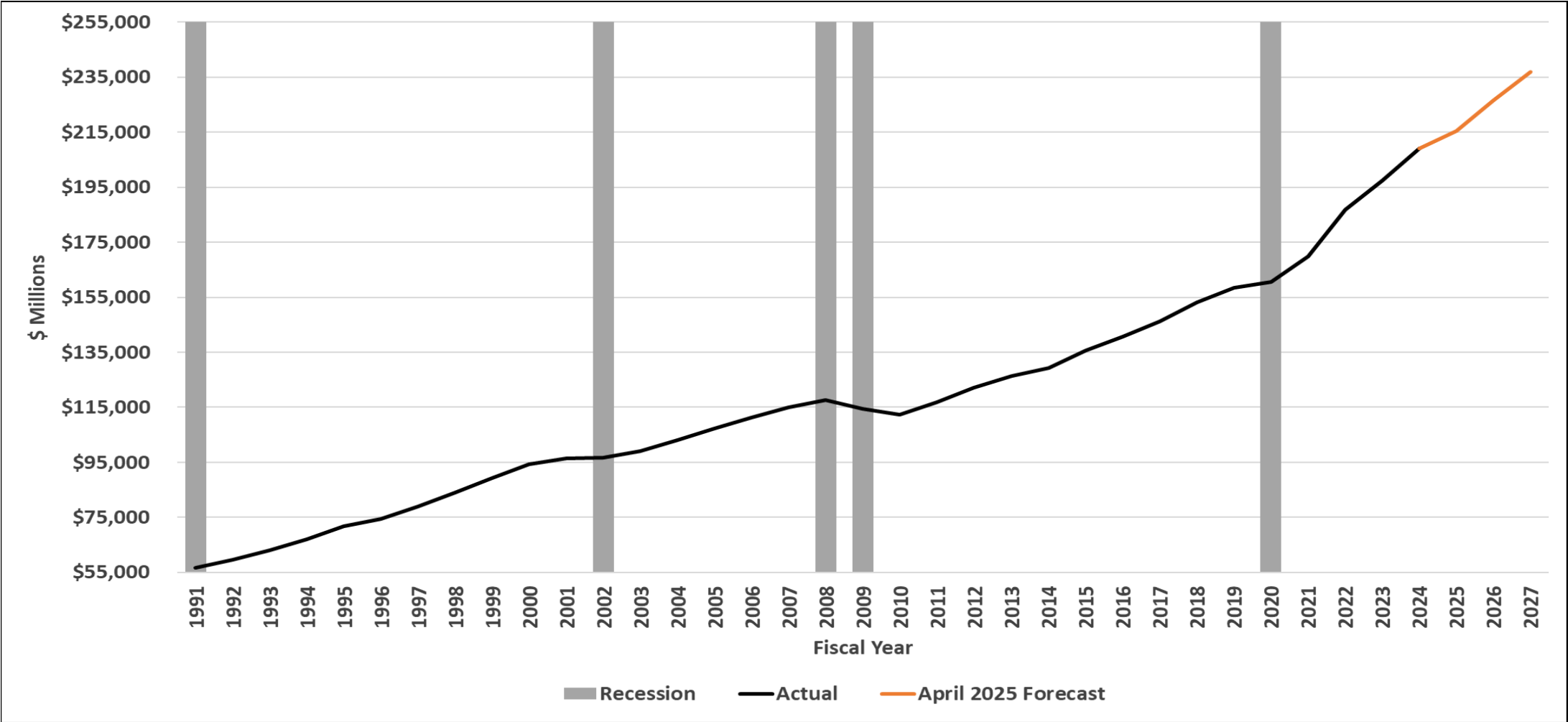
## Timing related to Pass Through Entity Tax Implementation

- Taxpayers adjust to changes in timing and flow of tax payments.

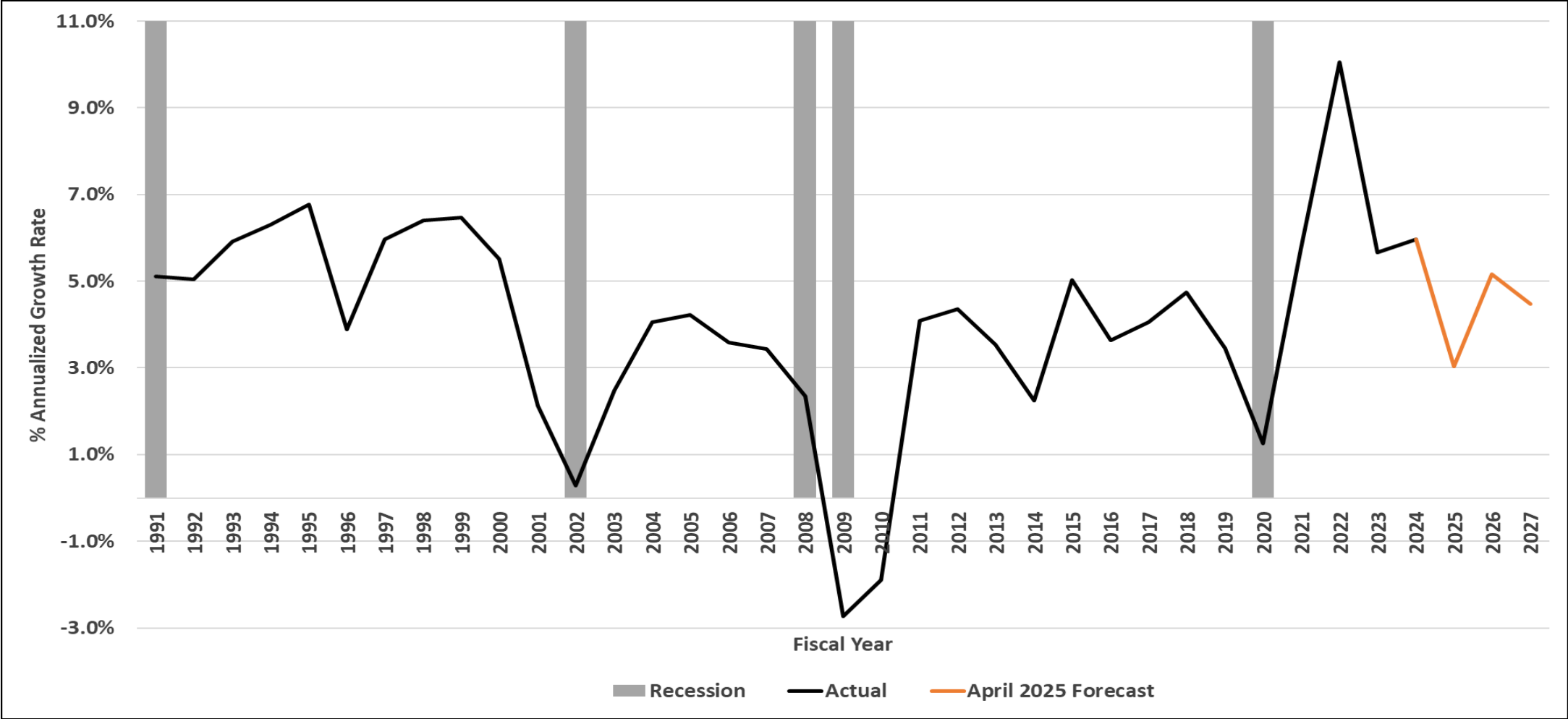
# Prior Calendar Year S&P 500 Index of Common Stocks

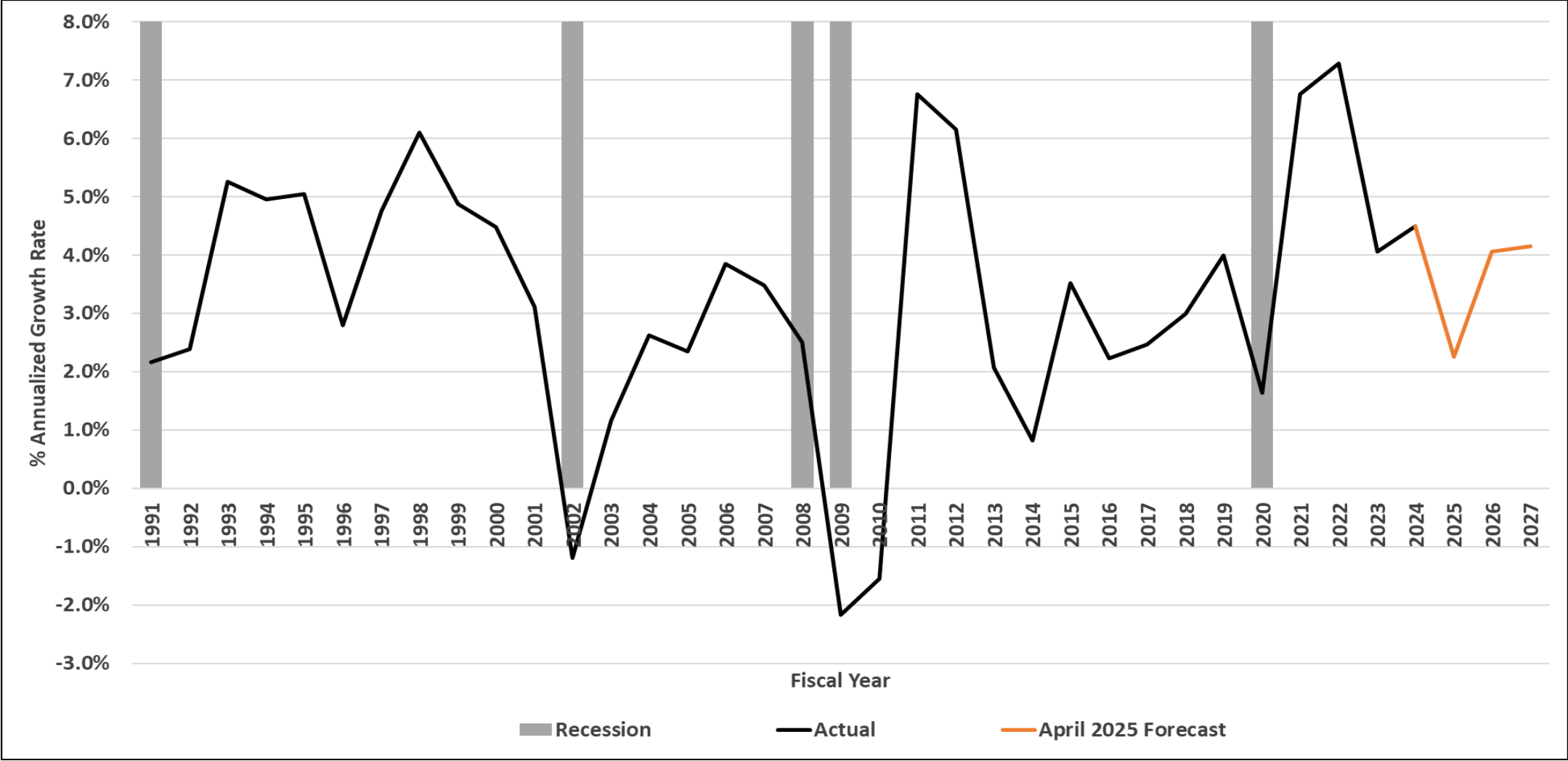


# Indiana Wages & Salary Growth over Prior Year

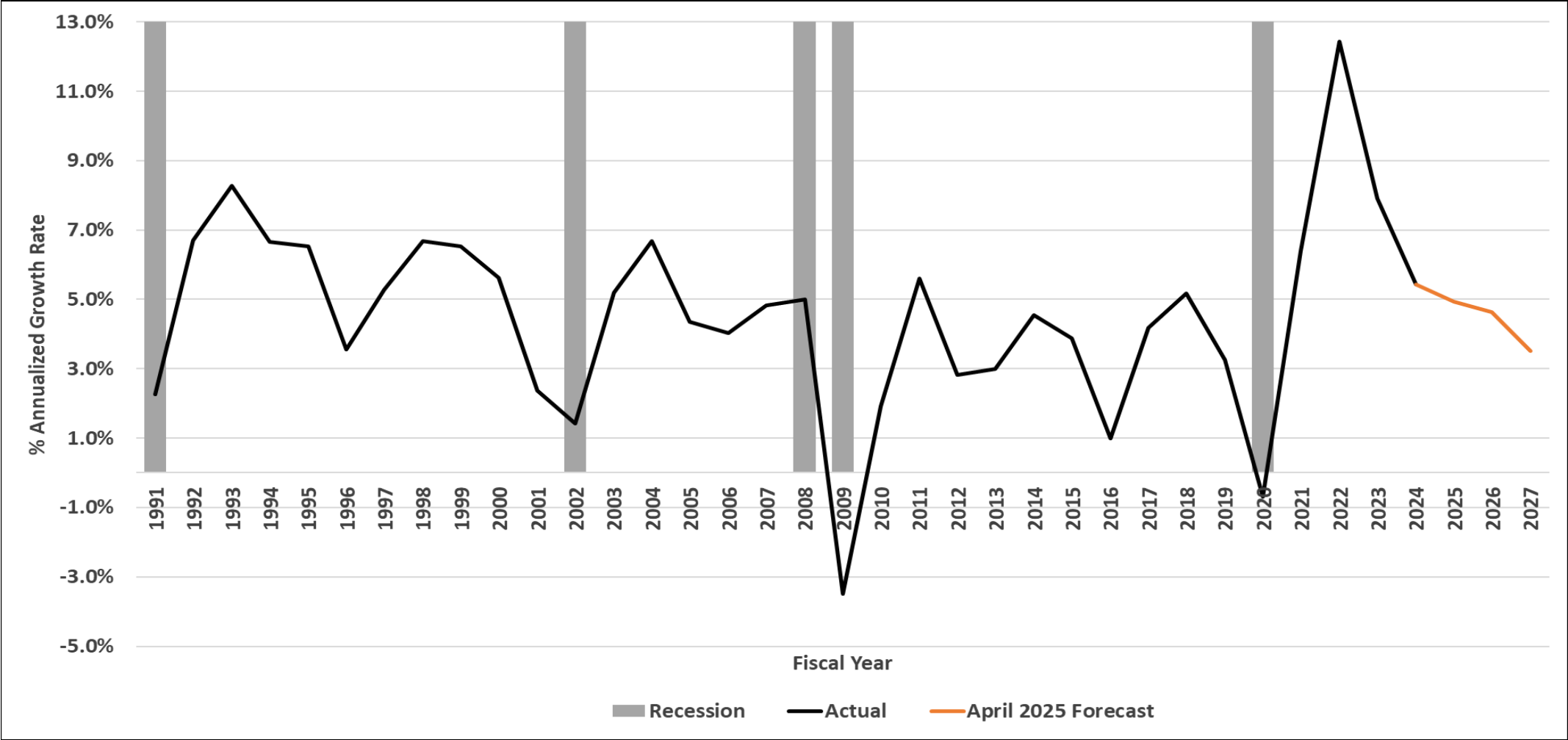

# Indiana Personal Income Net of Transfer Payments Per Household - Growth over Prior Year

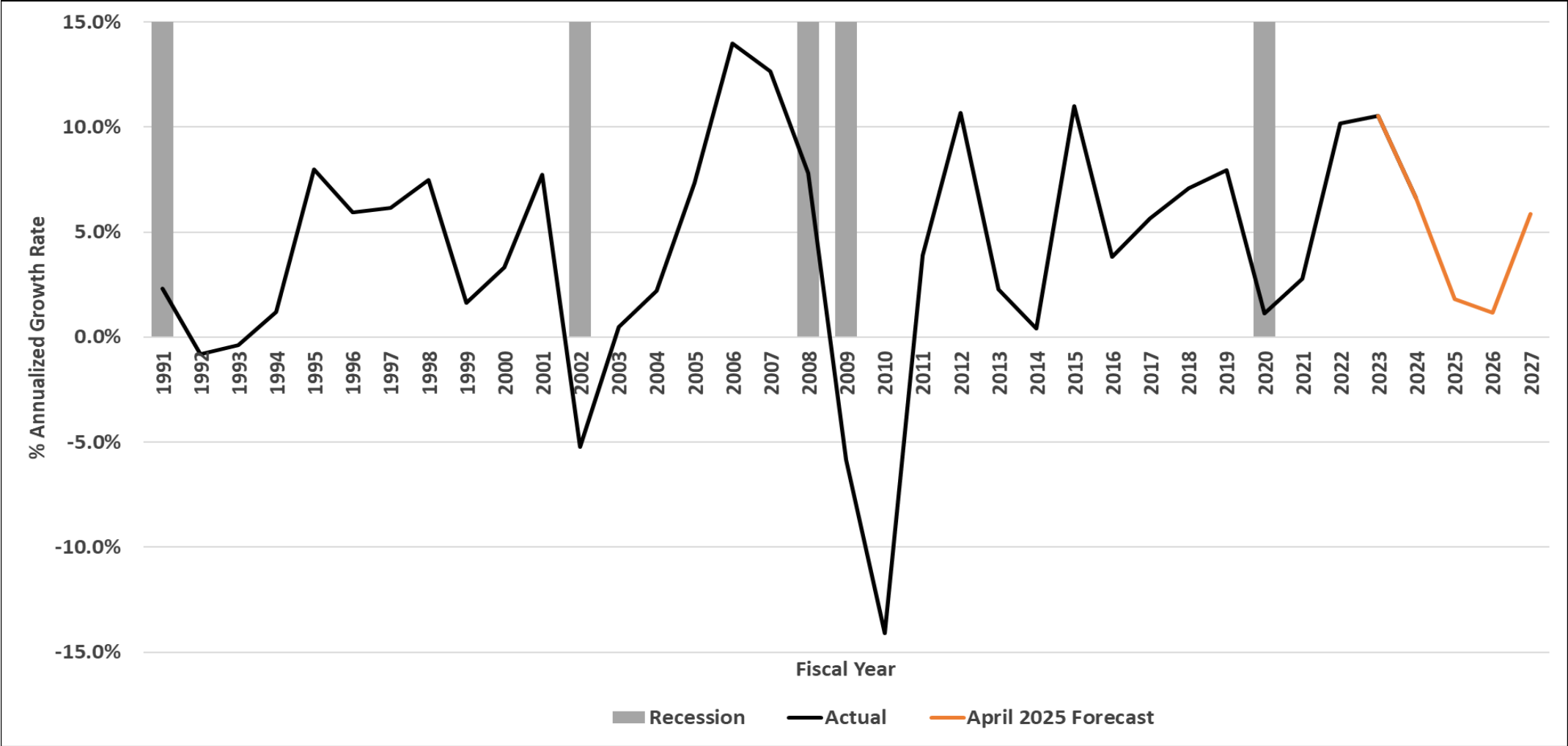


# Indiana Gross State Product Growth over Prior Year

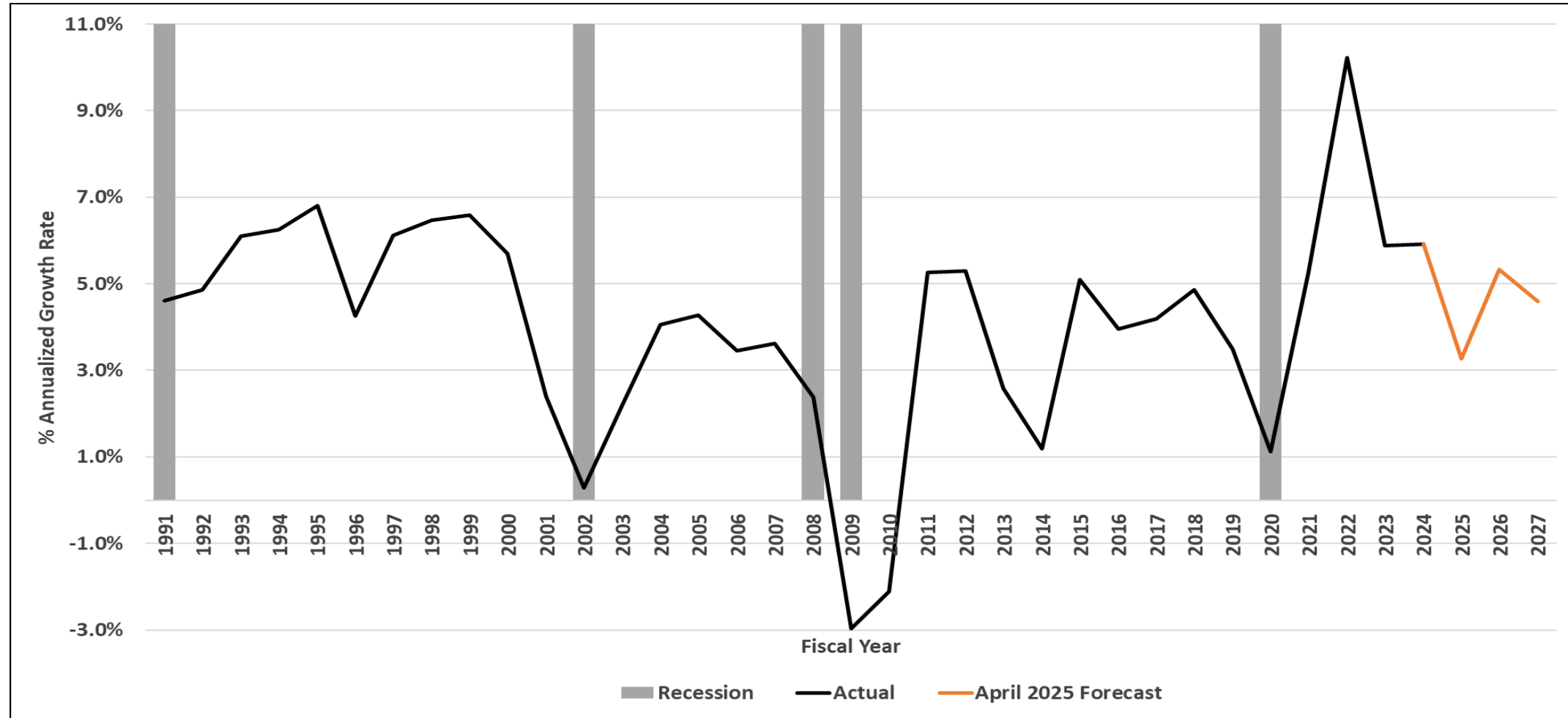




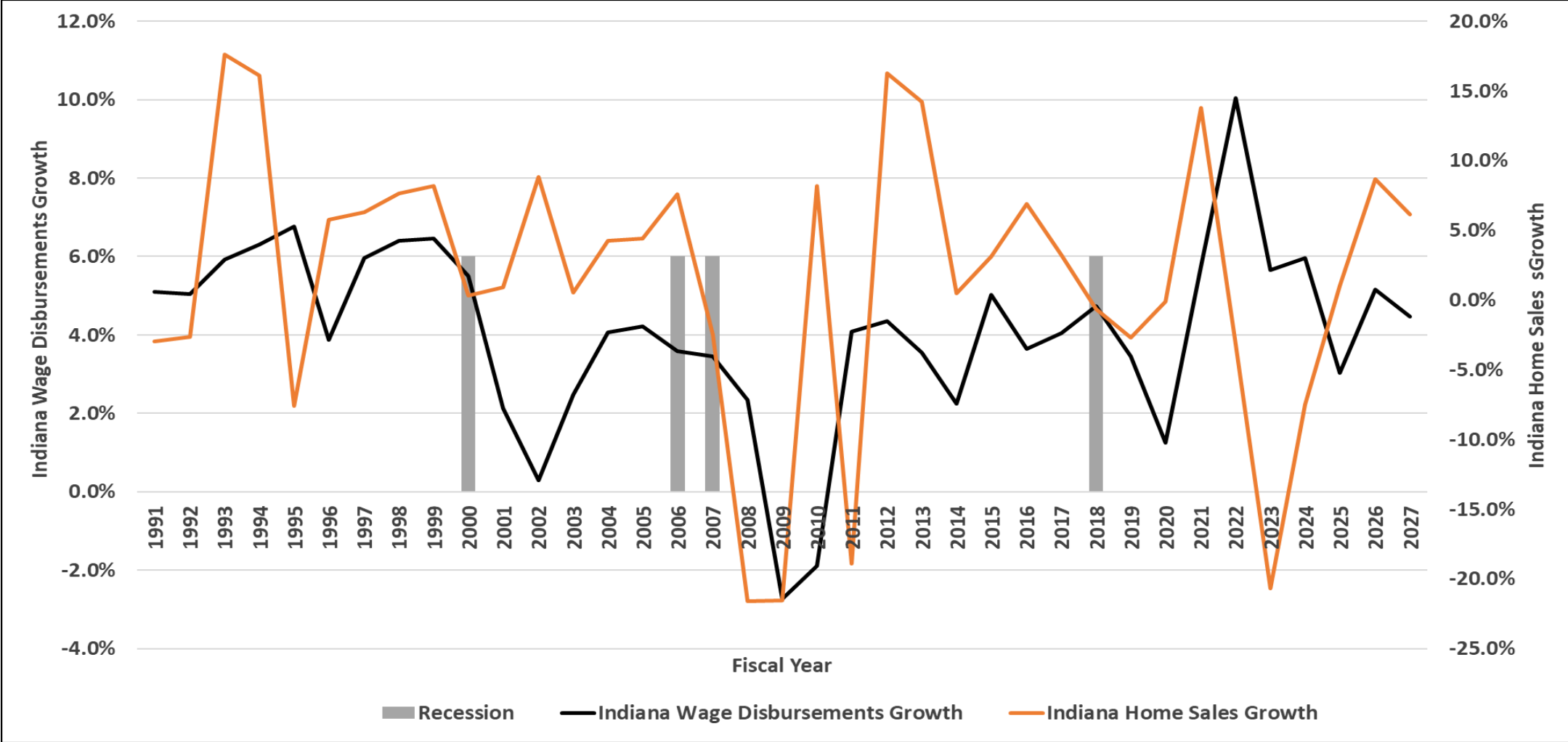
# U.S. Dividend Payment and Interest Income Growth over Prior Year

# Indiana Wage Disbursements and Home Sales Growth over Prior Year

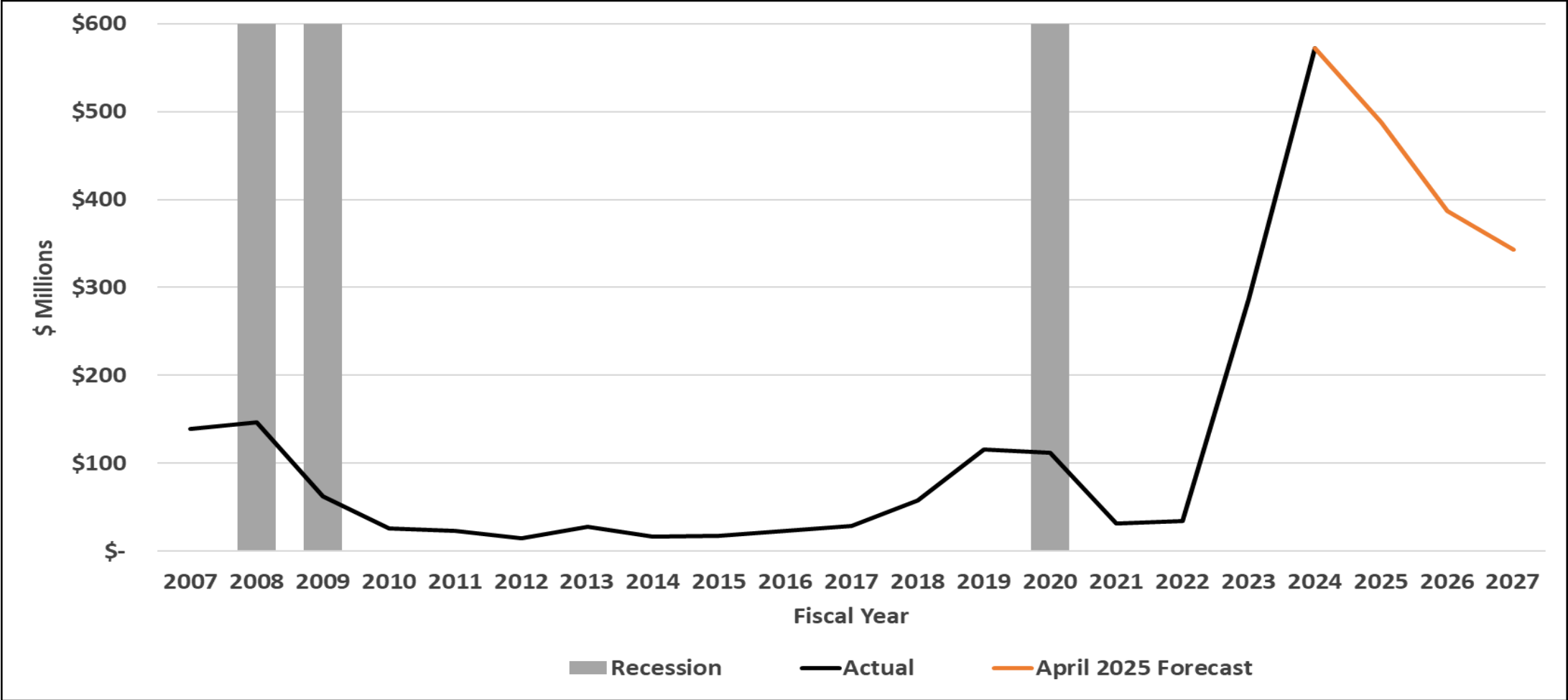

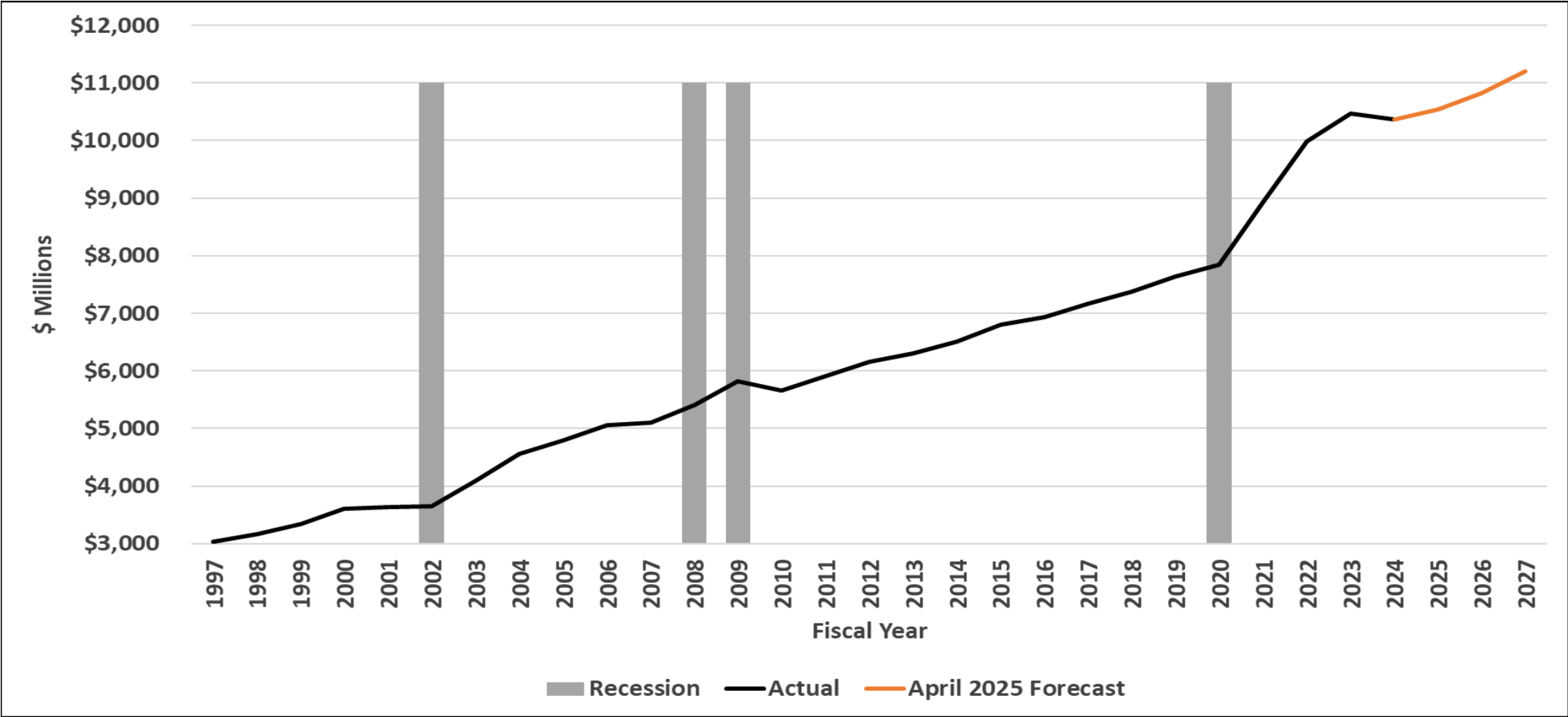

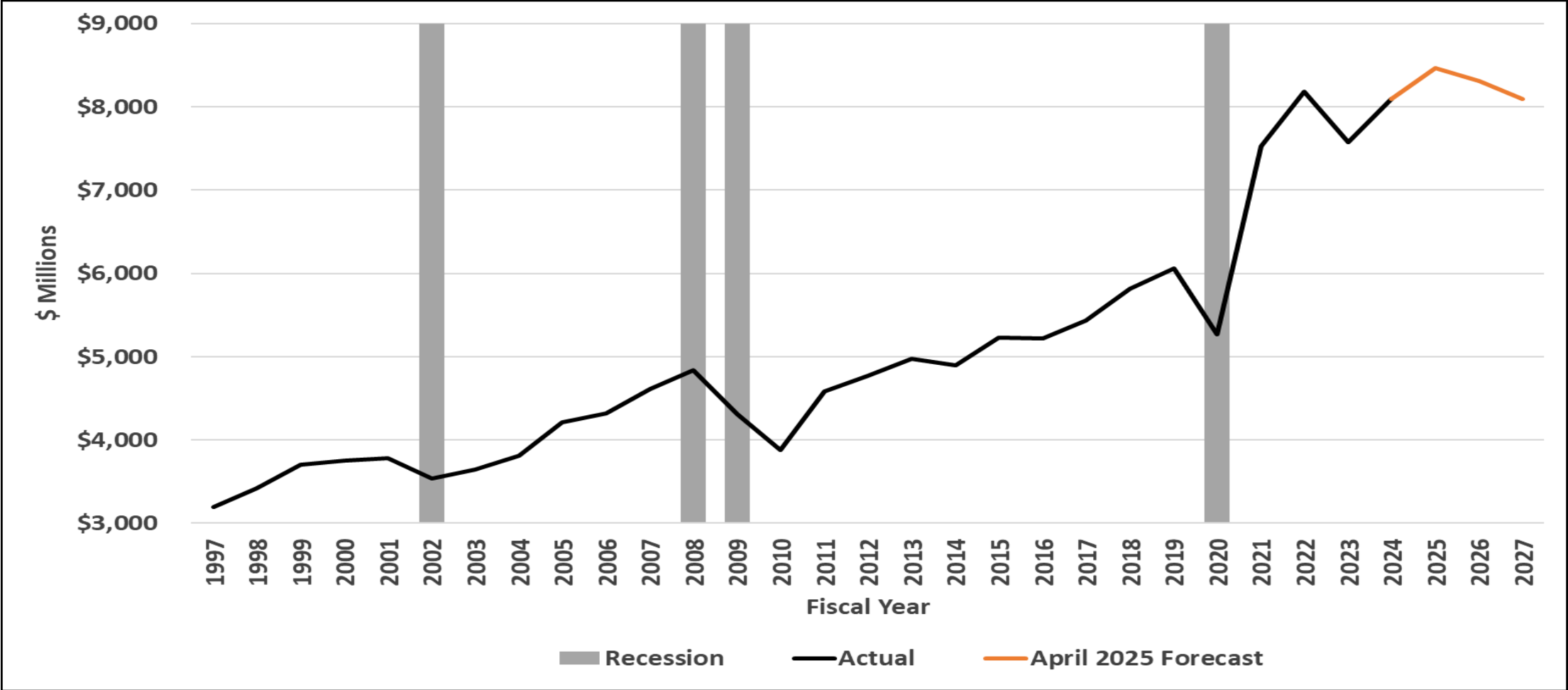

## Adjusted Sales Net of GUT Tax

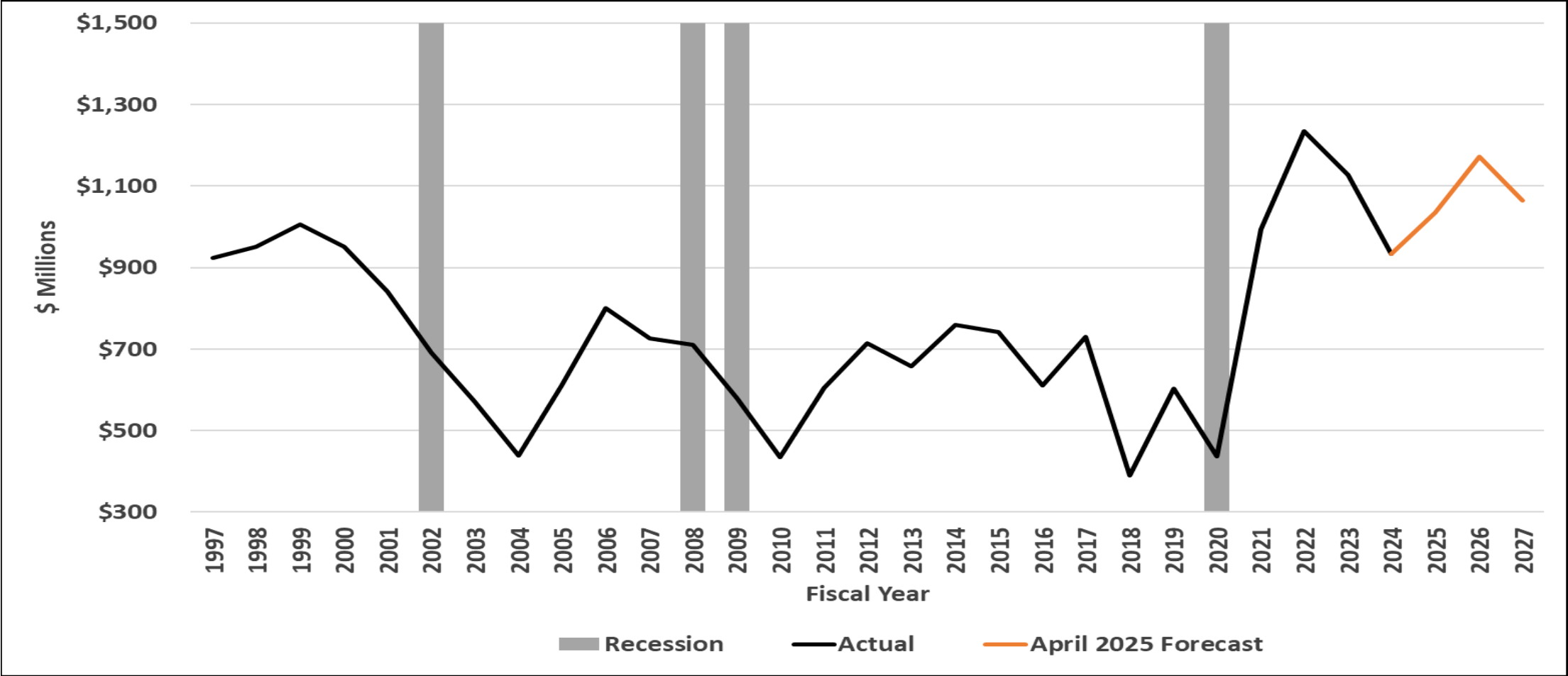
