### Who We Are and What We Do

Division	Principal Activities
Advisory	Provides formal and informal legal opinions to state elected officials and legislators, reviews all state contracts and administrative rules, and serves as legal counsel to all professional licensing boards
Appeals	Represents the State in criminal, civil, and child services appeals
Litigation	Represents and defends the State in lawsuits in which the State's interests are at stake
Consumer Protection	Safeguards Hoosier consumers from predatory and unlawful business practices, antitrust investigations, data privacy violations, and ID theft.
Solicitor General	Defends state statutes from constitutional challenges, pursues litigation against the federal government, and drafts amicus curiae briefs advocating for vital state interests.
Medicaid Fraud Control Unit	Investigates providers and enforces state health care laws to protect elderly patients in Medicaid facilities, keep costs as low as possible, and to ensure tax dollars are being spent properly
Unclaimed Property	Connects Hoosiers to their unclaimed assets that have been remitted to the State

# Appeals Division

#### **Angela Sanchez, Chief Counsel**

The Appeals Division represents the State, its agencies, officers, and employees in civil appeals before the state and federal appellate courts and defends ever conviction challenged in the Indiana appellate courts or federal habeas corpus proceedings. Our Capital Litigation Team prosecutes all phases of a case after a sentence of death is imposed. The division also assists prosecutors, law enforcement, and crime victims by coordinating extradition of wanted fugitives and managing the State's Address Confidentiality Program.

In the first three quarters of 2024, the Division received decisions in over 1,300 cases and achieved favorable outcomes in over 95%. Some notable examples from the Indiana Supreme Court this year include:

- State v. Franciscan Alliance: prevented potentially catastrophic road-construction costs by reaffirming longstanding rules on the scope of just compensation owed to landowners in eminent domain suits
- Rust v. Morales: successfully defended the constitutionality of Indiana's requirements for candidates to appear on primary election ballot
- State v. Hancz-Barron: affirming convictions and four consecutive sentences of life without parole for the murder of mother and her three young children



# Litigation Division

#### Patricia Erdmann, Chief Counsel

The Litigation Division serves as the state's law firm. Our dedicated team represents the State and its agencies, officials, and employees in state and federal courts in complex and significant impact cases in almost every substantive area of the law. This includes representing and defending the State of Indiana in lawsuits in which the State's interests are at stake. The Litigation Division has four Sections – each with their own area of expertise:

- Administrative & Regulatory Enforcement Litigation
- Asset Recovery & Bankruptcy Litigation
- Government Litigation
- Real Estate Litigation

In FY 2024, the Litigation Division recouped more than \$17.6 million.


- Saved millions through successful litigation defense strategy and advocacy achieving significant savings for taxpayers.
- In 2024, the Litigation Division has 5,500 active matters. The Division has opened 3,274 and closed 3,110 matters.



### **Protection of State Interests**

James Barta Solicitor General and Corrine Youngs, Policy Director & Legislative Counsel

- Reviewed or authored 280 sign-on letters and amicus briefs in 2024.
- Received sign-on letters and amicus briefs from 39 states, both Republican and Democrat
- Joined 191 sign-on letters and amicus briefs that align with Indiana's values.

# Defense of State Legislation

#### **James Barta Solicitor General**

- One of the primary functions of the Solicitor General is to defend the laws passed by the General Assembly against constitutional challenges.
- Status of Recent Challenges
  - Pro Life: In 2023, the Indiana Supreme Court rejected the argument that Indiana's pro-life law violates an unwritten right to abortion. On remand, the trial court rejected other constitutional challenges to the law.
  - Sex in Schools: In 2023, a district court upheld the state law that ensures our very youngest schoolchildren do not receive ageinappropriate instruction on human sexuality.
  - Age Verification: In 2024, the Seventh Circuit allowed Indiana to implement its law requiring websites that offer hardcore pornography to verify that users are adults.
  - Protecting Hoosier Children: Recently, the Seventh Circuit upheld the State's law barring unproven gender-transition procedures for minors.



# Litigation Status: Opioid Settlement

#### **Betsy DeNardi, Special Counsel of Complex Litigation**

- Anticipated total contribution to State revenue of nearly \$1 billion
  - Confirmed settlements
    - Distributors \$407M over 18 years (reduced slightly because of pre-payments)
    - Janssen \$96M over 11 years
    - Three settlements for approximately \$7M each (Endo, Mallinckrodt, and Publicis)
    - Walgreens \$114 M over 15 years
    - CVS \$104.9 M over 10 years
    - Teva \$86M over 13 years
    - Allergan \$47M over 7 years
    - Walmart \$59M in single payment in 2024
  - Pending settlements
    - Continuing work to resolve Purdue Pharma bankruptcy
    - Kroger \$43M over 11 years
    - Anticipate additional settlements

We have been able to create a collaborative environment to work with local governments.
Through our partnership, we have been a key participant in facilitating recoveries for cities, towns and counties.




# Licensing Enforcement

#### Scott Barnhart, Chief Counsel and Amy Osborne Section Chief

- The mission of the Licensing Enforcement Section is to protect the rights of consumers using licensed professionals by investigating and litigating where appropriate.
- Since December of 2022, there have been 4,677 investigations opened with 724 of those matters being litigated.




### Litigation Status: Robocalls


- Leading two active multistate cases against organizations responsible for over 1 billion robocalls



### Homeowner Protection

#### Scott Barnhart, Chief Counsel and Chase Haller, Section Chief

- The mission of the Homeowner Protection Unit is to protect the rights of all individuals involved in the housing market by investigating and redressing deceptive acts in connection with mortgage lending and violations of relevant state and federal laws.
- Landlords at the very least owe their tenants properties that are fit for human habitation. When they fall short of that, we intervene.
  - 585 Complaints Resolved: Addressing issues such as landlord/tenant disputes, homeowners' association (HOA) complaints, and loan servicing conflicts.
  - Landlord Tenant Disputes: Represented 47.7% of total HPU complaints, with over 52% of investigations finding legal violations.
  - In Fiscal Year 2024, HPU obtained \$718,077.60 in judgments, including \$412,842.10 in consumer restitution.
  - Willow Brook Gardens Lawsuit: Resulted in \$150,000.00 in restitution and rent credits as well as over 160 eviction expungements.
  - Lugar Towers AVC Monitoring HPU has conducted multiple inspections and meetings with residents to ensure compliance with a settlement reached with Indianapolis Housing Agency.
  - HPU's impact is state-wide with lawsuits or investigations in Merrillville, Anderson, Plymouth, Indianapolis, and Mt. Vernon.
  - Criminal referrals: Work with FBI and other LEOs led to at least 30 felony and 11 misdemeanor charges.



## Medicaid Fraud Control Unit

MFCU as it is known across the state, fights to reduce Fraud by Medicaid providers and protect Medicaid recipients from abuse and neglect.


- The Unit is funded by a 75% federal grant and a 25% state match.
- The operation of an effective MFCU is required by federal regulations.

When Medicaid Providers commit fraud on the Medicaid program or Medicaid patients are harmed by providers, the unit investigates and prosecutes those cases criminally, civilly, or administratively – or sometimes all three. During the present biennial budget:

- The unit has thus far recovered over 4 million dollars from Medicaid Providers
- The Unit recovered over 2 million dollars from Durable Medical Equipment vendors in criminal cases leveraging data analytics and investigative work. This recovery highlights not just the funding recovered from unscrupulous providers but stopped future losses by those specific providers and deterred other fraud.
- The Unit has recovered nearly 900K in civil settlements from whistleblower suits.
- Investigations by the unit have resulted in 72 convictions and 66 indictments in state and federal courts for fraud on the Medicaid system or abuse and neglect of patients.










### **OAG Operating Fund Budget**
