Chairman Ryan Mishler called the meeting to order at 9:05 AM EST.

During the economic outlook presentation by IHS Markit Principal Economist Tom Jackson, Senator Liz Brown asked about the number of Hoosiers choosing not to work. Mr. Tom Jackson responded he did not have that figure but would follow up with the Committee.

Krista Ricci, Senior Fiscal Analyst of the Senate Majority Caucus, and Hari Razafindramanana, State Budget Agency Assistant Director, presented the Revenue Forecast Technical Committee's revenue forecast for fiscal years 2022 and 2023.

Allison Taylor, Medicaid Director, and Rob Damler, Principal and Consulting Actuary of Milliman, presented the December 2021 Medicaid Forecast. Senator Liz Brown asked if the Medicaid waiver and amendment services would increase due to the surplus. Ms. Taylor responded that she would follow up with the Committee concerning that question. Representative Gregory Porter asked if the public health emergency extended the net positive impact. Mr. Damler responded that he would follow up with the Committee concerning that question.

Following the Medicaid forecast, the Office of Management and Budget Director Cris Johnston presented the CARES Act Funding and American Rescue Plan Act updates. Senator Fady Qaddoura asked about how the Family and Social Services Administration (FSSA) had been awarded funds for early childhood programs and how FSSA planned to leverage these funds to address underlying issues. Mr. Johnston stated he would connect with FSSA and would follow up with the Committee.

Following the discussion items, Chairman Ryan Mishler introduced the minutes from the October and November 2021 meetings. Representative Tim Brown motioned to approve the minutes. Representative Gregory Porter seconded the motion. The October and November 2021 minutes were adopted by the Committee.

After the agency and university project presentations, FSSA State Medicaid Director Allison Taylor presented the Medicaid State Plan Amendments and Waivers. Representative Gregory Porter asked about

the Participant Directed Home Care pilot and which zip codes were selected and how. Ms. Taylor stated she would follow up with the Committee.

Last, Marian University Director of Enrollment Management, College of Osteopathic Medicine Kyle Hattenburg presented the Marian University Primary Care Scholarships review item. Senator Liz Brown asked how many students applied for residencies and didn't match. Mr. Hattenburg stated he would follow up with the Committee regarding that figure. Representative Gregory Porter asked the demographics of the students. Mr. Hattenburg said he would follow up with the Committee regarding that question.

After all agenda items had been presented and discussed, Representative Tim Brown motioned to approve the December 2021 agenda. Senator Fady Qaddoura seconded the motion. The agenda was adopted by the Committee.

III. Agency Projects

Indiana Department of Transportation (800) \$ 450,000
 Architectural and Engineering Fees for the Construction of the Mishawaka Unit Building,
 Salt Building, and Equipment Storage Building

The Department of Transportation requests funding for the architectural and engineering fees for the construction of the new Mishawaka unit, salt, and equipment storage buildings. The existing Mishawaka unit and salt buildings were built in 1967 and have several safety, environmental, and operational defects that necessitate the construction of new facilities. The existing garages do not allow for proper work clearances, nor do they contain an exhaust system or a wash bay. Further, the current salt building cannot fully contain all salt within the building. Due to it being filled over the capacity, the structural integrity of the salt building is compromised, and the surrounding ground and water supply are at risk of contamination. The architectural and engineering fee is about 6.5% (\$450,000) of the projected total construction costs for the unit, salt, and storage buildings. The actual construction of the aforementioned buildings has been proposed for FY23.

HVAC Update for Internet Crimes Against Children (ICAC) Laboratory

The Indiana State Police requests reallocation of capital funding to proceed with an HVAC upgrade at the ICAC laboratory at 21st and Post Road in Indianapolis. The original HVAC system was installed in 1981, making the current age approximately 40 years old. The ICAC lab is 20,480 square feet. The system operates with obsolete pneumatic controls and uses R-22 refrigerant that is currently being phased out. When the current units go offline, all climate control is lost within the facility. The new "zoned" systems will provide better technology and greater efficiency reducing costs to maintain and operate.

Whole-of-State Cybersecurity Initiative

The Indiana Office of Technology requests funding to proceed with phase one of the Whole-of-State Cybersecurity Initiative. The first phase of the initiative would provide a comprehensive assessment of the current cybersecurity needs at the local level in Indiana and enable a better understanding of its cybersecurity posture based on both national and industry standards. The project will consist of three phases: assessing available information, creation of a cybersecurity plan, and deployment of the cybersecurity plan.

1. Ball State University (780)

Grand Lawn Amphitheater Project No. D-1-21-1-01

The Ball State University Board of Trustees request authorization for the construction of the new Grand Lawn Amphitheater. The University's Campus Master Plan recognizes the importance of open spaces on campus and the roles those spaces play in enhancing the experiences of the University and Muncie communities. Additionally, the master plan notes the need for additional space for their College of Fine Arts. The proposed Grand Lawn Amphitheater, to be constructed along the East Mall, will feature a stage, dressing rooms, green room, control room, and mixing station. The amphitheater will provide another location for their programs within the College of Fine Arts to hold classes and performances, as well as create an outdoor setting for other arts and cultural events. This project was approved by the Commission in February 2021 at an estimated cost of \$3,150,000 but has since had an increase in estimated cost. The estimated project cost is now \$4,700,000 and will be funded with private gifts, grant awards, and internal reserves.

Biochemistry Building Main Electrical Distribution

Project No. B-1-22-2-04

The Purdue University Board of Trustees requests approval of the planning, financing, construction, and award of construction contracts for the Biochemistry Building Main Electrical Distribution Replacement. This project will replace two transformers and two electrical distribution systems in the Biochemistry Building that are past their useful life. This includes main switches, panels and circuit breakers that support building equipment and lighting. This project will improve service reliability, provide research laboratories with the flexibility to install more or different lab equipment and will enhance technician safety. The estimated cost of this project is \$2,300,000 and will be funded with Operating Funds.

3. Purdue University West Lafayette (760)

Schleman Hall, Steward Center, and Related Renovations Project No. B-1-22-2-03

The Purdue University Board of Trustees request authorization to proceed with the planning, financing, construction, and award of construction contracts for Schleman Hall, Steward Center and Related Renovations. This project will provide a home for the growing Data Science program in the existing Schleman Hall of Student Services with a total renovation of 101,000 GSF of space. This project will also include renovations to approximately 45,000 GSF of space in Steward Center to modernize and centralize student services and accommodate current occupants of Schleman Hall. Approximately 10,400 GSF will be renovated in the following facilities to support related occupant moves: Purdue Memorial Union, Hicks Undergraduate Library, and Recitation Building. This project is being pursued in place of the \$40,000,000 86,000 GSF new Data Science Building that was approved by the Purdue Board of Trustees in December 2019 and the Indiana Commission for Higher Education in February 2020. The total cost of this project is \$52,800,000 and will be funded with Operating Funds – Reserves and Gift Funds.

4. Purdue University West Lafayette (760)

Whistler Hall of Agricultural Research Mechanical Systems Replacement Project No. B-1-22-2-05

The Purdue University Board of Trustees request authorization to proceed with the planning, financing, construction and award of construction contracts for Whistler Hall of Agricultural Research Mechanical Systems Replacement. As part of this mechanical systems replacement project, the steam heating system will be replaced, along with the installation of three new air handling units and replacement of 100 individual exhaust fans with a new central manifold system. The project also includes changes to associated plumbing and electrical systems. The existing mechanical systems are past their useful life. This project will improve service reliability, provide research laboratories with the flexibility to install more or different lab equipment and will improve performance, energy efficiency and indoor air quality. The new systems will meet updated laboratory standards for temperature control and ventilation. The total cost of this project is \$12,500,000 and will be funded with Operating Funds and Repair and Rehabilitation Funds.
