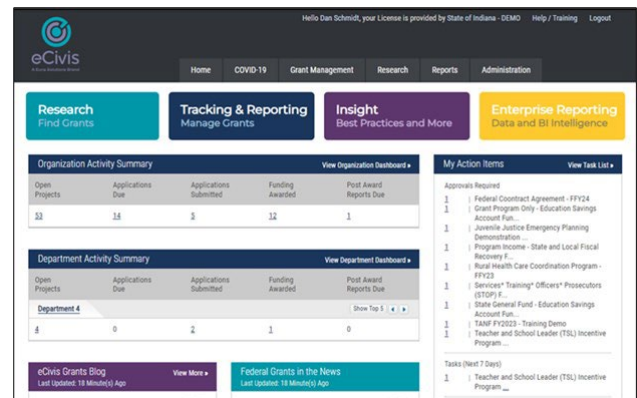
Introducing Euna Grants - The Next Step in Grants Management

What is Euna Grants?

Euna Grants is Indiana's new state-wide grants management system that will track grants from application to close-out.

All state agencies are required to use Euna Grants to manage state **and** federal grants.

Agencies will use Euna Grants to build solicitations, publish solicitations to applicants, review applications, issue award decisions, and perform grant close-out.



Dashboard state agencies will use to manage grants.

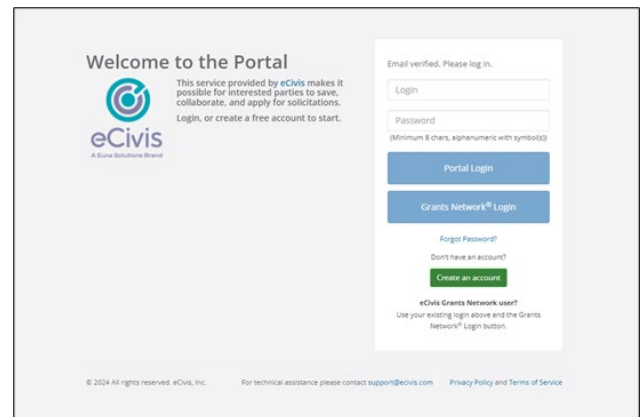
What does Euna Grants mean for recipients of state grants?

Grant applicants will access solicitations via the SBA website or a private link.

Applications will be submitted electronically through the Euna Grants Portal.

Grant recipients will receive their award notice via Euna Grants.

Recipients will use Euna Grants to submit activity reports, request reimbursement, and conduct grant close-out activities.

Why is grants management important?

The Office of Management and Budget and the Indiana State Budget Agency are driving an initiative to improve grants management.

As Indiana's state-wide grants management system, Euna Grants will help improve grants management in Indiana by tracking grants from application to close-out, streamlining the grants management process, and enhancing the effectiveness of state government's internal controls.

Euna Grants will also unlock new *federal* funding opportunities for Indiana's state agencies.

Please Note!

- On the State Budget Agency's [website](#), there is a full suite of Euna Grants resources available to state grant recipients.
- On the website, state grant recipients will find Euna Grants resources under the "subrecipient" heading.
- While state grant recipients are not "subrecipients" in their relationship to state agencies, the Euna Grants resources under "subrecipients" are applicable to state grant recipients.

For Euna Grants purposes, there is *no difference* between a subrecipient and a state grant recipient. While state agencies have different federal reporting requirements for federal funding distributed to a subrecipient, state grant recipients can view the term "subrecipients" as synonymous with "state grant recipients" in the Euna Grants system and the support resources.

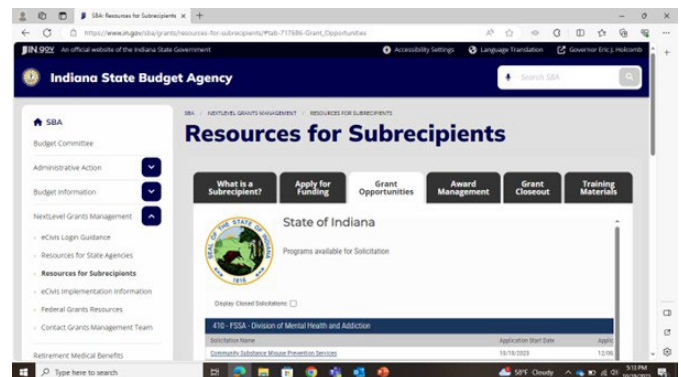
