We are required to be independent and to meet our other ethical responsibilities in accordance with relevant ethical requirements relating to the engagement. We believe that our examination provides a reasonable basis for our opinion on compliance with the requirements referred to above. However, our examination does not provide a legal determination of the School's compliance.

**Opinion**

In our opinion, the School Corporation complied, in all material respects, with the types of compliance requirements referred to above for the period from July 1, 2021 to June 30, 2022.
