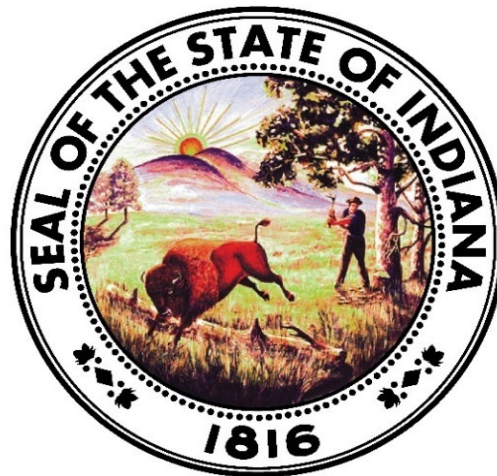

The Evansville Redevelopment Authority (Authority) is considered a component unit of the City of Evansville (City) under accounting principles generally accepted in the United States of America. The Authority's financial information was audited as part of the City's financial statements for the periods January 1, 2020 to December 31, 2022. The Financial Statements Audit Reports of the City, which provides our opinions on the City's financial statements and which includes the Authority's financial information, may be found at [www.in.gov/sboa](http://www.in.gov/sboa).

As authorized under Indiana Code 5-11-1, we engaged private examiners under our review to perform the audit of the City of Evansville and its significant component units. As a significant component unit of the City, the firm performed procedures to determine compliance with applicable Indiana laws and uniform compliance guidelines established by the Indiana State Board of Accounts. The procedures performed did not indicate any instances of noncompliance that warranted comment at this time. The procedures were not designed to identify all instances of noncompliance; therefore, noncompliance may exist that is unidentified.
