

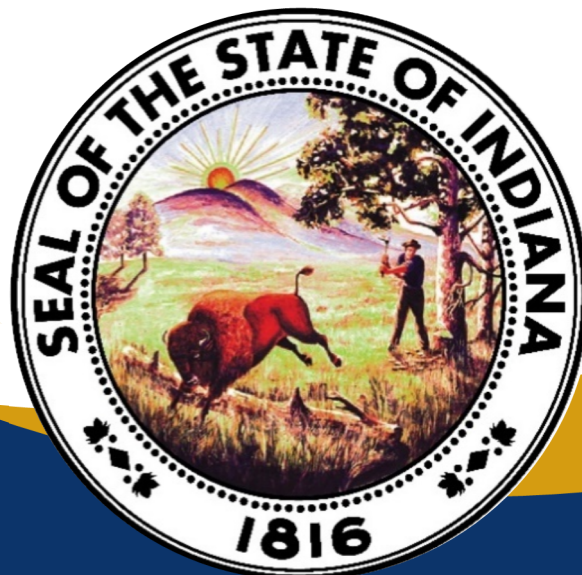

As authorized under Indiana Code 5-11-1, we performed certain procedures to the accounting records and related documents of the Marion Community Schools, Extracurricular Accounts (School ECAs), for the period of July 1, 2021 to June 30, 2023. Management's responsibility also includes, but is not limited to, complying with other applicable Indiana laws, regulations, and Guidelines concerning how it operates: authorized sources and uses of funds and what reports are required to be prepared and filed.
