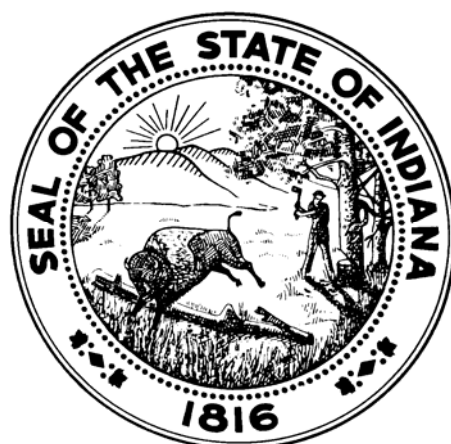

TRUSTS

The subsidiary records for each type of trust account (cash bond, judgments, restitution and trust) did not agree to the Clerk's Cash Book. A similar comment has appeared in prior Report B28792.

At all times, the manual and/or computerized records, subsidiary ledgers, control ledger and reconciled bank balances should agree. If the reconciled bank balance is less than the subsidiary or control ledgers, then the responsible official or employee may be held personally responsible for the amount needed to balance the fund. (Accounting and Uniform Compliance Guidelines Manual for Clerk of the Circuit Courts, Chapter 13)
