INDEPENDENT ACCOUNTANT'S REPORT

TO: THE OFFICIALS OF THE MADISON JUVENILE CORRECTIONAL FACILITY

We have reviewed the receipts, disbursements, and assets of the Madison Juvenile Correctional Facility for the period of November 1, 2009 to June 30, 2010. Madison Juvenile Correctional Facilities management is responsible for the receipts, disbursements, and assets.

Our review was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants. A review is substantially less in scope than an examination, the objective of which is the expression of an opinion on the receipts, disbursements, and assets. Accordingly, we do not express such an opinion.

Financial transactions of this office are included in the scope of our audits of the State of Indiana as reflected in the Indiana Comprehensive Annual Financial Reports.

Based on our review, nothing came to our attention that caused us to believe that the receipts, disbursements, and assets of the Madison Juvenile Correctional Facility are not in all material respects in conformity with the criteria set forth in the Accounting and Uniform Compliance Guidelines Manual for State and Quasi Agencies, and applicable laws and regulations.
