RECEIPTS AND DEPOSITS

We examined records relating to cash received at the School and selected 40 receipts for testing. We noted that 11 of the 40 receipts were not deposited in a timely manner. Receipts were not deposited for up to 66 days with individual late deposits ranging from \$25 to \$100.

All charter school money must be deposited in the designated depository not later than the business day following the receipt of funds on business days of the depository in the same form in which the funds were received. Timely receipts and deposits are required to provide the organizer and charter school administration with current information necessary for all financial decisions. (Accounting and Uniform Compliance Guidelines Manual for Indiana Charter Schools, Part 8)
