RE: Court Cost Changes

The following court fees will change, effective July 1, 2013.

**AUTOMATED RECORD KEEPING FEE** - The automated record keeping fee increases from \$5 to \$7, effective July 1, 2013. This does not affect the automated record keeping/deferral/diversion fee, which remains at \$5.

The Late Payment Fee that can be adopted locally by a court will be applicable to Class C and Class D Infractions as it does other case types on and after July 1, 2013 per HEA 1124. The late payment fee is authorized under IC 33-37-5-22. Changes in IC 34-28-5-4 as of July 1<sup>st</sup> will allow this fee to be charged when applicable for Class D Infractions for safety belt violations and Class C Infractions for handicapped parking violations even when the fine of up to \$25 is ordered.

SEA 387 raises the civil judgment from \$50 to \$100 on Class C infractions for handicapped parking violations.

A breakdown of court costs and fees on Infraction/Ordinance Violation Cases is attached.
