- (1) Collect \$.50 only if traffic offense and could be \$25.50 if exceeding the worksite speed limit or failure to merge.
- (2) If the criminal action is a misdemeanor and the defendant enters the pretrial diversion program.
- (3) As of July 1, 2022 the amount will be reduced to \$2.
- (4) However, if accused person enters into a pretrial diversion agreement under IC 33-39-1-8 the fee is \$5.
- (5) A court that adopts a local rule imposing a late payment fee may collect \$25.

- (1) The clerk shall collect from the party filing the civil action, a service fee of \$10 for each additional defendant named other than the first named defendant. The clerk shall collect from any party adding a defendant, a service fee of \$10.
- (2) Add a \$10 fee per garnishee defendant in excess of 3 whether named or added
(The fee noted in (1) and (2) does not apply to an action in which the service is made by publication in accordance with Indiana Trial Rule 4.13 or to an action filed through the Indiana electronic filing system adopted by the Indiana Supreme Court.
- (3) As of July 1, 2022 the amount is reduced to \$2.

- (3) As of July 1, 2022 the amount will be reduced to \$2.
- (4) A court that adopts a local rule imposing a late payment fee may collect \$25.

- (1) Monthly fee is \$20 for each month that the person remains in the pretrial diversion program.
The maximum time in the program may not exceed maximum length of the possible sentence.
This maximum length could include probation as an alternative sentence per *Davidson vs. State*
The above illustration uses a six month sentence, you will need to adjust the calculation
of the total fees based on the actual number of months of the program.
- (2) If the violation is non moving traffic offense, then this will not be collected.

- (1) If the infraction or violation is not a moving traffic offense, then this will not be collected.
- (2) \$50 goes to the deferral program and \$2 goes to the jury pay fund.
- (3) Monthly fee is \$10 for each month that the person remains in the program.
(These scenarios would illustrate a 6 month program. Your county may have different time ranges for the program which will cause your total to be different.)
