Subject: 2024-2025 Indiana Assessment Windows

The Indiana Department of Education (IDOE) recommends the 2024-2025 assessment windows to the Indiana State Board of Education (SBOE) for approval. Information regarding updates to typical testing windows is outlined below:

- The ILEARN Biology End-of-Course Assessment (ECA) will again be available for the typical three administrations (fall, winter, and spring). A fall window during the 2023-2024 school year was not administered due to updates to the Indiana Academic Standards for Science and the development of the new ILEARN Science assessment.
- Assessment windows for the new ILEARN Checkpoints Pilot program are included, but will apply only to schools that opt in to the pilot opportunity. The ILEARN Checkpoints are a component of the ILEARN Through-Year system.
