RE: Approval of Governing Body Change - Brownstown Central Community School

Corporation

Recommendation: Approve the proposed governing body plan change

Pursuant to IC 20-23-8, the Board of School Trustees of Brownstown Central Community School Corporation ("BCCSC") adopted a resolution to initiate a change to BCCSC's governing body plan. After adopting the resolution, BCCSC submitted the attached materials for the Indiana State Board of Education's ("Board") review and consideration, in accordance with the requirements set forth in IC 20-23-8-15.

Indiana Department of Education ("Department") staff reviewed the attached material and determined that BCCSC's plan and the manner in which it was initiated satisfy the requirements set forth in IC 20-23-8. As such, BCCSC's new governing body plan is recommended for approval.

To Whom It May Concern:

Brownstown Central Community School Corporation is among a small number of school corporations in Indiana that are appointed rather than elected. We believe this is a more favorable manner to fill our board seats as our townships' boards "vet out" candidates before their appointment. It also ensures that a majority of new members never begin their board terms at the same time.

Through consolidation that occurred over 50 years ago, 3 townships shared 2 board seats resulting in one of them not having board representation for periods as long as 6 years. Our board has worked cooperatively to create a new plan in which all 8 board seats rotate on an equitable schedule. The resolution to amend our current board plan and all other requested documents are included in this correspondence.

With the required 120 day period to file a petition protesting or proposing an alternative plan having passed, we respectfully submit our amended board plan for consideration by the Indiana Department of Education.

OF OWEN SCHOOL TOWNSHIP AND THE ADVISORY BOARD
OF OWEN TOWNSHIP, AND THE BOARD OF TRUSTEES
OF BROWNSTOWN CENTRAL COMMUNITY SCHOOL CORPORATION,
ALL OF JACKSON COUNTY, INDIANA, WHICH WAS HELD MARCH 31,1970.

A joint meeting of the Trustee of Owen School Township, and the Advisory Board of Owen Township and the Board of Trustees of Brownstown Central Community School Corporation, all of Jackson County, Indiana, was held at the High School Building of the Brownstown Central Community School Corporation in the Town of Brownstown, Indiana, at 7:30 P.M. on the 31st day of March, 1970.

Those present were Carl Dean Fisher, Trustee, Owen School
Township, Kenneth McMahon and Kenneth Sherrill, members of the
Advisory Board of Owen Township and Norman C. Brown, Ralph Kovener,
Ralph A. Mitchell, William D. Scharbrough, Osmar Schneider, Larry
E. Sullivan and Carroll Weaver, members of the Board of Trustees
of Brownstown Central Community School Corporation, William B. Sharp,
Superintendent, Brownstown Central Community School Corporation,
Russell C. Butt, County Superintendent of Schools of Jackson County,
Indiana, and Bruce Markel, Jr., Attorney at Law, Brownstown, Indiana.

Upon motion duly made and seconded, a joint resolution was adopted declaring the intention of said officials to consolidate their respective school corporations, being Owen School Township and Brownstown Central Community School Corporation, both of Jackson County, Indiana, and which said resolution was approved by Carl Dean Fisher, Kenneth McMahon, Kenneth Sherrill, Norman C. Brown, Ralph Kovener, Ralph A. Mitchell, William D. Scharbrough, Osmar Schneider, Larry E. Sullivan and Carroll Weaver, each in his respective official capacity, and by the signing of which, each of said persons expresses his approval of and the adoption of said resolution and which said resolution reads as follows:

RESOLUTION

A resolution declaring the intention of the Trustee of
Owen School Township, Jackson County, Indiana, upon the
recommendation and concurrence of a majority of the members of
the Advisory Board of Owen Township, and the Board of Trustees
of the Brownstown Central Community School Corporation, Jackson
County, Indiana, to consolidate the elementary schools and the
high schools of said Owen School Township and Brownstown
Central Community School Corporation and to furnish consolidated
school facilities for the children of school ages of said consolidated school corporation pursuant to the provisions of Chapter
123 of the Acts of the General Assembly of the State of Indiana,
approved March 7, 1947, and any and all amendments thereto, and
all other laws of the State of Indiana pertaining thereto.

Whereas, it would be conductive to, and result in, better school facilities, greater efficiency in the schools, increased educational advantages to the children of school age residing in said school corporations, afford more economical operation, and be to the best interest of the pupils of school age, the taxpayers and citizens of said two school corporations to provide for the education of all pupils of school age in the elementary and high school of each of said school corporations in a consolidated school in a single school corporation created and existing as one unit for all school purposes.

Now, therefore, be it resolved by the Trustee of Owen School Township upon the recommendation and concurrence of a majority of the members of the Advisory Board of Owen Township, and the Board of Trustees of the Brownstown Central Community School Corporation:

That the elementary schools and the high schools of Owen
School Township and Brownstown Central Community School Corporation, each of Jackson County, Indiana, be consolidated as a single school unit and school corporation, and

That Owen School Township and Brownstown Central Community School Corporation, be consolidated into one new school corporation with all of the rights, powers, duties, obligations, privileges and functions as authorized by Chapter 123 of the Acts of the General Assembly of the State of Indiana, approved March 7,1947, and any and all laws amendatory and supplemental thereto, and any and all laws of the State of Indiana pertaining thereto, as follows:

- 1. The name of the new consolidated school corporation shall be "Brownstown Central Community School Corporation".
- 2. That said consolidated schools of said consolidated school corporation shall be under the control and management of a Board of Trustees, consisting of seven members who shall be appointed, and for the tenure of office, as follows:
- a. Two (2) members shall be residents of the Town of Brownstown, Jackson County, Indiana, and shall be appointed by the Town Board of the Town of Brownstown.
- b. One (1) member shall be a resident of Brownstown Township, Jackson County, Indiana, outside the corporate limits of the Town of Brownstown and shall be appointed by the Advisory Board of Brownstown, Township.
- c. One (1) member shall be a resident of Driftwood Town-ship, Jackson County, Indiana, and shall be appointed by the Advisory Board of Driftwood Township.
 - d. One (1) member shall be a resident of Grassy Fork

Township, Jackson County, Indiana, and shall be appointed by the Advisory Board of Grassy Fork Township.

- e. Two (2) members shall be residents of a district composed of Owen, Pershing and Salt Creek Township, Jackson County, Indiana, according to the schedule hereinafter set out, and each such member shall be appointed, respectively, by the advisory board of the township of which such member is a resident.
- 3. The schools of the Consolidated School Corporation shall be under the direction of a Superintendent selected by its school board.
- 4. a. Two members of the school board of the consolidated school corporation shall be residents of the Town of Brownstown, Jackson County, Indiana.
- b. One member of the school board of the consolidated school corporation shall be a resident of Brownstown Township, Jackson County, Indiana, outside the corporate limits of the Town of Brownstown.
- c. One member of the school board of the consolidated school corporation shall be a residentitof Driftwood Township, Jackson County, Indiana.
- d. One member of the school board of the consolidated school corporation shall be a resident of Grassy Fork Township, Jackson County, Indiana.
- e. Two members shall be residents of a district composed of Owen, Pershing and Salt Creek Townships, Jackson County, Indiana, with no more than one member being a resident of any one such township and in order, as nearly as possible, to provide continuity of the direction of said school corporation, the residence of the

representatives of said district shall be according to the

following schedule:	!

said alternating schedule to continue in the same manner thereafter. Each member shall be appointed by the advisory board of the township of which such member is a resident.

- f. Each member of the school board of the consolidated school corporation shall be a resident, freeholder and a registered and legal voter of the town, township or district from which he is appointed.
- g. The original term of office of the members of the school board of consolidated school corporation shall be as follows:

Thereafter each person appointed as a member of the school board of the consolidated school corporation shall serve for a term of four years.

As each of the above original terms expires the members of the school board shall be appointed for a term of four years each beginning at the end of the term of the original appointment of the vacancy to which said appointee is appointed by the respective authority, provided any member may succeed himself in office upon proper appointment.

- 5. a. The names of the present school corporations which are to be merged together as a consolidated school corporation are Owen School Township and Brownstown Central Community School Corporation, all of Jackson County, Indiana.
- b. Said consolidated school corporation shall come into existence as soon as the consolidation shall be approved by the office of the State Superintendent of Public Instruction.
- 6. That said consolidated school corporation, and the officers thereof shall have all the right, powers, functions, duties and privileges granted, authorized or conferred under and by virtue of Chapter 123 of the Acts of the General Assembly of the State of Indiana, approved March 7,1947, and all acts and laws amendatory thereof and/or supplemental thereto, and any and all laws of the State of Indiana, thereto appertaining.

Upon motion duly made and seconded, it was voted and determined to give notice of intention to consolidate the elementary and high schools of Owen School Township and Brownstown Central Community School Corporation, all of Jackson County, Indiana, as by law provided, and to proceed with the consolidation of the said Owen Township and the Brownstown Central Community School Corporation.

And there being no further business to come before the meeting, said meeting was adjourned.

RESOLUTION INITIATING A CHANGE IN THE PLAN OF ORGANIZATION FOR THE BOARD OF EDUCATION OF BROWNSTOWN CENTRAL COMMUNITY SCHOOL CORPORATION, JACKSON COUNTY, INDIANA

WHEREAS, the Board of Education of Brownstown Central Community School

Corporation desires to constitute itself in a manner that provides more equitable representation

considering the current demographics within the Brownstown Central Community School

Corporation boundaries.

NOW THEREFORE BE IT RESOLVED BY THE, Board of Education ("Board") of Brownstown Central Community School Corporation, Jackson County, Indiana ("School Corporation") that the manner in which the Board is constituted shall be changed under I.C. § 20-23-8-10 so that it is constituted in accordance with the following plan ("Plan"):

- Name. The governing body of the School Corporation shall be called the Board of Education as it presently is.
- 2. Members to be Appointed Number, Term and Qualification. The Board shall consist of seven (7) members who shall be appointed as described in paragraph 3 below. Each member shall be a resident and registered and legal voter of the town, township, or district from which he or she is appointed. Each member shall serve for a term of four (4) years and may succeed himself or herself in office.

- Residential Districts. The Board shall consist of seven (7) members appointed on a
 rotating basis from eight (8) residential districts described below. The rotation is
 described below in paragraph 4.
 - a. One (1) member shall be a resident of the Town of Brownstown, Jackson County, Indiana, and shall be appointed by the Town Board of the Town of Brownstown. (herein "Brownstown A").
 - b. One (1) member shall be a resident of the Town of Brownstown, Jackson County, Indiana, and shall be appointed by the Town Board of the Town of Brownstown. (herein "Brownstown B").
 - c. One (1) member shall be a resident of Brownstown Township, Jackson County, Indiana, outside the corporate limits of the Town of Brownstown and shall be appointed by the Advisory Board of Brownstown Township.
 - d. One (1) member shall be a resident of Driftwood Township, Jackson County,
 Indiana, and shall be appointed by the Advisory Board of Driftwood Township.
 - e. One (1) member shall be a resident of Grassy Fork Township, Jackson County,

 Indiana, and shall be appointed by the Advisory Board of Grassy Fork Township.
 - f. One (1) member shall be a resident of Owen Township, Jackson County, Indiana, and shall be appointed by the Advisory Board of Owen Township.
 - g. One (1) member shall be a resident of Salt Creek Township, Jackson County,
 Indiana, and shall be appointed by the Advisory Board of Salt Creek Township.
 - h. One (1) member shall be a resident of Pershing Township, Jackson County, Indiana, and shall be appointed by the Advisory Board of Pershing Township.

4. Rotation. Bach residential district will be actively represented on the Board for a period of sixteen (16) years after which the residential district will rotate "off" active representation for a period of two or three years. To account for the staggering of Board terms, every fourth rotation "off" active representation, will be three years instead of two.

For example, at the time this Plan is effective, Grassy Fork Township will begin a three-year "off" rotation period from July 1, 2023 until July 1, 2026. Grassy Fork Township will not have another three-year "off" rotation period until July 1, 2096 after it has three, two-year "off" rotation periods (July 1, 2042-July 1, 2044; July 1, 2060-July 1, 2062; and July 1, 2078-July , 2080). For reference purposes, at the time this Plan is effective, the following seven (7) residential districts will be actively represented with the first rotation "off" active representation slated for the date listed:

Members of the Board of School Trustees of the Brownstown Central Community School Corporation met in Regular Session at the Brownstown Central Administration Office at 7:30 p.m., on Tuesday, August 9, 2022.

An executive session was held at 6:30 p.m. to discuss personnel as listed in I.C. 5-14-1.5-6.1 (b) (5) (6). No subject matters were discussed in Executive Session other than the subject matters specified in the public notice.

Scott Shade called the meeting to order. David Martin led the Pledge of Allegiance, and a moment of silence was observed.

Roll call was taken by Scott Shade. Members Brian Wheeler, Clayton Beard, Jerry Hounshel, Paul Borden, and David Martin were present, as were Superintendent Tim Taylor, Assistant Superintendent Jade Peters, Melissa Hogan, Paula Workman, 6 patrons, and 1 member of the media.
