After adopting the resolution, Goshen submitted the attached materials for the Indiana State Board of Education’s (“Board”) review and consideration, in accordance with the requirements set forth in IC 20-23-8-15.

Indiana Department of Education (“Department”) staff reviewed the attached material and determined that Goshen’s plan and the manner in which it was initiated satisfy the requirements set forth in IC 20-23-8. As such, Goshen’s new governing body plan is recommended for approval.



CONSTITUTION
OF
THE BOARD OF SCHOOL TRUSTEES
OF
GOSHEN COMMUNITY SCHOOLS,
ELKHART COUNTY, INDIANA

The following plan shall determine the manner in which the Board of School Trustees of Goshen Community Schools shall be constituted:

I. NUMBER OF MEMBERS

A. The number of members of the Board of School Trustees, as the Governing Body of Goshen Community Schools, shall be seven (7), elected on a nonpartisan basis.

B. Three (3) of the members shall be at-large members, elected by all the voters of the school corporation, and four (4) of the members shall be election district members, each residing in an election district from which he or she is elected by voters residing in that same election district. The four (4) election districts of Goshen Community Schools shall be designated as Districts 1, 2, 3 and 4.

District 1 shall consist of Elkhart Township precincts numbered 1, 2, 6, 7, 10 and 11 as the same have been established prior to the 2022 general election in accord with Ind. Code § 3-11-1.5-38 and Ordinance Number 2011-372 of The Board of Commissioners of Elkhart County, Indiana.

District 2 shall consist of Elkhart Township precincts numbered 3, 4, 8 and 13 as the same have been so established.

District 3 shall consist of Elkhart Township precincts numbered 12, 14, 15, 19, 20 and 21 as the same have been so established.

District 4 shall consist of Elkhart Township precincts numbered 5, 9, 16, 17 and 18 as the same have been so established.

II. CANDIDATES FOR ELECTORAL DISTRICT POSITIONS ON SCHOOL BOARD;
ELIGIBLE VOTERS

Whenever a candidate runs for one of the election district positions on the school board, the following applies:

A. An individual who runs for one of the election district positions on the school board must reside within that election district.

B. Upon filing an intention to run for a position on the school board, the candidate must specify that the candidate is running for an election district position.

C. Only eligible voters residing in the candidate's election district may vote for the candidate.

D. The candidate who receives the greatest number of votes in the candidate's election district will win the election in that district.

III. CANDIDATES FOR AT-LARGE POSITIONS; ELIGIBLE VOTERS

Whenever a candidate runs for one of the at-large positions on the school board, the following applies:

A. An individual who runs for one of the at-large positions on the school board must reside within the boundaries of the school corporation.

B. Upon filing an intention to run for a position on the school board, the candidate must specify that the candidate is running for an at-large position.

C. Eligible voters from all districts may vote for the candidate.

D. The candidates who receive the greatest number of votes win the available at-large positions.

IV. ELECTION PROCEDURES AND TERMS

A. Two (2) at-large members of the school board shall be elected at the general elections held in November, 2022, and in November of every fourth year thereafter.

B. One (1) at-large member of the school board shall be elected at the general elections held in November, 2024, and in November of every fourth year thereafter.

C. The District 1 and District 3 electoral district members of the school board shall be elected at the general elections held in November, 2022, and in November of every fourth year thereafter.

D. The District 2 and District 4 electoral district members of the school board shall be elected at the general elections held in November, 2024, and in November of every fourth year thereafter.

E. The terms of members of the school board shall run from January 1 in the year following election to December 31 of the fourth year thereafter.

F. School board elections shall be held at each general election and shall be conducted in accordance with the requirements of Indiana general election law and school board election law; however, in the event of a conflict, the school board member election law shall prevail.

V. BOARD MEMBERS

A. Vacancies on the Board shall be filled temporarily by the Board. A member chosen to fill a vacancy shall hold office for the remainder of the unexpired term. A board member chosen by the Board to fill an election district vacancy shall reside in the District of the school corporation for which he or she is chosen to represent. A board member chosen to fill an at-large vacancy may reside anywhere in the school corporation. If there is a tie vote, or the Board fails to fill the vacancy in thirty (30) days, then the judge of the Elkhart Circuit Court shall fill the vacancy for the unexpired term.

B. Board members shall have resided in the school corporation for at least one (1) year prior to taking office. Board members must be at least twenty-one (21) years of age at the time of taking office. Pursuant to Ind. Code § 20-26-4-11, an individual who is employed as a teacher, as defined in Ind. Code § 20-18-2-22, or as a noncertificated employee, as defined in Ind. Code § 20-29-2-11, of the school corporation may not be a member of the governing body of the school corporation.

C. Board members shall be compensated in an amount determined by the Board but not in an amount exceeding that set by the Indiana General Assembly at Ind. Code § 20-26-4-7.

VI. EFFECTIVE DATE

This plan shall be effective on January 10, 2022.

The Regular Meeting of the Board of School Trustees of Goshen Community Schools was held on Monday, January 24, 2022, 6:00 p.m. at Goshen Community Schools Administration Center, 613 E. Purl St., Goshen, IN. Board President Bradd Weddell presided, and Mrs. Teri McCrindle recorded the minutes. Action Items:

Action: 4.1 Redistricting and Resolution 785 (Weddell)

Mr. Weddell reminded everyone the importance of redistricting the four elective districts for board members. As the population in Elkhart Township has changed, it is required to have a better balance to meet the statute governed by the state of Indiana. After further discussion and looking over all three options, he believed that Option 1 was going to be the best choice. Mr. Kauffman motioned to go with Option 1 as Mr. Nafziger second the motion. Mr. Nafziger reiterated that it was a difficult task finding many options, he tried and finds the best choice is Option 1 as well. Mr. Kauffman thanked Mr. Weddell for all his work on coming to these conclusions. Approval of using Option 1 and approving Resolution 785 passed with a vote of 6/0.


