FBI National Criminal History Background Checks must be submitted with all new license applications.

Indiana Code IC 9-32-16-11(d)

An FBI National Criminal History Background Check must also be submitted for any new individual being added to an existing dealer license.

OPTION 2: Call Center Scheduling (Available Monday through Friday, 7AM – 6PM)

1. Call 866-226-2952 to schedule your appointment.
2. Operators will collect required information and schedule the fingerprinting appointment.
3. Be sure to have the complete information for the applicant available when calling, as the Operator will ask for the Agency Name, Applicant Type, and the Applicant's full name, address, methods of contact, and complete personal demographic information.
