RE: **Revised** Amendment to Vote Center Plan

Dear Co-Directors:

Pursuant to I.C. 3-11-18.1-4, please accept the following Amendment entitled “**Revised Amendment 2016-3**” to our current Vote Center Plan:

On August 3, 2016 the Miami County Election Board met and established several changes for the November 8, 2016 General Election. Each change set out below was discussed and a unanimous vote of three ayes was obtained.

Whereas, the Miami County Election Board so APPROVES the Miami County Plan Amendment for vote centers in Miami County, Indiana.

BE IT THEREFORE ORDERED BY THE MIAMI COUNTY ELECTION BOARD;

Miami County has switched from using ES&S E-Poll Books and their software programs to using KnowInk iPad Air 16 GB WiFi e-poll books and their software.

The Miami County Fairgrounds was added as a vote center for the General Election. This added vote center will result in having nine vote centers open on Election Day.

The office of the Circuit Court Clerk will begin absentee voting on October 12, 2016 from 8:00 A.M. till 4:00 P.M. each weekday through November 4, 2016. The Absentee Board will end the early in person voting at 12:00 P.M. on November 7, 2016. (See Resolution 2016 – 4)

Of the nine vote centers shown below, seven will have two additional clerks added. (See Resolution No. 2016-3)


