**BARTHOLOMEW COUNTY ELECTION BOARD**

**ORDER ADOPTING VOTE CENTER PLAN AMENDMENT ON MAY 14, 2020**

**WHEREAS**, the Bartholomew County Vote Center Plan was duly adopted on May 14, 2020;

**WHEREAS**, Indiana Code 3-11-18.1-15 authorizes Bartholomew County to amend a plan adopted with a county election board's order under 3-11-18.13 by unanimous vote of the entire membership of the board approving the plan amendment.

**WHEREAS**, the Bartholomew County Election Board has determined that the Office of the Circuit Court Clerk and vote center locations should be changed due COVID-19 and poll worker shortages for both political parties.

**WHEREAS**, the Bartholomew County Election Board should approve the Bartholomew County plan amendment for vote centers in Bartholomew County, Indiana.

**BE IT THEREFORE ORDERED BY THE BARTHOLOMEW COUNTY ELECTION BOARD:**

Pursuant to IC 3-11-10-26 The vote center and Office of the Circuit Court Clerk location shall be as follows:

1. Donner Center, 739 22<sup>nd</sup> Street, Columbus, IN 47201. Tuesday, May 26<sup>th</sup> – Saturday, May 30<sup>th</sup>, 8:00 a.m. - 5:00 p.m., and Monday June 1<sup>st</sup> prior to Election Day from 8:00 a.m. – 12:00 p.m.

The following are vote center locations to be open on Election Day from 6:00 a.m. – 6:00 p.m.:

1. Flintwood Wesleyan Church, 5300 E. 25<sup>th</sup> St., Columbus, IN 47203
2. St. John's Masonic Lodge, 4131 Rocky Ford Rd., Columbus, IN 47203
3. Donner Center, 739 22<sup>nd</sup> St., Columbus, IN 47201
4. Terrace Lake Church, 4260 W. 200 S., Columbus, IN 47201
5. German Township Fire Station, 9428 Main St., Taylorsville, IN 47280
6. Hope Moravian Church, 202 Main St., Hope, IN 47246
7. Ogilville United Methodist Church, 11910 S.E. St. Rd. 58, Columbus, IN 47201
8. Elizabethtown Fire Station, 10203 E. Legal Tender Rd., Elizabethtown, IN 47232


The Election Board of Bartholomew County hereby adopts this Order to approve the Vote Center Plan Amendments.


