

**TIPPECANOE COUNTY BOARD OF ELECTIONS AND REGISTRATION
ORDER ADOPTING VOTE CENTER PLAN AMENDMENT**

WHEREAS, the Tippecanoe County Vote Center Plan was adopted on July 31, 2006;

WHEREAS, Indiana Cod 3-11-18.1-15 authorizes Tippecanoe County to amend a plan adopted with a county election board's order under IC 3-11-18.13 by unanimous vote of the entire membership of the board approving the plan amendment;

WHEREAS, the Tippecanoe County Board of Elections and Registration has determined that the satellite vote centers and vote center locations on election day should be changed for the 2019 Municipal election;

WHEREAS, Tippecanoe County Board of Elections and Registration should approve the County plan amendment for vote center in Tippecanoe County, Indiana;

**BE IT THEREFORE RESOLVED BY THE TIPPECANOE COUNTY BOARD OF ELECTIONS
AND REGISTRATION:**

1. The Tippecanoe County Vote Center Plan is hereby amended to allow the use of fifteen (15) vote center sites: Battle Ground Fire Station, Dayton United Methodist Church, Eagles Lodge, Evangelical Covenant Church, Jenks Rest Senior Center, Lafayette City Hall, Lafayette Fire Station #5, St. Lawrence Catholic Church, The Outpost Catering, Greater Lafayette Career Academy, West Lafayette Intermediate School (WLIS), Federated Church, City of West Lafayette, Purdue University Memorial Union and West Lafayette Fire Station #3 for the 2019 Municipal Elections.


2. The Tippecanoe County Vote Center Plan is hereby amended to use the following fifteen (15) satellite vote centers for absentee voting: Tippecanoe County Board of Elections, University Place, Purdue University Memorial Union, Cumberland Pointe, Westminster Village, Friendship House, Five Star Residences of Lafayette (Rosewalk Commons), Krach Leadership Center, Lafayette Jefferson High School, West Lafayette Highschool, Greenbush Payless, Beck Lane Payless, Maple Point Payless, West Lafayette Payless, The Springs at Lafayette for the Municipal Election of 2019.

A copy of this resolution amending the Tippecanoe County Vote Center Plan shall be filed with the Indiana Election Division.

The Board of Elections and Registration of Tippecanoe County hereby approves and adopts the Vote Center plan Amendment.

Further, this resolution shall take effect immediately and may only be rescinded by the unanimous vote of the entire membership of the Tippecanoe County Board of Elections and Registration Board.
