Whereas, the Carroll County Vote Center Plan was duly adopted on February 28, 2014; and,

Whereas, the Indiana Code 3-11-18.1-15 authorizes Carroll County to amend a plan adopted with a county election board's order under I.C. 3-11-18.1-3 by unanimous vote of the entire membership of the board approving the plan amendment; and,

Whereas, the Carroll County Election Board has determined that the early voting locations will be amended from the original plan, as listed below.

Whereas, the Carroll County Election Board so approves the Carroll County plan amendment for vote centers in Carroll County, Indiana.

Further, the layout of the polls will stay the same. All vote center locations will remain the same and will be as follows:

BE IT THEREFORE ORDERED BY THE CARROLL COUNTY ELECTION BOARD;

**Satellite Stations**

One (1) Vote Center will be open the two (2) Saturdays prior to the election per I.C. 3-11-18.1-4(17), not including the Courthouse (Clerk's Office), which is required by IC 3-11-10-26, to be open the two (2) Saturdays that precede the Election. Two (2) of the Satellite Locations will be open one (1) of the two (2) Saturdays prior to the election. All of the locations will be open from 8 am-2 pm, except for the Courthouse location which is required by statute to be open at least 7 hours the 2 Saturdays preceding the election.

The following satellite locations will be open the first Saturday of Early Voting.


Further, this resolution shall take effect immediately and may only be rescinded by unanimous vote of the entire membership of the Carroll County Election Board.




