CLINTON COUNTY ELECTION BOARD
ORDER ADOPTING VOTE CENTER PLAN ADMENDMENT

WHEREAS, the Clinton County Vote Center Plan was adopted on February 26, 2015;

WHEREAS, Indiana Code 3-11-18.1-15 authorizes Clinton County to amend a plan adopted with a county election board's order under IC 3-11-18. 1-3 by unanimous vote of the entire membership of the board approving the plan amendment;

WHEREAS; the Clinton County Election Board has determined that a permanent alternate vote center site should be added for future elections beginning with the General Election of 2015. The additional site would be the Commissioner's Room, first floor of the Clinton County Courthouse. The site would be used in the event one of the vote center sites should become disabled;

WHEREAS; there will be adequate equipment available for the alternate site;

WHEREAS; the Clinton County Election Board so approves the Clinton County Vote Center Plan amendment for the addition of a permanent alternative vote center site;

BE IT THEREFORE RESOLVED BY THE CLINTON COUNTY ELECTION BOARD:

1. The Clinton County Vote Center Plan is hereby amended to add a permanent alternate vote center site in the County Commissioner's Office in the Clinton County Courthouse.
2. A copy of this resolution amending the Clinton County Vote Center Plan shall be filed with the Indiana Election Division.

The Election Board of Clinton County hereby adopts this Order to approve the Permanent Alternate Vote Center Site Amendment.


Further, this resolution shall take effect immediately and may only be rescinded by the unanimous vote of the entire membership of the Clinton County Election Board.


