A MESSAGE FROM THE CLERK

Citizens of Grant County

Of the 92 Indiana counties, over 40 have changed the process in which they vote. And several, like Grant, are in the process of exploring the idea of Vote Centers.

December of 2019, both major party chairs, Rep. Darren Reese & Dem. Terry Stodghill, came to me asking that we look into the Vote Center concept. I had been hearing a lot about them in e-mails back and forth among the Indiana Clerks and when attending Clerk Conferences. Party members, as well as Clerks before me, have been entertaining the idea as well.

In January of 2020 Darren, Terry, my Election Deputy, Nancy Bryant & myself formed an "Election Advisory Committee". It consisted of Terry Stodghill and 4 Democrat Representatives, Darren Reese and 5 Republican Representatives. Together we worked hard reading everything we could find on Indiana Vote Centers. We learned from the experiences of other counties and of course, the Indiana Election Division. We also recruited some special consultants to help us understand and work out some of the details.

This Volunteer ~ Bipartisan committee worked so beautifully together, pooling our resources, and individual expertise to bring this plan to life.

Vote Centers will allow the Grant County voter to cast their vote at any of the eleven (11) vote center locations. No more trying to rush across town to "your" precinct to vote, only to get their too late, or be told, I'm sorry, but this is not your voting location, and then not having time to get to your proper polling place.

Using the Electronic Poll Books, the check in procedure will also go much more smoothly. With the swipe of your Indiana ID or Indiana Driver's License, much like you would a credit card, "your" information comes up. This gives your Name, Address, Precinct, School Board etc. then, you are on to the voting machine. It's just that simple!

We will be able to have more machines at each center, which will hopefully shortening the voters wait time. And having fewer locations, fewer poll workers, providing fewer meals, will also afford Grant County a financial savings.

We want to thank you for your feedback, some sharing thoughts of concern and suggestions, and some have been "Way to go". And all have been carefully read and considered.

As we have gone through, and are still in the midst of this season of COVID, it has become very evident to us that this is a perfect time to address the Vote Center idea. As we were trying to staff the 32 polling locations for the 2020 Primary Election and yet we were getting calls late Monday from poll workers saying that they would not be able to make it the following morning. We had some locations that were working without a complete staff. But they dug in and did a great job, but with added work, pressure and stress.

We are excited to present this plan to the citizens of Grant County. Vote Centers will be so much more convenient for both the Voter as well as the Poll Worker. And we feel very strongly that once we go through and election season, we will all wonder why we waited so long.

I count it a true pleasure to serve you as the Clerk of Grant County. This is my home too, born and raised, and I am proud to be working alongside you.

VOTE CENTER PLAN REQUIREMENTS AS DEFINED IN IC 3-11-18.1-4

1. The total number of vote centers to be established and the location(s)
2. The effective date of the order establishing Hendricks County as a vote center county
3. The following information according to the computerized list (as defined in IC 3-7-26.3-2) as of the date of the order:
 - (A) The total number of voters within the county
 - (B) The number of active voters within the county
 - (C) The number of inactive voters within the county
4. For each vote center designated under subdivision (2), the number and title of the precinct election officers who will be appointed to serve at the vote center.
5. A description of any hardware, firmware, or software used:
 - (A) to create an electronic poll list for each precinct whose polls are to be located at a vote center; or
 - (B) to establish a secure electronic connection between the county election board and the precinct election officials administering a vote center
6. A description of the equipment and procedures to be used to ensure that information concerning a voter entered into any electronic poll list used by precinct election officers at a vote center is immediately accessible to:
 - (A) the county election board; and
 - (B) the electronic poll lists used by precinct election officers at all other vote centers in the county
7. The number of electronic poll lists to be provided for the precinct
8. The security and contingency plans to be implemented by the county to do all of the following:
 - (A) Prevent a disruption of the vote center process
 - (B) Ensure that the election is properly conducted if a disruption occurs
 - (C) Prevent access to an electronic poll list without the coordinated action of two (2) precinct election officers who are not members of the same political party
9. A sketch depicting the planned layout of the vote center, indicating the location of:
 - (A) equipment; and
 - (B) precinct election officers within the vote center
10. The total number and locations of satellite offices to be established under IC 3-11-10-26.3 at vote center locations designated under subdivision (2) to allow voters to cast absentee ballots in accordance with IC 3-11. However, a plan must provide for at least one (1) vote center to be established as a satellite office under IC 3-11-10-26.3 on the two (2) Saturdays immediately preceding an election day.
11. That the county election board shall adopt a resolution under IC 3-11.5-5-1 or IC 3-11.5-6-1 to make the central counting of absentee ballots applicable to the county (if the board has not already done so).
12. Make the central counting of absentee ballots applicable to the county (if the board has not already done so).

County considering election changes

Grant County Clerk Pam Harris has convened a bi-partisan commission to explore the transition in Grant County from precinct-based elections to vote centers.

Vote centers provide added flexibility and efficiency to the voting process. In addition, early voting options are expanded as part of vote centers. Nearly half of Indiana's counties used vote centers in the 2019 election cycle. In the precinct-based model used currently in Grant County, a voter is assigned to one precinct polling site and on Election Day can only cast their ballot there. Under the vote center model, any registered and eligible voter can cast their ballot at any vote center in the county.

The Indiana Secretary of State's Election Division has recommended forming a commission to assist with the process of exploring a move to vote centers. In line with that recommendation, Harris has asked the election advisory commission to help investigate and evaluate the options for vote centers in future elections, possibly as soon as Fall 2020. The commission is helping to review logistics, policies, technology, and other aspects of a potential transition to vote centers.

Vote centers can provide a cost savings to the county for election administration, and may also improve voting times and vote counting. Studies show that in counties where vote centers have been implemented, it has not hurt voter turnout. In fact, in some cases voter turnout has increased due in part to increased availability of early voting. The election advisory commission is co-chaired by Darren Reese, Grant County Republican Party chairperson, and Terry Stodghill, Grant County Democratic Party chairperson. The commission also includes Mark Bardsley, Grant County Commissioner; Deborah Cain, Marion City Council President; Patricia Gibson, Vice Chair of the Grant County Democratic Party; Lori Goss-Reaves, former Oak Hill School Board member; Jonathan Perez, Grant County Council member; Mike Roorbach, Grant County Council member; Paul Thompson Jr., former Marion City Council member; Joselyn Whitticker, former Marion City Council member; and Torri Williams, Secretary of the Grant County Democratic Party. Steve Shamo from MicroVote, supplier of the voting machines the county currently uses, is providing his expertise to the

commission as well. Grant County Election Board Attorney Marty Harker is serving as an adviser to the commission.

Anticipated next steps include:

- Communication with the Grant County Council and the Grant County Commissioners to convey the findings of the commission and make any needed requests regarding budget allocation.
- A review of potential voting center sites, taking into consideration population, traffic, parking, and voter access needs.
- A public outreach program to help inform the voters of Grant County when and where they will be able to cast their ballot.

More information will be provided as the exploration process continues.



INTRODUCTION

What is a Vote Center?

A Vote Center is a polling location where any eligible voter in the county may vote. The Vote Center model is intended to give voters more flexibility on Election Day as they will no longer be required to go to a specific polling location.

Vote Centers are connected through secure internet connections to servers that maintain Electronic Poll Books for all registered county voters. As voters cast their ballots, the electronic poll books are instantaneously updated so that poll workers know if a prospective voter has already cast a ballot at another location.

Findings on Vote Centers

A study conducted by Ball State Universities Bowen Center found that Vote Centers:

- Improve voter convenience by permitting voters to vote at any of the multiple locations thus potentially reducing wait time
- Reduce the number of poll workers needed, elimination of the printing of paper poll books, as well as the wasteful pre-printing of precinct specific ballots thus giving a savings to the county
- Increases flexibility of the staffing, locations, and number of machines thus impacting the cost per voter

PROCESS OVERVIEW

The Grant County Election Board, along with the Election Advisory Committee, has developed this plan after much research, thought and discussion. We have had public meetings and have tried to be open to their concerns and suggestions. During our deliberations, the CEB & EAC have followed these guiding principles:

1. Voter Convenience
2. The reduction of cost incurred during the election process
3. To insure the security and integrity of the election process

Satellite Location

Grant County will utilize eleven (11) vote centers placed throughout the county on Election Day. There will also be one (1) satellite vote center for early voting the two Saturday's prior to Election Day. (Westview Wesleyan Church - 1300 W. 6th St., Jonesboro, 46938 - Sat. Oct. 24th & Sat. Oct. 31st - 8:00 ~ 3:00)

This is a strategically placed location to most effectively serve all voters. As well as the Court House which will also be open for early voting.

Voter Technology

E-poll books are the cornerstone of how vote centers function.

E-poll books allow a voter to cast their ballot at any vote center they choose, while making sure the integrity of the election process is maintained by not allowing a voter to cast their ballot at more than one location.

All e-poll books are connected to a central server which allows for real-time updates to each of the other individual vote centers. The connection to the server will be a VPN which will be setup by County Information Technology personnel.

E-poll books have the ability to scan the barcode that is on the back of your Indiana ID/Driver's License, increasing the ability to check-in voters and move lines along in a much faster and more efficient manner. Voters will sign their name on the e-poll book digitally, once this is done the e-poll book will create the voter access card. This will insure that each voter is given the correct ballot for the precinct in which they are registered.

Voter Education Efforts

Public forums will be held with a thirty day window following, to allow the public an opportunity to provide feedback on the Vote Center Plan. Individuals will be able to email any comments to G.C. Information will also be added to the Clerk's webpage, as well as possible other social media outlets. The CEB & EAC will also rely upon local media and the Democratic and Republican parties for additional support in informing voters.

ELECTION DAY VOTE CENTER LOCATIONS

Requirements

The eleven (11) vote center locations were carefully chosen by the CEB & EAC to best serve the voters of Grant County. The following criteria were also taken into consideration:

- ADA compliance (American with Disabilities Act)
- Adequate parking
- Wifi compatibility with the e-poll books
- Space large enough for the number of voters expected at the location
- Location well known to the voter
- Location willing to be a long-term vote center
- Location to public transportation routes where available





Voters with Disabilities

The Help America Vote Act of 2002 (HAVA) requires at least one accessible voting machine be placed in each polling place in addition to making the facility physically accessible. The Secretary of State and Indiana Election Division have been working with county election administrators to make these changes and upgrade polling places as of the 2006 Primary Election. All polling locations in the State of Indiana should be compliant.

Voters that require assistance or are experiencing mobility issues are welcome at the polls on Election Day, where poll workers will assist them throughout the voting process. A voter may designate a relative or friend to assist them at the polling place. If the voter requests assistance but does not designate someone else to help them, two poll workers (one from each political party) will be available to assist. Those assisting a voter must complete the Affidavit of Voter Assistance at the Polls, available at the polling station, before entering the voting booth.

If you are uncomfortable receiving assistance at the polls, you may request an absentee ballot from your local county clerk's office. Further information can be found by clicking the below link 'Information for Voters with Disabilities'.

If you have a complaint about your polling place's accessibility limitations please call the Hoosier Voter Hotline to report the issue. We need your help to identify areas needing assistance so the issue can be resolved.

The toll free number is: 866-IN1-VOTE (866-461-8683). HAVA staff will be on hand to answer the calls from 6:00AM to 7:00PM EDT on Election Day, and 8:00AM to 4:30PM on normal business days.



Help make the election better

A big change is coming, and you've still got a chance to make your voice heard.

The election board has announced a preliminary list of 11 vote center locations, and Grant County Clerk Pam Harris is asking the public for their input before the list is finalized soon.

Going from 32 assigned voting locations to just 11 vote centers, where anyone can cast a ballot, is a big deal. Just like any large system change, there will undoubtedly be issues, but hopefully the election department's proactive approach will help minimize this.

The proposed locations are:

Grant County Family YMCA, 123 Sutter Way, Marion (10 voting machines)

St. Paul Baptist Church, 1204 W. 14th St., Marion (10 voting machines)

Lakeview Wesleyan Church, 5316 S. Western Ave., Marion (10 voting machines)

Calvary Social Brethren Church, 304 N. Miller Ave., Marion (10 voting machines)

Eastview Wesleyan Church, 414 N. 10th St., Gas City (10 voting machines)

Westview Wesleyan Church, 1300 W. Sixth St., Jonesboro (10 voting machines)

Fairmount Baptist Church, 1201 N. Main St., Fairmount (eight voting machines)

Upland Community Church, 439 W. Berry Ave., Upland (eight voting machines)

Liberty Baptist Church, 517 Church St., Sweetser (five voting machines)

Swayzee United Methodist Church, 306 S. Washington St., Swayzee (five voting machines)

United Methodist Church Fellowship Hall, 105 S. Second St., Van Buren (four voting machines)

Overall, the list appears to cover a large swath of the county, and it looks like the committee has done a good job allocating machines to the right places. Marion will have 40 voting machines, or about half of the total allotment. Since almost half of the county's population lives within city limits, there should be enough machines to keep lines from growing too long.

One place for improvement would be to eliminate the vote center at the YMCA and move it to county-owned property nearby in downtown Marion, like the courthouse or county annex.

Since county offices are closed on Election Day, it would be a wiser use of taxpayer dollars compared to paying rent to use the YMCA facility.

We are glad that YMCA Executive Director Steve Wright, who has ties to county and city government, agreed to use his building as a vote center, but unless there are valid concerns about why county buildings can't be used, the county should opt to save money and allocate it elsewhere. Perhaps the savings could be used to hire more absentee ballot judges instead.

The next order of business that needs to be hashed out relates to public transportation to and from the polls since Grant County Republican Party Chair Darren Reese said it is unclear whether city buses will be running on Election Day due to COVID-19.

If the city and county can come up with a decision soon, the election office can give voters advance warning ahead of the absentee ballot application deadline.

Many key voters would be disenfranchised if they thought they could get a ride on the bus to a vote center on Election Day only to find the buses parked all day.

If public transportation cannot be provided, the county must ensure voters who apply for an absentee ballot are approved if they claim to not have reliable transportation to the polls.

Ideally, everyone can get to their voting center safely and efficiently to cast their ballot in November.

Good Morning Karen,

Thank you for your e-mail concerning the Vote Centers.

Let me address the thought of "Security" first.

We are going away from the Paper Poll Book and will be using an "Electronic-Poll Book".

This device uses the Bar Code from the back of your driver's license, or Indiana ID.

It is swiped, the same as a credit card/credit card machine.

"Your" information comes up, identifying You, your address/precinct/school board etc.

The Poll Books are connected, on a secure line, with all other poll books – allowing you to vote at only one location.

I hope this helps to put your mind at ease. It is a very secure system.

Now with the locations, we have tried to take great care in accommodating all of our county voters, and yes, we are open to suggestions.

We have been thinking for some time now, (for the two of the past clerks even) that Vote Centers would be a good choice for Grant County.

And even though this process started before COVID, the COVID experience cemented our, (my) resolve that Vote Centers would be good for the County Budget, going from trying to get the required 160 poll workers, (with Vote Centers we will only need approx.. 70.

We had an extremely hard time getting people willing to work at the 32 polling locations.

In trying to select locations that would be large enough for a greater number of machines, people, (6 feet apart), an area large enough for people to get in out of the weather, and a nice large parking lot.

Chapel Pike Wesleyan Church has been a wonderful location, and has served our county voters for a very long time. But we believe that we are just going to need a larger inside space.

We did contact Sunnycrest Baptist Church, but with the wonderful ministers they offer the community, they have no available space.

We have selected Calvary Social Brethren Church located at the corner of Miller Ave & Spencer Ave (just across the street from the GM Plant) – 304 N Miller Ave.

This is just down the road from Chapel Pike Wesleyan.

And I'm hoping that we will find that it is a good site for one of our Voting Locations.

I want to thank you again Karen for reaching out to us, I hope that this helps to ease your mind. Please, let me know of any concerns that you may have.

Good Morning Barbara,

I am so very sorry for the delay in getting back with you!

I very much agree with your thought about getting out.
The parking lots of so many stores are full, proving your thought.

But the Vote Center concept is really for the convenience of the community.
We have had "Precinct" voting for a very long time. As you know this allows the voter ONE place to cast your vote.
With Vote Centers you have 11 (Eleven) options for voting. Depending on how your day is going, which part of the county you are in when you have time to stop and vote.
You can vote at any of the locations throughout the county. If you live in Gas City but are at the Farmers Market in Upland, you can vote in Upland.
And in "real time" the other locations are notified on a SECURE line, that you have voted (NOT HOW YOU VOTED - ONLY THAT YOU DID VOTE!!!) So there is no going to another location and voting a second time.

With Precinct Voting there are a few machines, and there are sometimes longer lines.
Some people go into the voting booth knowing exactly who they are wanting to vote for and are able to move away from the booth rather quickly.
Whereas some people take a bit longer as they study the ballot.
If we have more machines at each voting location, then this will help the lines move along a little more smoothly, with less time waiting in line.

We are using the same machines that everyone is familiar with.
The main change is in the "Check In" process. You have always needed to have a Indiana ID when you come to the polls to vote.
But now, instead of the Clerk looking through a paper poll book, they have an Electronic Poll Book.
You swipe your ID, like you would a Credit Card, and your information comes up.
Your Precinct, Your address, your School Board etc.

In my case, there are a couple of Pam Harris's, with the E-Poll Books, MY info come up - with no confusion.

I hope that this helps to answer a few of your concerns and questions.
And Thank you for voicing them to us.

I have a few suggestions/questions about the voting centers

- 1. Hanfield United Methodist Church would be more convenient for more people than the Fellowship Hall in Van Buren. People that work at Dollar General, Dunhams, etc. could come straight down State Road 18 to vote. There are only four voting machines planned in Van Buren. Couldn't you put a few more voting machines at Hanfield, which would be a larger space and maybe even have more parking?**
- 2. What are you doing for the elderly and others who do not have access to city buses? There are voters outside of the city limits who rely on others to take them voting. This isn't convenient for them either.**

The proposed voting centers should have been tabled until next year. This is a major election, with the health concerns related to COVID-19 still lingering (and many working from home) and you decided to change it now.

1 - You are right, Handfield United Methodist Church is a beautiful facility, and has worked very well for us as a polling location for many years. We were trying to reach to the four corners of the county to be certain the rural communities were also taken

care of. And also have several in the areas of the larger populations. Keeping in mind, that we can vote at any of them, so if you are on the way to the bank or the store you can stop at any vote center.

We are hoping that our citizens will see the convenience in not being locked down to one location, and not be able to make it away from work in time to get to your one and only voting option.

2 - We care very deeply for the elderly and disabled citizens of Grant County, and we are providing for them with Absentee Voting, and also by providing the Traveling Board, a bipartisan team of two, who will come to your home and allow you to vote.

You just need to contact my Voter Registration Deputy, Sharyn Sherron at ssherron@grantcounty.net or call at 765-664-9880.

3 - We do not have an election next year. And the 2020 Primary proved to me that this is a perfect time to move to Vote Centers.

We had poll workers calling the office as late as 7:30 Monday night saying they would not be at their post at 5:00 the next morning. We were replacing poll worker left and right, many joined our team at the last minute getting absolutely No Poll Worker

Training. I had some polling locations that ran the election without a complete staff. This put so much extra stress, pressure and work on an already stressful election, with it being a Presidential, and then top it off with COVID, well it was beyond the pale.

We are using the same machines, and pretty much the same process.

You will still need your Driver's License at the Clerks table, it will be scanned much like when you are using a credit card machine. You have to present you license or Indiana ID already, so there is no change there.

This saves time and potential mistakes for the check in process.

On a secure line, the other locations are made aware that you have voted - BUT NOT HOW YOU VOTED - And you can vote at any of the 11 (eleven) locations.

I hope this information helps you understand our thought process.

I will share your thoughts and concerns with the rest of the committee.

MASTER Software License and Services AGREEMENT

This Master Agreement (the "**Agreement**") is entered into as of the 19th of August, 2020 between Grant County TN Clerk ("**Customer**"), and KNOWiNK, LLC ("**KNOWiNK**").

WHEREAS, Customer wishes to engage KNOWiNK to provide, install and set-up an electronic poll books ("**EPBs**") system known as the KNOWiNK Poll Pad System (the "**System**"), to license certain software from KNOWiNK, and to train Customer and/or its designated personnel in the use of the System;

WHEREAS, KNOWiNK is willing to perform such services and the other services described in this Agreement (the "**Services**") for, and license such software (the "**Software**") to, Customer;

NOW THEREFORE, in consideration of the mutual agreements set forth in this Agreement, Customer and KNOWiNK agree as follows:

1. PROVISION OF THE SYSTEM:

KNOWiNK shall deliver and implement the System and the Software as described herein and in the attached quote (Exhibit B, "**Quote**").

2. LICENSE AND SUPPORT; RESTRICTIONS:

- 2.1. Subject to the terms and conditions of this Agreement and for so long as Customer has a current license and support subscription in effect, KNOWiNK grants to Customer a personal, nonexclusive, nontransferable, and limited license to use the Software (which includes firmware, meaning the Software embedded in any System device that allows execution of the software functions) and the applicable documentation. With this right to use, KNOWiNK will provide Customer, and Customer will be permitted to use, only the run-time executable code and associated support files of the Software for Customer's internal requirements as part of the System. The Software may be used only at the Licensed Location specified as the jurisdiction on Exhibit A and only on the hardware or other computer systems authorized by KNOWiNK in writing. Customer's use of the Software will be limited to the number of licenses specified in the applicable Quote. Only Customer and its authorized employees, agents or contractors may use or access the Software. To the extent Software contains embedded third party software, third party licenses may apply.
- 2.2. Subject to the terms and conditions of this Agreement, KNOWiNK shall provide: (a) annual software maintenance and support ("**Software Support Services**") and (b) the implementation, training, support and/or other services ("**Professional Services**") set forth in this Agreement and the applicable Quote provided in Exhibit B. Software Support Services will consist of periodic updates to the Software, issued at KNOWiNK's discretion. KNOWiNK does not warrant that all errors or defects will be corrected.
- 2.3. Customer may not modify or copy the System or Software. Customer shall not, under any circumstances, cause or permit the adaptation, conversion, reverse engineering, disassembly, or de-compilation of any Software or attempt to derive the source code thereof. Customer shall not use any Software for application development, modification, or customization purposes, except through KNOWiNK.
- 2.4. The use, duplication, reproduction, release, modification, disclosure, or transfer of the System

or Software is restricted in accordance with the terms and conditions contained in this Agreement. All other use is prohibited. Further, the System and Software were developed at KNOWiNK's private expense and are commercial in nature. By using or receiving the System or Software, the user agrees to the terms and conditions contained in this Agreement including the terms and conditions contained in this paragraph.

25. Customer acknowledges and agrees that the design of the System and the Software, and any and all related patents, copyrights, trademarks, service marks, trade names, documents, logos, software, microcode, firmware, information, ideas, concepts, know-how, data processing techniques, documentation, diagrams, schematics, equipment architecture, improvements, code, updates, trade secrets and material are the property of KNOWiNK and its licensors. Customer agrees that the sale of the hardware and license of the Software does not, other than as expressly set forth herein, grant to or vest in Customer any right, title, or interest in such proprietary property.
26. Subject to the terms and conditions of this Agreement, KNOWiNK will provide Customer with phone support and will provide all other Services, including implementation, any technical support, Software Support Services, and training.

3. OBLIGATIONS:

31. Hardware is shipped Ex Works (Incoterms 2010) from KNOWiNK's designated shipping point. Title change from KNOWiNK to Customer is upon shipment to Customer. Shipping dates are approximate and are based, to a great extent, on prompt receipt of all necessary ordering information from Customer. Billing will commence once shipment has been made.
32. On Non-Election Days KNOWiNK will physically or remotely answer or respond to a service call request within eight (8) hours. On Election Day, KNOWiNK's help desk will be available for calls one hour prior to polls opening until one hour after polls close. On Election Day all calls will be acknowledged and/or addressed within one hour.
33. Each party agrees to comply with applicable laws, rules and regulations in connection with its performance under this Agreement or use of the System, Software or Services. The System, Software and components thereof may be subject to U.S. and other government export control regulations. Customer shall not export or re-export all or a part of the System or the Software.

4. TERM; TERMINATION:

41. The term of this Agreement ("**Term**") shall initially be three years, unless earlier terminated in accordance with this Section.
42. Either party may terminate this Agreement or any outstanding order if the other party is in material breach of this Agreement and fails to cure such breach within thirty (30) days after written notice of such breach has been given.
43. Sections 2.3-2.5, 4, 8, 9, 10.2, 10.3, 10.5 and 13-15 shall survive any termination or expiration of this Agreement or the applicable order. All other rights and obligations shall be of no further force or effect.

5. PRICING:

51. Prices for hardware shall be specified by KNOWiNK in the relevant quotation or proposal and are subject to change without notice, including prices for backordered hardware; however, prices in Quotes signed by both Parties are not subject to change. Unless otherwise noted, all prices include shipping and packing costs, and insurance.

- 5.2. The "Annual Fee" is the combined, annual fee for licensing (in the case of Software) and support (a "License and Support Subscription"). Pricing for the initial Annual Fee is the amount specified in the Quote and/or Exhibit B. KNOWiNK may increase the Annual Fee for a renewal term with 30-days notice to Customer before the term renews.
- 5.3. Pricing for other Services shall be set forth in the applicable Quote. Additional charges may apply to Services, e.g., travel, communication and other expenses.
- 5.4. All prices are exclusive of applicable taxes. All taxes shall be payable by Customer, unless Customer presents KNOWiNK with a proper certificate of exemption from such tax. If Customer challenges the applicability of any such tax, Customer shall pay the tax and may thereafter seek a refund. In the event KNOWiNK is required to pay any tax at time of sale or thereafter, Customer shall promptly reimburse KNOWiNK therefore.

6. **ORDERS:**

Customer may request a quotation from time to time. The existence of this Agreement does not obligate Customer to request a quotation or purchase any products or Services. KNOWiNK reserves the right to accept or reject any order initiated by Customer in KNOWiNK's discretion. Only signed Quotes will obligate the parties. Each Quote shall be subject to the terms and conditions of this Agreement.

7. **PAYMENT TERMS:**

- 7.1. KNOWiNK will invoice Customer for all hardware, software and services including parts replacements or Customer-requested software modification upon shipment to Customer. Except as otherwise provided in the applicable Quote, such invoices shall be paid in full within thirty (30) days after delivery.
- 7.2. If any dispute exists between the parties concerning any payment or invoice, Customer shall promptly pay the undisputed portion. Such payment will not constitute a waiver by Customer, KNOWiNK of any of their respective legal rights and remedies against each other. Customer has no right of set-off.
- 7.3. Should, at any time during the term of this contract, the State of Indiana require additional Acceptance Testing of Poll Pad units, Service Provider retains the right to invoice Customer an additional fee in the amount of Fifteen Hundred Dollars (\$1,500.00).

8. **CONFIDENTIALITY:**

- 8.1. "Confidential Information" means any confidential or proprietary information of a party, including information related to KNOWiNK's business or the System or Software (and applicable documentation), and the terms and conditions of this Agreement. Confidential Information does not include information that was (a) at the time of disclosure or through no fault of the receiving party, in the public domain, (b) in the possession of the receiving party at the time of disclosure to it without any obligation to restrict use or disclosure, (c) received by a third party who had a lawful right to disclose such information without any obligation to restrict use or disclosure.
- 8.2. Each party will keep in confidence and protect Confidential Information (electronic or hard copy) from disclosure to third parties and restrict its use to performance or use of the Software or System pursuant to this Agreement and other uses expressly permitted under this Agreement. Customer shall take all reasonable steps to ensure that the trade secrets and proprietary data contained in the System and Software and the other Confidential Information are not disclosed, copied, duplicated, misappropriated, or used in any manner not expressly permitted by the terms of this Agreement. Customer acknowledges that unauthorized disclosure of Confidential Information may cause substantial economic loss to KNOWiNK or their suppliers and licensors.

- 8.3. Upon termination or expiration of this Agreement or, if earlier, upon termination of Customer's permitted access to or possession of Confidential Information, Customer shall return to KNOWiNK all copies of the Confidential Information in Customer's possession (including Confidential Information incorporated in software or writings, electronic and hard copies).
- 8.4. Each party will inform its employees and other agents and contractors of their obligations under this Section 8 and shall be fully responsible for any breach thereof by such personnel.

9. **INDEMNIFICATION:**

- 9.1. **Indemnity.** KNOWiNK, at its own expense, will defend Customer against any claim that the System or the Software infringes an issued United States patent, registered United States copyright, or misappropriates trade secrets protected under United States law, and shall indemnify Customer against and pay any costs, damages and reasonable attorneys' fees attributable to such claim that are finally awarded against Customer, provided Customer (a) gives KNOWiNK prompt written notice of such claims; (b) permits KNOWiNK to control the defense and settlement of the claims; and (c) provides all reasonable assistance to KNOWiNK in defending or settling the claims.
- 9.2. **Remedies.** As to the System or Software that is subject to a claim of infringement or misappropriation, KNOWiNK may (a) obtain the right of continued use of the System or Software for Customer or (b) replace or modify the System or Software to avoid the claim. If neither alternative is available on commercially reasonable terms, then, at the request of KNOWiNK, any applicable Software license and its charges will end, Customer will cease using the applicable System component or Software, Customer will return to KNOWiNK all applicable KNOWiNK hardware and components and return or destroy all copies of the applicable Software, and Customer will certify in writing to KNOWiNK that such return or destruction has been completed. Upon return or KNOWiNK's receipt of certification of destruction, KNOWiNK will give Customer a credit for the price paid to KNOWiNK for the returned or destroyed System Component or Software, less a reasonable offset for use and obsolescence.
- 9.3. **Exclusions.** KNOWiNK will not defend or indemnify Customer if any claim of infringement or misappropriation (a) is asserted by an affiliate of Customer; (b) results from Customer's design or alteration of any System component or Software; (c) results from use of any System component or Software in combination with any non-KNOWiNK product, except to the extent, if any, that such use in combination is restricted to the System designed by KNOWiNK; (d) relates to third-party hardware or software alone; or (e) arises from Customer-specified customization work undertaken by KNOWiNK or its designees in response to Customer specifications.
- 9.4. **EXCLUSIVE REMEDIES.** THIS SECTION 9 STATES THE ENTIRE LIABILITY OF KNOWiNK AND CUSTOMER'S SOLE AND EXCLUSIVE REMEDIES FOR INFRINGEMENT AND TRADE SECRET MISAPPROPRIATION.

10. **WARRANTY; LIMITATION OF LIABILITY:**

- 10.1. KNOWiNK warrants all products provided hereunder to be free from defects in material or workmanship under normal use and service for a period of four (4) years from the date of delivery. All repair covered by this warranty must be done by KNOWiNK, or other such warranty repair facilities of KNOWiNK as designated by KNOWiNK unless KNOWiNK specifically directs that this service be performed at another location. Any defect corrected within four (4) years and found to be within this scope of the warranty will be repaired by KNOWiNK and all charges for labor and material, will be borne by KNOWiNK. KNOWiNK warrants that all Professional Services will be performed in a professional and workmanlike manner. THIS CONSTITUTES THE SOLE WARRANTIES MADE BY KNOWiNK, EITHER EXPRESSED OR IMPLIED. THERE ARE NO OTHER WARRANTIES EXPRESSED OR IMPLIED WHICH EXTEND BEYOND THE FACE HEREOF, HEREIN, INCLUDING THE

IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

- 10.2. KNOWiNK MAKES NO REPRESENTATIONS OR WARRANTIES AS TO THIRD PARTY HARDWARE, IF ANY, PROVIDED BY KNOWiNK TO CUSTOMER, ALL OF WHICH IS SOLD, LICENSED, OR SUBLICENSED TO CUSTOMER "AS IS," OTHER THAN AS MAY BE PROVIDED IN ANY PASS-THROUGH WARRANTY. KNOWiNK HAS NO RESPONSIBILITY OR LIABILITY FOR THIRD PARTY HARDWARE, IF ANY, PROVIDED BY DISTRIBUTORS OR OTHER THIRD PARTIES TO CUSTOMER. If KNOWiNK sells, licenses, or sublicenses any Third Party Hardware to Customer, KNOWiNK will pass through to Customer, on a nonexclusive basis and without recourse to KNOWiNK, any third-party manufacturer's warranties covering the equipment or software, but only to the extent, if any, permitted by the third-party manufacturer.
 - 10.3. Customer is solely responsible for any hardware or software purchased from an outside source. KNOWiNK will not be liable for such products.
 - 10.4. Any tampering, misuse or negligence in handling or use of products provided hereunder renders the warranty void. Further, the warranty is void if, at any time, Customer or any third party attempts to make any internal changes to any of the components of the products provided hereunder; if at any time the power supplied to any part of the product exceeds the rated tolerance; if any external device attached by Customer creates conditions exceeding the tolerance of the product; or if any time the serial number plate is removed or defaced. OPERATION OF THE EQUIPMENT THAT RENDERS THIS WARRANTY VOID WILL BE DEFINED TO INCLUDE ALL OF THE POSSIBILITIES DESCRIBED IN THIS PARAGRAPH, TOGETHER WITH ANY PRACTICE WHICH RESULTS IN CONDITIONS EXCEEDING THE DESIGN TOLERANCE OF THE PRODUCT.
 - 10.5. IN NO EVENT SHALL KNOWiNK BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES AND CUSTOMER'S REMEDIES SHALL BE LIMITED TO REPAIR OR REPLACEMENT OF NONCONFORMING SERVICES, UNITS OR PARTS. EACH OF KNOWiNK'S MAXIMUM AGGREGATE LIABILITY HEREUNDER SHALL NOT EXCEED FEES RECEIVED BY SERVICE PROVIDER DURING THE 12 MONTHS PRECEDING THE APPLICABLE CLAIM.
11. **CONFLICTS:**
- KNOWiNK will not pay to Customer or any of Customer's officials or employees having official responsibility for the procurement transaction, or member of his or her immediate family, any financial benefit of more than nominal or minimal value relating to the award of this Agreement.
12. **FORCE MAJEURE:**
- KNOWiNK shall not be considered in default by reason of any failure in its performance under this Agreement if such failure results from, whether directly or indirectly, fire, explosion, strike, freight embargo, Act of God or of the public enemy, war, civil disturbance, act of any government, de jure or de facto, or agency or official thereof, material or labor shortage, transportation contingencies, unusually severe weather, default of any other manufacturer or a supplier or subcontractor, quarantine, restriction, epidemic, or catastrophe, lack of timely instructions or essential information from Customer, or otherwise arising out of causes beyond the control of KNOWiNK .
13. **RELATIONSHIP OF THE PARTIES:**
- 13.1. The parties to the Agreement are independent contractors and the Agreement will not establish any relationship of partnership, joint venture, employment, franchise, or agency between the parties. Neither party will have the power to bind the other or incur obligations on the other's

behalf without the other's prior written consent. KNOWiNK's employees, agents, and subcontractors will not be entitled to any privileges or benefits of Customer employment. Customer's employees, agents, and contractors will not be entitled to any privileges or benefits of KNOWiNK or employment.

14. **DISPUTE RESOLUTION:**

- 14.1. The parties will attempt to resolve any claim or controversy related to or arising out of this Agreement, whether in contract or in tort ("**Dispute**"), on a confidential basis according to the following process, which either party may start by delivering to the other party a written notice describing the dispute and the amount involved ("**Demand**").
- 14.2. After receipt of a Demand, authorized representatives of the parties will meet at a mutually agreed-upon time and place to try to resolve the Dispute by negotiation. If the Dispute remains unresolved after this meeting, either party may start mandatory nonbinding mediation under the commercial mediation rules of the American Arbitration Association ("**AAA**") or such other mediation process as is mutually acceptable to the parties.
- 14.3. Notwithstanding the other provisions of this Section 14, if either party seeks injunctive relief, such relief may be sought in a court of competent jurisdiction without complying with the negotiation and mediation provisions of this Section.

15. **GENERAL:**

- 15.1. KNOWiNK may assign or otherwise transfer the obligations incurred pursuant to the terms of this Agreement with the prior written consent of the Customer.
- 15.2. This Agreement is the complete and exclusive statement of the mutual understandings of the parties regarding the subject matter hereof. It is agreed that there is no representation, warranty, collateral agreement or condition affecting this Agreement other than was expressly stated herein. This Agreement may not be amended or waived except in writing signed by an officer of the party to be bound thereby.
- 15.3. THIS AGREEMENT WILL BE GOVERNED BY THE LAWS OF THE STATE OF INDIANA, TO THE EXCLUSION OF THE LAW OF ANY OTHER FORUM. THIS AGREEMENT IS NOT BINDING UNTIL ACCEPTED BY KNOWiNK IN WRITING.
- 15.4. In the event any provision of this Agreement shall be invalid, illegal or unenforceable in any respect, such a provision shall be considered separate and severable from the remaining provisions of this Agreement, and the validity, legality or enforceability of any of the remaining provisions of this Agreement shall not be affected or impaired by such provision in any way.
- 15.5. Any notice required or permitted to be given under this Agreement by one party to the other must be in writing and shall be given to Customer at the address set forth on **Exhibit A**, or to KNOWiNK at the address set forth on the first page of this Agreement, and deemed to have been given: (a) immediately, if delivered personally; (b) on the fifth (5th) business day following mailing if placed in the United States Mail, postage prepaid, by registered or certified mail with return receipt requested, addressed to such address. Each party may change its address for notice by giving written notice of the change to the other party; or (c) on the next business day upon confirmation of delivery, if delivered by overnight delivery by a nationally recognized overnight delivery service.



Council approves transition to vote centers

Local governing bodies are making the transition to vote centers this fall official, as plans for the change continue to come into clearer focus.

At Wednesday's county council meeting, council approved a resolution approving Grant County as a vote center county. Vote centers are polling places that any Grant County registered voter can visit on Election Day to vote regardless of their home address.

According to the resolution, the county is designated as a vote center county pending the approval and filing of a vote center plan by the election board. Grant County Commissioners are scheduled to vote on a similar vote center authorization resolution at Monday's regular meeting, according to the agenda.

Councilman Mike Roorbach, a member of the bipartisan committee working on the vote center transition, applauded county Clerk Pam Harris's leadership through the process.

"It had to be a little bit of a sales job, but I think it's the way to go," he said. "I think we're on the right track, and I want to thank you for all you've done."

The Grant County Courthouse, 101 E. Fourth St. in Marion, will again serve as an early voting location weekdays during normal business hours beginning Oct. 6 through Monday, Nov. 2, the day before Election Day, according to Election Deputy Nancy Bryant. The courthouse will also be open Saturdays, Oct. 24 and 31, from 8 a.m. to 3 p.m. for early voting, but the courthouse will not serve as an Election Day vote center location.

The vote center committee is also nailing down plans for one of the current proposed vote center locations to serve as an additional early voting location that would be open the same Saturdays as the courthouse and potentially additional weekday morning and evening hours, according to previous reports.

Harris, Bryant, the election board and the vote center committee are encouraging the public to attend a public meeting on Thursday, Aug. 27 at 6 p.m. at College Wesleyan Church, 200 E. 38th St., Marion, to ask questions and provide feedback on the current locations and overall vote center plan. The space will be large enough for social distancing practices to be followed, and the public can also access the meeting virtually, including the ability to ask questions, by visiting VoteGrantCounty.net and clicking on the link.


