A RESOLUTION AND ORDER APPROVING THE DESIGNATION OF HANCOCK COUNTY AS A VOTE CENTER COUNTY

## ORDER 2013 - 01

WHEREAS, IC 3-11-18.1 grants permission for any Indiana county that so chooses to implement vote centers in their county and,

WHEREAS, pursuant to IC 3-11-18.1-3(e) the Hancock County Election Board held at least two (2) public meetings 30 days apart where the vote center draft plans were distributed to attendees. March 19, 2013, March 26, 2013, April 2, 2013, April 23, 2013 and August 1, 2013. And,

WHEREAS, the Hancock County Commissioners and Hancock County Council have designated Hancock County as a vote center county and,

WHEREAS, the Hancock County Commissioners have certified that vote center locations are in compliance with HAVA and ADA guidelines and,

WHEREAS, the Hancock County Commissioners have contracted with an election vendor to provide election software, firmware and hardware and,

WHEREAS, the Hancock County Election Board so approves the Hancock County plan for the implementation of vote centers in Hancock County effective January 1, 2014

**THEREFORE, BE IT RESOLVED AND ORDERD BY THE HANCOCK COUNTY ELECTION BOARD that Hancock County adopts the Vote Center Plan incorporated in this order by reference. Plan dated: August 1, 2013 effective January 1, 2014.**
