VERIFIED PETITION FOR RECOUNT

Petitioner Greg (No Bull) Knott, by and through himself, and pursuant to IC 3-12-11-1 et seq., hereby files this Verified Petition for Recount and states the following:

1. Office Subject to Recount

Petitioner desires a recount of votes cast for the Republican nomination for Indiana State Representative, House District 57, at the primary election held on May 5, 2026.

2. Petitioner's Entitlement to Recount

Petitioner Greg (No Bull) Knott was a candidate for the Republican nomination for Indiana State Representative, House District 57, at the primary election held on May 5, 2026, and is entitled to a recount under IC 3-12-11-1.

3. Precincts Subject to Recount

The nomination for Indiana State Representative, House District 57, was voted upon in the following precincts in Hendricks County, Indiana, in which Petitioner desires a recount of all votes cast for said nomination:

6. Request for Recount of All Votes

Petitioner desires a recount of all of the votes cast for the Republican nomination for Indiana State Representative, House District 57, in the precincts specified above.

7. Request for Manual Hand Count

Pursuant to IC 3-12-11-17.5, Petitioner hereby requests that the ballot cards in each of the precincts specified above be counted manually. Petitioner does not consent to the use of automatic tabulating machines to count ballot cards in the specified precincts.

8. Cash Deposit

Petitioner tenders herewith a cashier's check payable to the Indiana Election Division in the amount of One Hundred Dollars (\$100.00) as the required cash deposit pursuant to IC 3-12-11-10, to be deposited in the state recount fund.
