MINUTES OF EXECUTIVE MEETING

August 12, 2011

Call to order and introduction of Board members

The meeting was called to order at approximately 2:00 PM by Thomas A. Massey, President of Vanderburgh County Election Board. Going around the table, David Shaw, Board Member, Susan K. Kirk, Board Secretary, Donna Porter, Chief Deputy, Anthony Bushrod, Voter Registration. Also in attendance, Ian Hauer, Neil Kellen, News 25, Wayne Parke, VCRP, Tabnie Dozier, News 7, Andy Overton, News 7, Richard Goode, Courier Press and Ted Miller.

Approval of Minutes

Thomas Massey asks for a motion to approve and sign the minutes from the May 13, 2011 meeting. David Shaw makes the motion and Susan Kirk seconds the motion for approval. Motion carried and minutes entered into the book.

Vote Center Order

Susan Kirk states we have had the two public meetings and has the resolutions signed from the County Council and County Commissioners. Thomas Massey asks if it was unanimous and Susan Kirk says except for Stephen R Melcher, Member County Commissioners it was unanimous.

Thomas Massey reads the order. (**Attachment 1**) Thomas Massey then asks for a motion and David Shaw makes a motion to adopt the resolution and Susan Kirk seconds and Thomas Massey states our resolution passes unanimously.

Susan Kirk goes over the hand outs (**Attachment 2**) listing of the Vote Centers 23 total but only 15 for the City Election and a map. David Shaw says a recent change with Fairlawn United Methodist Church being added in the last couple of days and Susan Kirk tells the Board that Faith Heritage Baptist Church/School could not be used because they had a gravel drive and that is not handicap accessible and no internet service. Thomas Massey says that all the Vote Centers were decided upon and with agreement from party Chairmen, Wayne Parke and Mark Owen. Susan Kirk commended on the good job both Party Chairmen did on the Vote Centers.

The next handout in the packet is the budget for the 2012 Election and the savings next year is \$81,620 to be saved every year. This General Election for the City 2011 will be a savings of \$20,000.

Susan Kirk states the Vote Centers advantage is convenience, savings and easier to find Poll workers.

Each Vote Center will have 1 Inspector, 4 Judges and 4 Clerks. The last page in the handout is the equipment for the Vote Centers.

Thomas Massey commends Susan Kirk on the great job she did on the Vote Centers and the savings.

David Shaw supports the concept of the Vote Centers because of the savings to the taxpayers, fewer Poll workers, and the other Counties have been happy with the Vote Centers.

The last handout is the FirstTuesday ePollbook showing how the system will work.

Thomas Massey asks when the early voting will start and Susan Kirk says 30 days out for the Election Office, 15 days out for the Libraries and the last two Saturdays we will at least one maybe two Vote Centers, Salvation Army and North East Baptist Church. In the Primary 2012 we will have the Libraries open 5 days.





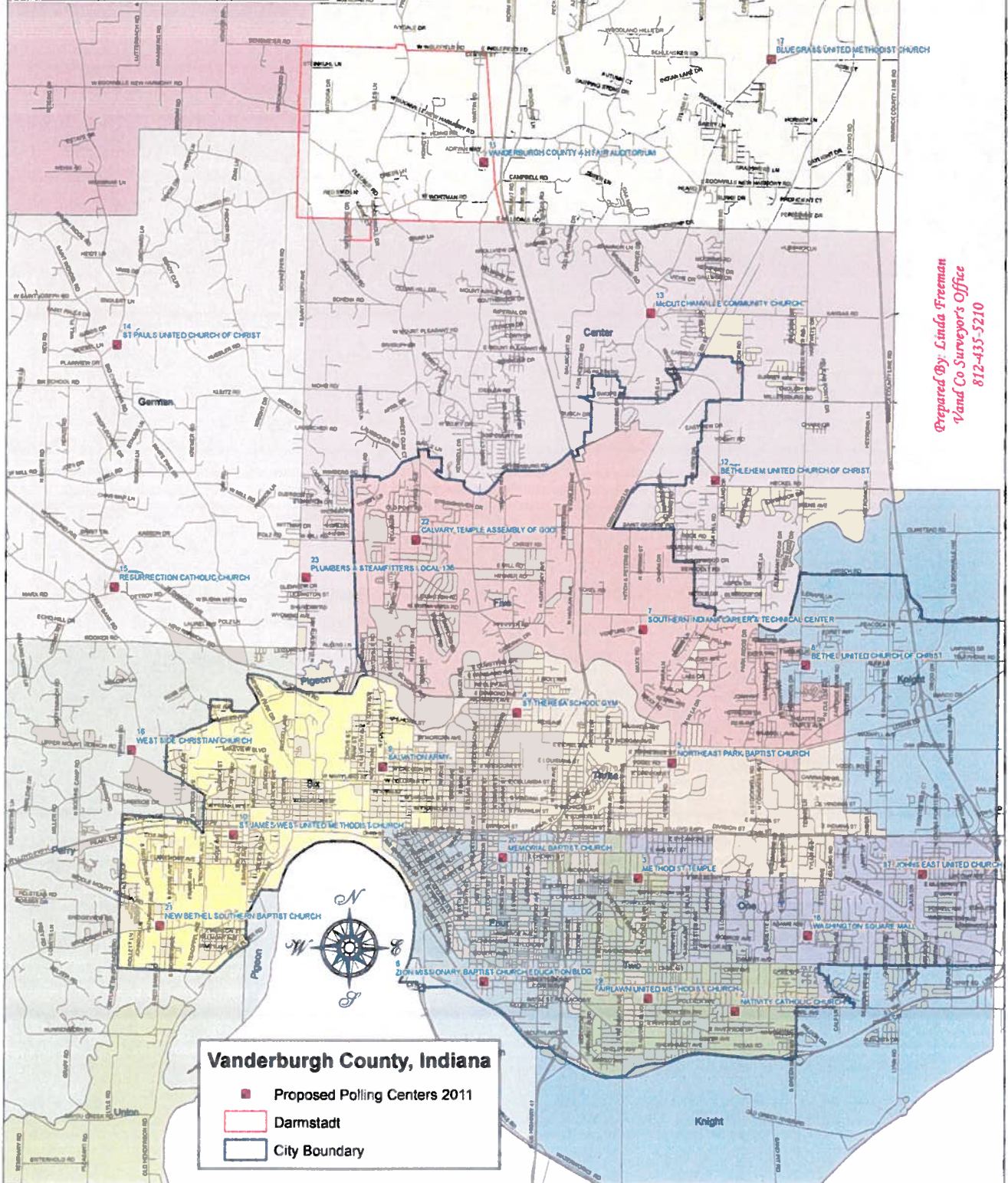
