VOTE CENTER PLAN AMENDMENT #4

WHEREAS, the Wabash County Vote Center Plan was duly adopted on February 28, 2013; and

WHEREAS, Indiana Code 3-11-18.1-15 authorizes Wabash County to amend a plan adopted under 3-11-18.1-3 by unanimous vote of the entire membership of the board approving the plan amendment; and

WHEREAS, the Wabash County Election board has determined that the vote center plan previously adopted should be amended to reflect changes for the 2016 elections; and

WHEREAS, the Wabash County Election Board so approves the Wabash County plan amendment for vote centers in Wabash County, Indiana.

BE IT THEREFORE ORDERED BY THE WABASH COUNTY ELECTION BOARD:

1. Wabash County will utilize ten (10) vote center sites at the Primary election, May 3, 2016 and at the General election, Nov. 8, 2016.


