

WABASH COUNTY ELECTION BOARD
VOTE CENTER PLAN AMENDMENT #2

WHEREAS, the Wabash County Vote Center Plan was duly adopted on February 28, 2013; and

WHEREAS, Indiana Code 3-11-18.1-15 authorizes Wabash County to amend a plan adopted under 3-11-18.1-3 by unanimous vote of the entire membership of the board approving the plan amendment; and

WHEREAS, the Wabash County Election board has determined that the vote center plan previously adopted should be amended to reflect changes for the 2015 City and Town elections; and

WHEREAS, the Wabash County Election Board so approves the Wabash County plan amendment for vote centers in Wabash County, Indiana.

BE IT THEREFORE ORDERED BY THE WABASH COUNTY ELECTION BOARD:

1. Wabash County will utilize five (5) vote center sites on Election Day, May 5, 2015 and on Election Day, Nov. 3, 2015 (if needed)



The Election Board of Wabash County adopts this Order to approve the Wabash County Vote Center Plan Amendment.



WABASH COUNTY ELECTION BOARD
RESOLUTION NO. 2015-1
ESTABLISHING DATE AND HOURS FOR IN-PERSON
ABSENTEE VOTING
FOR MAY 2015 PRIMARY ELECTION

Recitals

Whereas, a certain number of voters will vote in the May 5, 2015 primary election in Wabash County by absentee in the office of the Circuit Court Clerk before an absentee voter board pursuant to IC 3-11-10-25;

Whereas, the Wabash County Election Board desires to enact a resolution to set the absentee voting hours for absentee voting in the office of the circuit court clerk before an absentee voter board pursuant to IC 3-11-10-26.5.

Findings of Fact

Now, therefore, in support of this resolution, the Wabash County Election board makes the following findings of fact:

1. The Wabash County Election Board anticipates 50-60 absentee ballot applications to vote in the office of the circuit court clerk in the 2015 May primary; and
2. The expense that would be incurred if absentee voting was offered in the office of the circuit court clerk during the entire period required under IC 3-11-10-26 would be \$2,700.00-\$2,800.00; and
3. The voters would experience little or no inconvenience by restricting absentee ballot voting in the office to the days and hours specified in this resolution.

Resolution

BE IT THEREOFRE RESOLVED that, pursuant to IC 3-11-10-26.5, and the findings listed above, the Wabash County Election Board, by unanimous vote of the board's entire membership, sets the days and hours for **absentee voting** for the May 2015 primary election in the office of the circuit court clerk before an absentee voting board, as follows:

Mon-Fri April 20 – April 24 from 12:00 noon to 4:00 p.m.

Mon-Fri April 27 – May 1 from 12:00 noon to 4:00 p.m.

Saturday, April 25 from 8:00 a.m. to 12:00 noon

Saturday, May 2 from 8:00 a.m. to 12:00 noon

Monday, May 4 from 8:00 a.m. to 12:00 noon

This Resolution amends and replaces Resolution No 2014-1 signed by the Wabash County Election Board on July 23, 2014.
