DIRECT PAY OPTION FOR NON-PUBLIC SCHOOL TUITION INVOICES

To remove a barrier faced by ESA schools and parents, we are offering a new payment process for tuition and fee payments to Non-Public Qualified Schools.

New for 2023-24, the ESA Office can directly pay your ESA student's tuition (ADM allocated amount) and special education services (APC allocated amount) dollars, without the need for invoice submission through ClassWallet.

The Treasurer of the State will disburse funds to the ESA school on the parent's behalf in two allotments. The first disbursement will be in October of 2023, the second disbursement will be in April of 2024. The nonpublic school will receive disbursements from ClassWallet. ESA staff will provide reporting aligned to disbursements made per student with allocation amount.

To activate your student's payment(s) to your ESA school, we ask the parent to confirm or deny direct payments. If a parent does not complete the Parent Endorsement Form, we will defer to the ESA standard invoice and submission process through ClassWallet. If your nonpublic school has a tuition charge higher than your scholarship award amount and you choose direct payments, you will not have additional funds deposited into your ClassWallet account. Any outstanding balances after the ESA scholarship has been applied towards tuition and fees will be the responsibility of the parent.





CAREER SCHOLARSHIP ACCOUNTS



House Bill 1002 recently established the Career Scholarship Account (CSA) Program. This program provides \$5,000 to eligible 10th, 11th, & 12th grade students to pursue apprenticeships, applied learning experiences, work-based learning, and credential attainment experiences. To be eligible, students must:

- Be an Indiana resident
- Be a 10th, 11th, or 12th grade student
- Be enrolled in a course or educational experience approved by the Indiana Department of Education
