

**ANDREWS TOWN COUNCIL MINUTES  
OF A PUBLIC MEETING HELD NOVEMBER 10, 2025**

A public meeting of the Town Council of the Town of Andrews, Indiana convened on November 10, 2025, at 6:00 p.m. at the Andrews Town Hall in accordance with applicable law and pursuant to appropriate notice.

**ROLL CALL**

Council Members Laura Dillon and Roger Newsome, Jr. were in attendance. Councilmember Michael Dean Young was absent due to a work conflict. Clerk-Treasurer Laury Powell declared a quorum was present and the meeting would continue.

**APPROVAL OF COUNCIL MINUTES**

Roger Newsome made a motion to approve council minutes for a Regular Session held on October 27, 2025. Laura Dillon seconded the motion, which was approved, 2-0.

**OLD BUSINESS**

2026 CCMG Application: CT Powell reported that the CCMG application was submitted October 29, which was followed by the AMP Plan on November 7, which LTAP has since approved. The CCMG grant awards should be announced at the end of the year.

2026 Calendar: This matter was tabled until Dean Young can provide his new work schedule to the clerk and fellow council members and be present for discussion.

ARPA Funds: Powell said these funds designated for water infrastructure improvement must be expended by the end of this year or be returned to the federal government. As of today \$29,253.64, remains unspent in the ARPA Fund. Colin Bullock answered that the last custom-made part he ordered, a high-service pump for the water plant, is ready and should be shipped on November 14<sup>th</sup>. He added that Peerless Midwest should have the new pump installed this month.

**NEW BUSINESS**

A special meeting is scheduled for Wednesday, November 12 at 1:00 p.m. Lochmueller Group will provide an update on work completed for the IFA regarding an investigatory study of a possible Huntington-Andrews Drinking Water Regionalization Project.

C-T Powell said a WHARMM meeting is scheduled for December 10 at 6:00 p.m. in Huntington, location yet to be determined.

**DEPARTMENT REPORTS**

Police Department: Town Marshal Josh Platt updated council members on the 400 W Monroe St OE situation. The buyer at the tax sale is backing out of the purchase contract because the mobile home was largely demolished over the summer, leaving debris scattered across the property. Kim Hostetler plans to attend the December regularly scheduled meeting to discuss the next steps after the default of the sale. Platt thanked Neal Snyder and Paul Farnow for the Halloween candy donation. He then informed Council that Deputy Marshal Raber will be off work this week due to a work related injury.

Fire Department: No report was made.

Utility Department: Colin Bullock reported they are still picking up leaves across town. Also, both the bucket and dump truck are lined up for repairs soon.
