### **New Business:**

The tree that has fallen and is leaning against another tree, at the property across the street from the Town Hall, is a hazard. The Town needs to say something to the homeowner or have Tom Green say something. Taylor says he will have someone stop by and ask if something can get done. Joe says that it will no longer be considered an "Act of God" if it falls since so much time has passed since it originally fell.

Kelsie says she has sold her house and has until March 22<sup>nd</sup> to be out. She said that she talked to the Republican Chair and there was mention about possibly being an interim board member until the position is able to be filled.

Kelsie mentions that the HCCF TASK Grant is currently open and she would like to apply for it for playground equipment for the park. The board discusses the type of playground equipment and the possibility of Commercial Grade equipment and Liability risk.
