ORDINANCE 2021-006

AN ORDINANCE ESTABLISHING THE ARP CORONAVIRUS LOCAL FISCAL RECOVERY FUND 176

WHEREAS, on March 11, 2021 the American Rescue Plan Act of 2021 (ARP) was enacted; and

WHEREAS, the ARP provides \$350 billion in emergency funding to state and local governments and the Town of Culver will be a recipient of that funding; and

WHEREAS, the Indiana State Board of Accounts has provided guidance to funding recipients;

WHEREAS, any monies deposited into the Fund may only be used as permitted by Section 603(c) of the Social Security Act as added by Section 9901 of the ARP; and

WHEREAS, the Town Council of the Town of Culver desires to establish an ARP Coronavirus Local Fiscal Recovery Fund in which Federal assistance from the ARP shall be deposited in accordance with State Examiner Directive 2021-1.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Culver, Indiana as follows:

Section 1: Pursuant to State Examiner Directive 2021-1, the Town Council of the Town of Culver does hereby create Fund Number 176, which is a special, non-reverting fund designated as the ARP Coronavirus Local Fiscal Recovery Fund;

Section 2: The source of funding includes monies allocated to the Town from the American Rescue Plan Acct of 2021 and distributed to the Town in 2021 and 2022.

Section 3: Any monies deposited into said Fund may only be utilized for the following purposes:

- a. To respond to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19) or its negative economic impacts, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality;
- b. To respond to workers performing essential work during the COVID-19 public health emergency by providing premium pay to eligible workers of the Town of Culver that are performing such essential work, or by providing grants to eligible employers that have eligible workers who perform essential work;
- c. For the provision of government services to the extent of the reduction in revenue of the Town of Culver due to the COVID-19 public health emergency relative to revenues collected in the most recent full fiscal year of the Town of Culver prior to the public health emergency;
- d. To make necessary investments in water, sewer, or broadband infrastructure; and/or
- e. Funds made available may be transferred to a private non-profit organization (as that term is defined in Paragraph 17 of Section 401 of the McKinney-Vento Homeless Assistance Act 42 U.S.C. 11360(17)), a public benefit corporation involved in the transportation of passengers or cargo, or a special purpose unit of State or local government.

Section 4: The Town shall adopt a plan which provides details for the use of funds.

Section 5: This ordinance may be amended from time to time if additional guidance is received from any federal or state agency.

Section 6: The ARP Coronavirus Local Fiscal Recovery Fund shall exist until terminated by ordinance of the Town Council. Moneys from this Fund may not be transferred to another fund of the Town.
