## **ORDINANCE 2022-005**

## An Ordinance Amending and Restating Ordinance 2020-010 Restating and Establishing Parking Regulations in the Town of Culver, Indiana

WHEREAS, the Town of Culver, Indiana, has control over the streets and alleys of said Town and has established certain traffic regulations to install signs and other traffic control signals at different locations around the Town; and

WHEREAS, the Town has received a request from the Culver Community School Corporation to eliminate previously established parking restrictions for a drop-off and pickup zone at Culver Elementary School; and

WHEREAS, the Town has authority to implement parking restrictions within Town limits.

NOW, THEREFORE, BE IT ORDAINED by the Culver Town Council as follows:

- 1. The No Parking Zone previously established in Ordinance 2020-005 and extended in Ordinance 2020-010 by 20 feet on the north side of Lakeshore Drive between School Street and Slate Street approximately 260 feet in total length during specific times on school days shall be eliminated.
- 2. Other parking restrictions outlined in Chapter 73, "Parking Schedules" of the Culver Code of Ordinances shall be modified to include new parking restrictions. This parking schedule shall now include parking restrictions on the following streets:

Akron Street: No parking on either side.

Batabano Street: No parking on the North side.

College Avenue: Parking shall not be restricted on the south side from School Street on the west to Lake Shore Drive on the east.

Davis Street: No parking on the south side from Peru to S. Main Street.

Forest Place: No parking on the east side from Lake Shore Drive to College Street.

Jefferson Street: 2-hour parking is allowed on the north side from Ohio Street to Plymouth Street Friday through Sunday and Holidays from 8:00 a.m. to 4:00 p.m. Parking is allowed on the south side from Ohio Street to Plymouth Street, except from Main Street to the alley east of Main Street (in front of the Culver Academies museum) where parking is restricted to two-hour parking Friday through Sunday, 8:00 a.m. to 4:00 p.m.

Liberty Street: Parking shall not be restricted on the west side of the street from Lake Shore Drive to College Street. No parking on the east side from Lake Shore Drive to College Street.

Madison: In front of the Bed and Breakfast, on the south side of Madison Street, a handicap parking spot will be marked and accessible.

Madison: 2-hour parking on south side from Main Street to 30 feet east of Main Street Friday through Sunday and Holidays from 8:00 a.m. to 4:00 p.m. Parking allowed on north and south side from Ohio to Main Street and on north side of Madison from Main Street to the End (Cove).

Ohio Street: No parking on either side of Ohio Street from Washington Street to Lakeshore Drive. No parking on the east side of Ohio Street from Davis Street to Mill Street.

**Plymouth Street:** No parking allowed on S Plymouth Street on the west side of the street from Winfield to Davis Street and no parking on either side of the street from Winfield to Hawkins. No parking from Hawkins to Marmont Street.

School Street: No parking on the west side and east side from Lake Shore Drive on the south to a point north of the Culver Elementary School's pickup point entrance (approximately 650 feet north of Lake Shore Drive). No parking on the north end of School Street from Academy Road to Highway 10.

Washington: Parking is allowed on the north and side from Ohio Street to Plymouth Street, except for where it is restricted to 2-hour parking on the north and south sides from Main Street to the alley east of Main Street Friday through Sunday and holidays from 8:00 a.m. to 4:00 p.m.

Washington: No parking any time on south side of Washington Street from Lake Street to Coolidge Street.

3. Any person in violation of this ordinance is subject to the standard fines and costs as has been previously adopted by the Town of Culver.

All other parking restrictions shall remain unchanged.

This ordinance shall take effect from and after its approval and adoption.
