
WHEREAS, The Culver Town Council has identified funds to be pledged and authorized for said projects and improvements.


Now, THEREFORE, BE IT RESOLVED by the Town Council for the Town of Culver, Marshall County, Indiana:


1. The Culver Town Council pledges and will authorize the expense of approximately Two Hundred Twenty Thousand Dollars (\$220,000.00) from town funds to finance the design and construction of additional bicycle and pedestrian trail facilities in and connection to the Town of Culver beginning in 2019, with anticipated construction start date of summer 2024.
2. The Culver Town Council intends to approve and execute the necessary contract agreements on behalf of the Town to complete the projects and improvements listed herein for the purposes of the INDOT Local Call Application if the funds are awarded. The Culver Town Council may pursue additional grants that would be of assistance in funding additions to the proposed projects and improvements thereon.
3. The funding herein will be coupled with the additional funding to be considered by the Culver Redevelopment Commission, program partners, and in-kind donations to provide matching funds for the Lake Maxinkuckee Trail system.

To Whom It May Concern,

Please be aware that the Town of Culver has completed an INDOT grant application for additional funding for bicycle and pedestrian infrastructure for within and connecting to the Town of Culver, and the Culver Town Council has identified funds to be pledged and authorized for these improvements.

The Culver Town Council pledges and will authorize the expense of approximately Two Hundred Twenty Thousand Dollars (\$220,000.00) from town funds to finance the design and construction of additional bicycle and pedestrian trail facilities known as Lake Maxinkuckee Trail Phase 3, in and connecting to the Town of Culver beginning in 2019, with an anticipated construction start date of summer 2024.







