

RESOLUTION 2018-011

RESOLUTION AUTHORIZING FUNDS FOR PUBLIC IMPROVEMENTS

WHEREAS, The Culver Town Council and Union Township Advisory Board have met regularly throughout 2018 to discuss the purchase of an aerial ladder truck for the Culver Union Township Fire Department, and

WHEREAS, The Culver Town Council and Union Township Advisory Board have identified funds to be pledged and authorized for said purchase in 2019, including the use of private donations and pledges; and

WHEREAS, The Culver Town Council has budgeted for and committed to funding the Kline Levee repair project in partnership with the Lake Maxinkuckee Environmental Council with \$100,000 provided over four years;

Now, THEREFORE, BE IT RESOLVED by the Town Council for the Town of Culver, Marshall County, Indiana:

1. The Culver Town Council pledges and will authorize the expense of \$200,000 from the town fire department budget over a five year period, beginning with \$20,000 in 2019 and borrowing \$180,000 from the general fund, to be paid back through the fire department budget in years 2020-2023 for the purchase of an aerial ladder truck for the Culver Union Township Fire Department.
2. The Culver Town Council pledges and will authorize Town Non-Reverting Fire Fund expense of \$20,000 towards the aerial ladder truck purchase in 2019, and \$50,000 in Town Rainy Day funds in 2019 for the same.
3. The Culver Town Council acknowledges a similar commitment has been made by Union Township, in the amount of \$300,000 committed towards the purchase of an aerial ladder truck in 2019, as well as \$100,000 being committed from the Culver Redevelopment Commission.
4. An additional pledge of \$80,000 over the years from 2020-2023 has been received from private entities, which will be borrowed from the Town General Fund and repaid over four years from said pledge.
5. Town and Fire Department fundraising efforts and the sale of the existing vehicle will also contribute towards this purchase.

6. The Culver Town Council pledges to fund a total of \$100,000 towards the Kline Levee repair project in coordination with the Lake Maxinkuckee Environmental Council. This project is to help preserve the overall health and quality of Lake Maxinkuckee, pledged as \$25,000 per year in 2019, 2020, 2021, and 2022.
