LLC CPA Report – Michelle Skeen

Ms. Skeen reported on the financial report ending October 31, 2025 for the Edgewood Golf, Restaurant, and Event Center. Discussion followed.

Fire Department Report

Chief Vanderbur, EFD, reported on the various EMS runs, transports, and fire activity for the month of October 2025. The Chief presented a proposed rate increase for Fire Runs. Discussion followed.
