The Electronics Drop Off date will be July 19, 2025 between 8:00 am and noon (at the utility plant area).

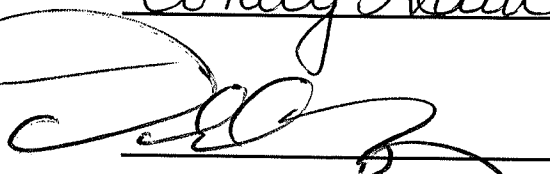
County and Town planning to join "forces"/merge was briefly discussed with no action taken. Future updates to be shared at the June 9, 2025 Council meeting.

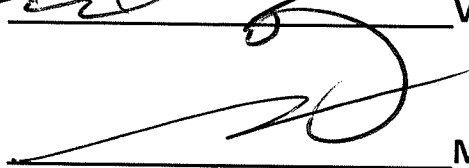
