Motion to approve using Misfits Towing & Recovery (MT&R), subject to receiving from MT&R a valid vendor contract (to be approved by Town Council) by Sam Levine; 2nd by Todd Fry. Motion carried by majority with one abstention.

Motion to adopt Resolution 2025-04 – Additional Appropriations by Todd Fry; 2nd by Sam Levine. Motion carried unanimously.

Motion to approve allocation of various funds to be used for the CCMG – 2025-01 matching amounts by Todd Fry; 2nd by Sunny Saylor Gordon. Motion carried unanimously.

Motion to approve Galveston Volunteer Fire Dept. for 2026 (\$40,979.40) by Sam Levine; 2nd by Todd Fry. Motion carried unanimously.

Motion to approve DLZ – CCMG 2025-01 invoice #3 of 3 for \$13,600.00 by Todd Fry; 2nd by Sunny Saylor Gordon. Motion carried unanimously.

Motion to approve DLZ – AMP/PER/SRF invoice #4 of 4 for \$1,000.00 by Sunny Saylor Gordon; 2nd by Todd Fry. Motion carried unanimously.
