Motion to approve payroll warrants for September 2025 by Sam Levine; 2nd by Todd Fry. Motion carried unanimously.

NEW BUSINESS:

Motion to table presentation of the ordinance (2025-03) for the Galveston Volunteer Fire Department vacating the alley between the fire station plots and a property lot east of the fire station by Todd Fry; 2nd by Sunny Saylor Gordon. Motion carried unanimously. The Town Attorney will develop the appropriate alley-vacating paperwork.

No action was taken on updates of traffic warning signage re: Ordinance 2025-02.

Motion to table the handling of the Misfits Towing contract by Sunny Saylor Gordon; 2nd by Todd Fry. Motion carried unanimously. Note that Council person Michael Deis departed the meeting to address an unrelated emergency.

Motion to approve transferring \$109,998.06 from the Payroll Fund (for years prior to 2025) equally to the Water and Wastewater Operating Funds(50/50).For 2025 and beyond, transfer equally (1/3,1/3, 1/3) to the same Operating Funds, plus the General Fund by Sunny Saylor Gordon: 2nd by Todd Fry. Motion carried unanimously.

Motion to approve DLZ invoice (\$400.00) for AMP/PER/SRF services by Todd Fry; 2nd by Sunny Saylor Gordon. Motion carried unanimously.

Motion to approve Resolutions 2025-06 and 2025-07 for Additional Appropriations and transfers by Todd Fry; 2nd by Sam Levine. Motion carried unanimously.

NEW BUSINESS (cont'd):

Motion to table Wage & Salary Ordinance 2025-04 by Sunny Saylor Gordon; 2nd by Todd Fry. Motion carried unanimously.

Motion to approve Christmas Décor Systems annual invoice (\$3,895.00) by Todd Fry; 2nd by Sunny Saylor Gordon. Motion carried unanimously.

Motion to consider paying overtime to Town workers for certain weekend work, such as testing at the water plant(s), subject to modification of the Personnel Handbook by Todd Fry; 2nd by Sunny Saylor Gordon. Motion carried unanimously.

Motion to approve the purchase price proposal (\$12,000.00) for Flock Safety Cameras (for GPD), subject to review by the Town Attorney by Sam Levine; 2nd by Todd Fry. Motion carried unanimously.
